A general municipal election in 2024 will not be held in the Resort Village. The Minister's Order that incorporated the Resort Village determined the next general election will be October 2028.

2024 Municipal Tax Levy

2.75 Mills

\$100 base tax on residential land

\$150 base tax on residential improvements

\$ 60 base tax on agricultural land

Prompt Payment Discount

Tax payments received before August 31, will receive a 5% discount on the municipal portion of the taxes.

Arrears Penalty

Unpaid taxes will be subject to a 2% interest penalty per month on total taxes assigned on the first day of each month.
