## MUNICIPAL PLANNING FEES BYLAW

#### A Bylaw to Establish Fees for Planning and Development Services

The Council of The Resort Village of Pasqua Lake, in the Province of Saskatchewan, enacts as follows:

- 1. The Resort Village of Pasqua Lake recognizes that there is an administrative cost for the provision of specific services related to planning and development, and that the user of these services should contribute towards their cost. Accordingly, fees and charges are to be implemented and collected for the service requested.
- 2. Pursuant to this *Municipal Planning Fees Bylaw*, the fees for planning and development services are attached hereto as "Schedule A" and forming part of this bylaw; shall apply.
- 3. Permit Fees are exempt from GST.
- 4. Payment of the above fees shall not be presumed to constitute an approval by Council.
- 5. Issuance of a Development Permit does not exempt the Applicant/Developer from any required Building Permit Review and Inspection process.
