**Taxervice Inc. Agreement**

26.25 *Neu* - WHEREAS the Tax Enforcement Act requires the municipality to conduct tax recovery proceedings every year;  
AND WHEREAS council for the municipality deems it to be in the municipality's best interest to hire Taxervice Inc. to manage tax arrears recovery on its behalf;  
THAT the Resort Village of Pasqua Lake hire Taxervice to manage tax arrears recovery on the municipality's behalf for a term of 3 (three) years;  
AND FURTHER THAT the CAO be authorized to sign the Taxervice Inc. engagement letter on behalf of the Resort Village. CARRIED

AND FURTHER THAT the Resort Village of Pasqua Lake appoint Aileen Swenson as Secretary to the Development Appeals Board for the term of January 1, 2026, through to December 31, 2026; remuneration as set out in the RM of Edenwold's fee schedule. CARRIED
