FireSmart Wildfire Community Preparedness Day

Wildfire Community Preparedness Day is a national campaign that encourages Canadians to take action to increase their resistance to wildfire at home and in the community. The Calling Lakes Wildfire Initiative will host a guest presenter from Saskatchewan Public Safety Agency who will provide simple and effective actions to prevent wildfire damage including:

- · move wood piles away from structures
- clean up debris from under decks or between buildings
- trim tree branches to avoid contact with roofs
- use non-combustible landscaping (rocks rather than mulch) around the house
- clean eavestroughs
- cover vents with tight mesh to prevent embers from entering the home

The world watched urban fires in the Pacific Palisades, Jasper, and Lytton, BC. It can happen anywhere. Be FireSmart - be prepared.

Planning Bylaws

As a new municipality, the Resort Village is required to adopt a zoning bylaw and Official Community Plan by the end of 2025. Draft bylaws are underway and will be available at the RV office for review. Council welcomes comments and input.

The zoning bylaw will regulate the use and development of land within our boundaries. It divides the community into zoning districts with a list of permitted and discretionary land uses. It includes regulations and development standards, such as setbacks, and flood and slope hazard requirements.

The official community plan establishes long-term goals, objectives, and policies for the Resort Village's future development. The OCP includes municipal infrastructure, land management and environmental protection, residential development, heritage and recreation.

The planning bylaws will be instrumental in shaping our new Resort Village for the future.
