

POLICY AND PROCEDURES

RESERVATIONS

- For your convenience we offer reservations for all your party needs. You should reserve your equipment well in advance. Upon receipt of the deposit, the rental items are reserved for the renter and guaranteed for the date of the reservation. Please make your selection accordingly.
- We do require a nonrefundable payment of 20-50% of the rental fees for items rented, which is due at the time of reservation and signing the policy contract. This payment is **NONREFUNDABLE** in the event that the renter cancels reserved rental items. The deposit for each item cancelled is forfeited and not applied to any other rental items on your contract.
- 50% deposit is required.
- 50% deposit is required on all barbecues, canopies, dance floors, staging and table linens.
- Table linens require a 14 day advance for any changes or cancellations of your order or you will be charged 100% of the total.
- A \$50 cleaning deposit is required on all barbecue rentals at the time of pick up.
- A 30% cleaning deposit is required on all dance floor rentals at time of pick up.

PAYMENT

- Full payment is due for all rental and resale items at time of pick up. Renters will not receive items or supplies until contract is paid in full.
- All rental items are charged for the time the equipment is in the renter's possession. No allowance is made for any period of time when rented items are not in actual use or if not used at all. If items are returned after the time due there will be an additional daily charge per item. Any cancellation is subject to a charge.
- Rates on the price list are for a 24 hour rental period. If long term rental is needed please call for a price. Wedding events please inquire about rental period.

We do accept Cash, Check, Visa, Master Card, American Express, Discover, and debit cards.

PICK UP AND RETURN

- The renter is responsible for loading and unloading all rental items. If the dealer employees assist you in loading or unloading the rented items, the renter agrees to assume the risk of, and hold the dealer harmless for any property damage or personal injuries. The dealer shall not enter your vehicle or trailer at any time.
- When picking up and returning rental items please consider the vehicle that the rentals are to be loaded into. Rental items must be protected from the elements at all times; rentals must be transported in a dry and clean environment. All horse trailers must be clean before rentals can be loaded.
- In the event the rental items (including boxes and protective materials are returned dirty, wet or have been transported in a manner that does not comply with the above guidelines, a minimum fee or damage/replacement fee will incur.

LOSS OR DAMAGES AND CLEANING FEES

- The renter is responsible for equipment from the time of pickup to time of return and keeping rented items safe and protected from damage while in renter's possession. The renter agrees that if the rented items are returned to the dealer in a condition other than the condition received, the renter will pay the amount necessary to return the rented items to its former condition, including labor and new parts or full replacement cost of the rented items that are broken, chipped, damaged, lost or stolen from the time of pick-up to the time of return.
- Please check all rental items carefully. If you receive any items, chipped, broken or damaged please notify us immediately so your contract can be noted. In not doing so the renter assumes all responsibility for damages.

CLEANING FEES

The renter must return items rented clean and in the condition they received them. All dishes, centerpieces, mirrors, and serving items must be returned clean or there will be a minimum of \$30 cleaning fee or 50% of the rental total, whichever is greater. \$50 cleaning deposit on all BBQs. 25% cleaning deposit on all dance floors.

DELIVERY AND SET UP

We currently do not offer delivery and set up except the 30'x60' Canopy. If you need items delivered and set up please contact the local delivery services or ask a sales associate for a referral.
