APPROVAL OF TREASURER'S INVESTMENT REPORT DATED JUNE 30, 2025

Treasurer Bellisario explained the investments by category, the largest being in certificates of deposit. Corporate bonds yield higher returns, so he will be investing more in this category. The IIIT Core Management account is going well, managing \$25M. Rates are currently best short term in money markets. Municipal bonds are bought with all the treasurers, investing in school districts in Illinois. Mr. Bellisario also explained that the tax money from Cook County will be delayed. We most likely not see this money until November. Treasurer Bellisario recommended that the board approve the Treasurer's Investment Report dated June 30, 2025 be approved as present. Treasurer Bellisario presented the bills paid by the Township Treasurers Office for the quarter. He explained the \$22,000.00 bill to Holicow AI for the software development to incorporate the investments into our accounting system. Mr. Bellisario met with other treasurers regarding this program and four of the treasurers would like to participate and contribute towards the cost of this software.


ADJOURNMENT
