




Confirmation messages, above and below. The image below was created to confirm God put Revelation confirmation images in both badges.








Above: The tilma Juan Diego holds in the center of Juan Diego's Badge.

Below: the mantle of the Juan Diego Badge.



The Mystery of My Fake Friends, And the Bodies in the Basement

In mid 1988, at 23, I moved into an apartment in Southern California with my younger sister, Kenya, who had recently turned 22. Kenya came out as lesbian in 1990 or 1991, but in 1988 she was still undeclared. While living with Kenya, around September 1988, a gay guy at work suggested we go out as “friends” sometime –although we were co-workers, not friends. I politely declined. Later, I told Kenya the story. She called me a *homophobe*, and urged me to go hang out with the guy, just once. I argued, but eventually conceded. I went to a movie with the guy, and hated every minute of the night. Sure enough, at the end of the night, he tried to get me to go up to his apartment. I refused, sharply, and the guy slammed the passenger door of my car, like a lunatic. Later, I told Kenya I respect gay people’s right to be, and I believe they have and deserve all human rights, but I would never have a gay friend; mostly because I never want to hear about their romantic lives or worry they might develop an interest in me. I would go on to make that declaration many more times.


By 1988, Gardner and Satan had been staging dirty tricks and skits for over 20 years. The fact that I was now declaring I would never have a gay friend was an irresistible challenge. Could Gardner create conditions where I had a new group of friends who were all secretly homosexuals –known to each other but not to me?

In 1992 I was sort of forced to leave the Los Angeles area, because suddenly every agency working with at-risk and emotionally disturbed children required a college credential (this requirement only lasted for about a year –long enough to pressure me to leave Los Angeles). The reason Gardner and his Hollywood brethren wanted me out of the LA area was tied to the fact that the band *Rage Against the Machine* stole the music to one of my songs for their song *Know Your Enemy*. At the time, I was active in the LA music scene, which created a reasonable possibility that I would discover the infringement early. But, if I were out of the area -back in Northern California- I might not discover the theft for a year or more.

After moving around Northern California for a year, in late 1993, I moved back to Berkeley, where Gardner and Satan started their attacks on me a quarter of a century earlier.

For their new skits, Gardner used Pay Rose to get things started. Because my friends, historically, tended to be few in number and pretty masculine, Gardner's plan was to introduce me to some of Pay's masculine LGBTQ friends and see if I connected with any of them. I liked Hugh because he was gritty and had a good sense of humor. Max seemed straight, but I only associated with him because we were in a band together, and he was a very competent musician. Once Pay saw that I really seemed to like Hugh, he informed Gardner (possibly via David Wilson or Lowell Bergman). To that point in my life, I usually only had maybe 2 or 3 close friends at a time, so being able to drop by and see Hugh, or maybe Pay, a couple times a week was perfect.¹

Pay soon introduced me to his *ex-girlfriend*, who now lived on the East Coast or something, and who, retrospectively, was almost certainly a fake ex-girlfriend. But Gardner correctly calculated that seeing Pay with a woman he identified as his ex-girlfriend would convince me he was straight.

In reality, Hugh was a bi-sexual who was not good with the ladies. But Gardner and Satan resolved to couple Hugh with the most beautiful young White woman they could find: Emily. Gardner likely insisted on pretending Hugh was dating Emily, hoping this would get me to "worship the beast", and overly admire Hugh –something I hadn't done since I was 14 years old and overly admired the rock band *Kiss*. However, seeing Hugh with a very beautiful "girlfriend", on and off, for 6 months or so, caused me to believe he was a ladies' man. After Emily and Hugh *broke up*, Gardner tried to bolster Hugh's image as a ladies man by having three girls (Palmy, Jimena and Amy) at Hugh's house, when I dropped by after band practice, for 6 months or a year. But the girls, who just sat around the livingroom, while Hugh and I talked, didn't change my already good opinion about Hugh.

¹ My old friend Rick was probably, technically, still my best friend. But from the time we were 23 (1988) to 35 (2000), our lives were moving fast in different direction. I was involved in music, then being a father; Rick was usually getting in trouble with the law. Eventually he settled down.

Thus, from the beginning of 1994 to mid 1996, the core male friends in my life were Hugh and Pay, and my band mates, Max and Marcus Brown. Although I thought we were all straight, in fact, only Marcus and I were straight. Marcus was also Black.

Gardner and Satan spared no expense for the joy of being able to giggle in their lair every time I told Hugh or Pay that I would never have a gay friend.

That's the solution to the mystery of my fake friends.

As for the reason Hugh was paid to kill four people from 1997 to 2000....

Satan hated me because God wagered I would solve His Revelation –no matter what Satan did, short of killing me.

But *Gardner* hated me because I was half Black –and because my older sister and I had extremely high IQs. This indicated racial mixing led to more intelligent children; a terrifying thought for Gardner. Gardner's hatred of me was so great that in November 1968, in the days just before he and Satan were finally free to commit unrestricted Mark Crimes against me, he ordered Dennis Wilson to try to kill me, in violation of the Wager terms, by poisoning me with strychnine and atropine. When the murder attempt failed, Wilson, on parole for a serious drug felony, was ordered to kill two innocent people –the first two Zodiac murders. A few years later, Dennis was ordered to kill two more innocent people, in the Santa Rosa hitchhiker murders, between 1972 and 1974. These four murders symbolized Gardner's war against the racially mixed, "unclean" boy, with an unusual connection to the number 4, who was predicted by God to solve His Revelation. To emphasize their war against me, Gardner also paid Dennis to bury some of Randall Yayayar's remains on my family' property. Randall was murdered because he was a distant relative of mine.

Against Satan and Gardner's symbolic war declaration, I was fortunate to have been born healthy and strong. This meant I would likely have children and multiple. But Satan and Gardner resolved to prevent that, by paying Marina and David Wilson, and Pay Rose and Chris Baridieaux to interfere with my dating life.

In 1996, having a child was not an immediate goal. That seemed like something to do a bit closer to 40. Nonetheless, in October 1996, I became a father.

Gardner and Satan were not happy. A few months later, Gardner resolved to pay Hugh, whom I consider a very good friend, to murder four *niggers* over a period of four calendar years –a punishment inflicted upon my race because I had multiplied. To emphasize this new chapter in their war against me, Satan and Gardner resolved to make sure Hugh's first victim shared my true family name: Yayayar. So Harry Yayayar was murdered by Hugh Schreiber in 1997.

TERMS

These are the participation agreement Terms of **Steven Kenyatta Briggs** (whose original and true family name is Yayayar; thus, I may also be referred to as Steven Kenyatta Briggs Yayayar, etc; other names I am known by are included in the *Signature* section of these Terms), related to my involvement and participation in what appears to have been the final *Revelation Wager*, between God and Satan, which began sometime in 1888 and ended sometime in 2025. Some evidence suggests the Wager ended around January 2025, but went into a period of arbitration or “hold” because I had not provided my terms, AND because there may have been a dispute about a key date (this dispute is addressed, in part, in *The Wagers PDF*, Wager #9). These terms can be loosely referred to as my *Wager Terms*, although at no point in these Terms do I wager with God or any laterally party.

These are the retroactive Terms of my participation in a Wager between God and Satan, in which God predicted I would accomplish certain things, and Satan requested permission to harm me and prevent me from accomplishing those things, and God granted Satan that *right*. Although God may have informed Satan that I would be permitted to enter my participation Terms later, retroactively, it is also possible that Satan was unaware, and God unilaterally provided for these Terms based on the laws of reason and fairness. In the Book of Job, we see God and Satan make private agreements, involving only God and Satan, which impact Job. Thus, I assume Satan initiated similar two-party agreements with God, involving me, a third party. Thus, these Terms are made with God, but unconditionally impact Satan and all of his minions, beasts and subordinate actors, as described, without any performance expectation, etc, on my part.

Should Satan or God prefer or require that Satan or any subordinate parties be identified as parties of the Terms, they and all other preferred or necessary parties are hereby made parties of these terms –although once these terms are signed, no party can have any remaining active terms that impact me adversely, forever.

All passages of these Terms, from the opening title, to the final word of the closing signature, and every bullet point in between, are enforceable aspects of these Terms (not just the 44 numbered items).

- These terms must not impact anyone who is innocent, and/or who did not knowingly take improper action (it does not matter if they knew their improper act would impact me, or anyone else).

As previously explained, God entered into a series of Wagers with Satan, related to God's *Book of Revelation*. God appears to entered into these wagers (1) to accelerate human evolution, and (2) reduce the duration of one or more periods of massive human suffering. I was "contemplated" in the earliest Wagers, which pertained to God accurately predicting who would solve (or *sufficiently solve*) his *Book of Revelation*. It appears that God predicted this somewhere between 1,900 and 4,200 years in advance. I am the person God predicted would sufficiently solve His Revelation.

I was primarily an unwitting participant of the final Revelation Wager, which might properly be called either call *The Beast Wager* (because the Wager gave Satan two human *beast* minions, in succession) or *The Destruction Day Wager* (because a great deal of Wager attention appears to have been paid to the date God would destroy Babylon –the US, and likely portions of its allies). Most of the details of the final Wager are not known to me, and most of the details of the prior Wagers are not known to me. However, I do know:

1. Satan and his minion or their subordinate actors were allowed to do harm to me (although I believe acts of violence were not allowed), but they were NOT allowed to kill me, or to *try* to kill me.

From what I've pieced together, there were at least two major pieces to the original Wager, which are (roughly):

- a. Satan bet God that He could not write a book of coded prophecy and revelation AND predict who would solve His Revelation, 1900+ years in advance.
- b. As the Wager allowed Satan to try to harm me, Satan must have had a Wager provision that required God to identify His solver, to allow Satan to harm me, and to try to prevent me from solving God's *Revelation*.
- c. Great attention appears to have been paid to the date of the One Hour War (the Destruction Date), as witnessed in *The Zodiac Killer's Identity Revealed*.¹ (My theory on why Satan focused on this date is in the footnote below.)

After the *Book of Revelation* was finally written and published, Satan appears to have made one or more new Wagers concerning various aspects revealed in *Revelation*.

During the Wagers, God gave Satan the ability to see all or most significant human event up to 274 years in the future, perhaps more. God also allowed Satan to see

¹ The fact that Satan and the West seem to have taken great effort to predict this Date and stop God's War from occurring on what was in fact just a *false strike* (Deception Date) may indicate Satan and the West mistakenly assumed God would not directly intervene in this War, if necessary. Currently (November 2025) it appears that God's preference is that His Eastern allies liberate themselves, but God's Elder base Revelations show God, if necessary, will fulfill His Own Will.

- From Satan's preoccupation with this Date (spying on my solutions, etc), it is possible he wagered that if he prevented the Destruction Date, he could avoid the Lake of Fire, and live forever on Earth, corrupting mankind. I speculate this because, although it was in the West's interest to focus on this date, Satan (impossibly selfish and disloyal) had no reason to prevent the fall of Babylon.

me, and most of my life, and my Revelation solutions (which I regularly updated and published) over 200 years before my solutions were written, and over 140 years before I was born (see *The Wagers*, Wagers #4, #6, #7). Because God allowed Satan to watch most of my life **in reverse** (also Wagers #4, #6, #7), Satan was able to follow my parents and ancestors going back to between 1777 and 1820. Thus, around this time (circa 1820), we see slave selling and “breeding” in the U.S. explode. Once Satan saw that my paternal ancestors were Black, and their true last names were *Yayayar*, Satan inflicted even greater punishment on Blacks, and killed many of my ancestors. Thus, in my Notebook, we see Satan kill Randall *Yayayar*, Para *Yayayar*, Pamela Rossford (mother of Para, and who loved Randall), Harry *Yayayar* and Erica Corran (who loved Harry). These attacks represent attacks on my family and race. Thus, my direct involvement in the Wagers dates back to around 1777 (the year God affixed His first set of badges on *Nuestra Señora de Guadalupe*). Accordingly, my Terms respond to Satan’s attacks on my family and my race.

At least one of Satan’s new Wagers (entered into *after* the *Book of Revelation* was written) appears to have focused on Mark Crime (Unforgivable Crime) #18. Because Mark Crime #18 (and several other Mark Crimes) were written by me (but approved by God), based on reason and fairness, but not necessarily flowing from the Revelation clues and evidence, it is probable that Satan requested a specialized *Mark Crime #18 Wager* with God, adjacent to any concurrent Revelation Wager(s), sometime between 1777 and 1888.

Although God and Satan may have had provisions to end the Wager(s) if one party cheated, I had no such option. During the final Wager, Satan and/or his Beast (Gardner) tried to kill me, in 1968 and 1993. I believe Satan’s and his second beast, John C Malone, also tried to kill me once or twice.

Based on the preceding information, and based on what I believe is fair, reasonable and just, my Wager Terms, delineating the non-negotiable terms of my Wager involvement (unless I feel like negotiating an item, to suit the needs of God, Jesus, or Natas) follow:

1. My Wager Terms supersede all other Wager terms entered by God, Satan and/or either of Satan’s beasts (John W Gardner and John C Malone), and/or any Terms entered by any other unknown Wager participants.
2. My Terms are “adjustable”, and can be altered in perpetuity, however I see fit – without negotiation. And these changes must be accepted and enforced to my satisfaction and expectation, immediately. This concept of an “adjustable” contract comes from contracts that were introduced in the US, at Satan’s and Gardner’s and Malone’s behest, which made the terms of home loans which the US primarily offered to Blacks and minorities unexpectedly change, after a couple years, in favor

of the banks, and suddenly homebuyers' monthly payments doubled or tripled; forcing the homebuyers to lose their homes –and their money.

3. No other party in this agreement can have or submit terms that are adjustable –only me ("only me" is the mantra of Satan and the US/West).
4. These Terms contemplate **God** and **Satan** and me (Steven Kenyatta Briggs, AKA Steven Kenyatta Briggs Yayayar...) as the **Primary Parties** of these Terms. These Terms contemplate John W Gardner and possibly John C Malone as **secondary parties**, who are included under Satan. These terms contemplate any human party who executed or carried-out a direction or suggestion that originated with John W Gardner or John C Malone or Satan, that was in any way harmful to me, or harmful to any basically good person, or clearly unwelcome by me (e.g., spying on me via direct observance or second party interviews; hacking into my computer, phone or cable-box; attempting to pester, harass or intimidate me; stealing my property...) is a **subordinate party** to these Terms. God and I are allied in this Wager, and none of these terms can impact God or me adversely. Satan and his secondary parties, Gardner and Malone, are allied under these terms, and all share in the specific major punishments described herein. All **subordinate parties** must be punished as specifically directed in these terms (typical punishments are being killed or substantially disabled by God, during their lives on Earth). Satan, Gardner, Malone and their allies and subordinate parties profited and made hundreds of millions of people (likely billions of people) *involuntary parties* in their corrupt contracts, by bribing politicians, judges, businessmen and statesmen to take secret actions (which impacted millions) that they would not take otherwise. These bribes and improper and conditional campaign donations were contracts –agreement to receive benefit in exchange for action. Because these subordinate parties adversely impacted my life, although I was not a voluntary participant of their improper agreements, and they likely impacted the lives of many other people, these subordinate parties are made involuntary parties to these terms, and they will be punished as described herein. In these Terms, The Primary and secondary adversarial parties (Satan, Gardner and Malone) must ALSO be treated as the final *executor* for any action they order (if they order a murder, they are the murderer).
 - Gardner and Malone may not have been signatories, or official parties, of the original *Beast Wager*, etc, but they are the hands that fulfilled Satan's actions against me, thus, they are part of these Terms. Any time in his post-human-life that Malone is not in the Lake of Fire, should be spent doing the same punishments described herein for Satan and Gardner.
5. Any entity who is not named in item 4, and who is not known to me, who may have previously been an unnamed party in this/these Wager(s) is hereby no longer a party of this Wager, until and unless they are revealed to me, as well as their Terms, and I am given time to update these Terms to nullify their terms.

6. My Wager Terms *adversely* apply to Satan, John W Gardner and John C Malone; meaning, my wager Terms are intended to harm Satan, Gardner and Malone. This means these Terms CAN NOT be applied or construed in ANY WAY that is useful or helpful to Satan or Gardner, or in any way that brings injustice to God's universe.
7. My Wager Terms are intended to help God and Jesus and Natas, and can be modified to the liking of God, Jesus or Natas. However, I reserve the right to refuse or negotiate any Divine modification that (1) harms someone I sought to Save (get accepted into Heaven), (2) seeks to reduce Satan, Gardner or Malone's punishment, described and demanded herein.
8. After the day/moment that I sign these Terms, across space and time, no party to God's and Satan's Wagers can have any active Wager term that I do not like, or that I disagree with, or that negatively impacts me. If any such term had existed, it is hereby nullified.
9. None of these Terms are conditioned on any performance aspect of my inclusion in the Wager(s).
10. In these Terms the word/name *Satan* or *Lucifer* applies to the Biblical figure/villain known as Satan, Lucifer, the Accuser, the Dragon, the Serpent... And the term *Beast*, *beast*, *Beasts* or *Beasts* apply to either or both John W Gardner and/or John C Malone. "Gardner" refers to John W Gardner. "Malone" refers to John C Malone. These parties may also be referred to as *convicts*, etc.
11. Any party who does not understand any portion of any passage in these terms must consult me (through God, Jesus or Natas), and that passage will be clarified to mean anything I want it to mean.

Concerning Satan, Gardner, possibly Malone, etc.

12. Neither Satan, nor his beasts (Gardner and Malone), nor any party that Satan's beasts deploy or contract, can *try* to kill me during the course of my life on Earth, from September 24th, 1964, forward. (I'm quite confident this was a term of Satan's Wager with God. If not, it is now, and it is hereby retroactively applied.)
13. If Satan or Gardner or any other party of Satan and God's Wager(s) attempts to kill me during their Wager(s), or after their Wager(s) ends, that party has thereby and hereby lost any and all portions their Wager(s) (including previous Wagers) that either God or I wish for him/them to lose; and, where beneficial to God, they (Satan, Gardner...) have thereby/hereto won any part of those Wagers that God or I wish for him to win.
14. If Satan or Gardner or any other party of their Wager(s) attempts to kill me during the course of their Wager, or after the Wager(s) ends, or if they attempt to kill me AGAIN (a 2nd, 3rd or 4th time), then: (1) ALL of the consequences that I invoke in these Terms upon Satan and Gardner (and Malone if he is not in the Lake of Fire), and any other party, must be doubled upon that party(s); and (2) if they try to kill me a 2nd, 3rd, 4th time, then ALL of the previously doubled consequences must be

doubled AGAIN, for each murder attempt; and (3) God is freed from any and all prior contracts with that party, except those contract elements that God wishes to continue and observe (under this provision, only God's preferences will be considered and upheld); and (4) once every 24 hours, the convicts (Satan, Gardner) must either say, "I was so stupid to think I was smarter than God," or say, "I was stupid to underestimate Steve Kenyatta Briggs" (or they can substitute the name "Steve Kenyatta Briggs Yayayar"). If Satan or Gardner (and Malone, if applicable) fail to say this in a 24 period, time must be suspended where they are, and they must spend an hour in specialized Gehenna-like area that produces heat halfway between level 10 of Gehenna and the Lake of Fire.

- The body they will use for this consequence is provided under item #15.
- In addition to trying to kill me somewhere between 2 and 4 times (maybe more), God has revealed that Satan and Gardner violated the rules, and began their attacks on me when I was only 2 years old, by having my babysitter infect me with pneumonia, which caused a seizure, which reduced my very short term memory. I believe God so prominently revealed this crime (in the Crime Timeline starting area –BEFORE my inclusion in the Wager was Authorized under God's Wager Terms) as a nonverbal direction to use this a basis to take action against Satan and Gardner for all actions against me, my family and race, that began BEFORE I was born.
- To utilize Satan as God's unwitting accelerator agent, God allowed Satan to negotiate a deal that allowed him to avoid consequences for somewhere between 1000 and 1400 years, as he sits comfortably in the Bottomless Pit, tormenting minds in Gehenna. Gardner arranged a similar deal. These tremendous delays represent the grossest miscarriage of justice. Delays are tactics of agents of injustice. In the Notebook body I described God's efforts, in curtain form, to delay my work. I believe God utilized these delays to get me to address and undo and correct the terms that Satan arranged. Thus, from the moment Satan is sent to the Bottomless Pit, to start his Gehenna torment services, Satan and Gardner must do the following (items 15 through 19):
 15. PART ONE: 12 consecutive hours of every 24 hour cycle of Satan and Gardner's time in the Bottomless Pit and/or Gehenna should be governed by the Terms, and the remaining 12 hours governed by God's previous terms with Satan and Gardner –unless God chooses to update those terms based on his right to do so under provisions in these Terms. PART TWO: I believe Satan and Gardner will be kept in a spiritual form in Gehenna, without an actual body. Thus, Satan and Gardner must be provided with separate bodies, to experience the various unpleasant consequences described in this section. These separate bodies should be the only things their remote spirits physically feel in the Bottomless Pit, at all times (or for the 12 hours governed by these terms), although these bodies are in Gehenna, or elsewhere. These bodies may need to be transported or teleported to various

locations at different times. Because Satan and Gardner are deviants and will try to pleasure themselves, given the opportunity, these bodies will not have genitalia, and especially not an anus. These bodies should have clothing over the abdomen, groin and buttocks; but the head, neck, arms, lower legs and feet should be exposed. The bodies' noses and ears should function and transfer all unpleasant odors and sounds to Satan and Gardner. Their bodies should not be able to make any attack or defensive motions, nor should they be able to flee. The bodies should be quite small, so they can't physically threaten any of the souls condemned to Gehenna. The mouths on the face of these bodies should not be able to open or speak when they are in public view. **THE PUNISHMENT:** Once every 24 hours, during the first hour or two of a 1-4 hour torment break that the souls of Gehenna *may* get (if God approves), the millions of condemned souls of Gehenna should be asked if they would like to spit (a big thick disgusting spit) on Satan and/or John Gardner. If possible, it would also be great to allow the damned to urinate on Gardner and Satan. To accommodate this. God or Jesus will likely need to make Satan and Gardner's separate bodies appear to millions of condemned at the same time. That may mean using many representations of the same body, bombarded with spit and urine. This should, through the miracle of God and Jesus, take less than an hour. All of that spit and urine will transfer and splash upon Gardner and Satan's true bodies, and their bodies will soak in spit and urine for the next hour. The spit should be infused with actual germs, like actual spit. **NOTE:** Although it may not have been intended that souls in Gehenna should be able to expectorate or urinate, I believe allowing this, exclusively for punishing Satan and Gardner, is just. If this is not allowable, I will be allowed to replace this punishment with something comparable, or worse. Selecting a smaller group of maybe 100 or 200 people who will spit (and possibly urinate) on Satan and Gardner is also possible.

16. Because Satan and the US tried to make digitizing souls a reality and tried to realize my replicator/accelerator concept, on alternating days, Satan and Gardner will be placed in a rehab replicator/accelerator for one hour every 24 hours. That one hour will simulates one month, and it will feel like one month. In the replicator, because they are deviants, Satan and Gardner will not have genitalia, and they will face different challenges. If they do not wholeheartedly perform the challenges, they will be sent to digital Gehenna, level 10.5 (where they will experience heat halfway between Gehenna level 10 and the Lake of Fire) for what feels like the remainder of their 31 day replication experience (which actually transpires in just an hour, or less). In the rehab replicator, Satan and Gardner will face such challenges as being a very creative non-Whit persone, in the US under Satan and Gardner (1946 to 2000), and trying survive and perform 33 good deeds per day, without committing any sins, as replicator Satan and Gardner try to sabotage them; at the point that their replicated soul commits a sin, they must go to the extremely

painful replicator/accelerator Gehenna, level 10.5, for the remainder of the replicator day, until the next replicator day begins.

17. On alternating 24-hour cycles, Satan and Gardner, separately, will spend one hour (1) in an actual (non-digital) Gehenna-like environment that reproduces the heat of Gehenna, level 9, but on the following 24 cycle they will separately spend an hour in a/the replicator accelerator, for a period that feels like 24 hours, where they are subjected punishment ideas offered by souls in Heaven, or offered by souls condemned to Gehenna levels 1 and 2. These punishment ideas should change every 24 hours. Good ideas can be reused as often as God or Jesus like.
 - Items 15, 16 and 17 cover about 3 or 4 hours per day. Item #18 explains how 8 of the remaining 8 or 9 hours of Satan and Gardner's daily punishment routine governed by my Terms will be spent.
18. Satan and Gardner will experience four (4) hours of Gehenna level 8.5 heat, while they torment souls in Gehenna. Either their souls in Gehenna can feel the heat (if God prefers), or their separate bodies in Gehenna. If the convicts say, "I was so stupid to think I was smarter than God," the heat can be reduced to level 8. Next, Satan and Gardner should experience 4 hours of cold, while they torment souls in Gehenna; the temperature should be 32 degrees Fahrenheit (0 Celsius), as experienced without a jacket (just as Gardner saw to it that I dealt with cold without a jacket when I was in 3rd to 5th grade); if the convicts say, "I was stupid to go against Natas," the temperature can be increased to 36 degrees. If, during this period of 8 hours of heat and cold punishment, there is a noticeable decline in the quality of the tormenting/psychological services that Satan and Gardner were contracted to provide for Gehenna, at the end of the 8 hour shift, God will suspend time, and the convicts must spend 1 to 8 hours (based on the severity of their performance decline) in an ACTUAL heat zone that achieves heat halfway between Gehenna, level 10, and the Lake of Fire.
19. Satan and Gardner may not communicate in the Bottomless Pit, or anywhere else in their afterlife punishment –unless God or Jesus think they *should* interact.
20. All of Satan and Gardner's punishments, described herein, can be changed and replaced with new punishments, as needed or desired by God, Jesus or Natas.

Regarding Satan and The Beasts' Allies on Earth

21. Over the past three years, many times, Satan, Malone and/or the 666 have sent people to try to intimidate me. Henceforth, God will immediately kill or appropriately debilitate anyone who moves to kill or intimidate me, long before they get near me. And God will do so gloriously.
22. At the time that I write this, Satan and the beasts' minions continue to spy on me. From this point forward, anyone who spies on me, or deploys others to spy on me, via technology or not, must be killed or severely debilitated, quickly, (with possible exceptions for a few dumb loved ones, whom God will know).

Related to Nations

23. Because Satan took his war against me 205 years back in time, to 1777, and increased suffering on Blacks, everywhere, especially in the US, all Blacks who were born into hardship, slavery, unfairness, poverty should be given a **4-level boost** (thus, people who were slated to go to level 3 of Gehenna, can land on the ground floor in Heaven). This intervention should extend back 410 years ($205 + 205 = 410$ years), because there are places in the Bible where repayment of harm is doubled. Taking the consequence back to the beginning of European enslavement seems appropriate. Also, under this item, any slave who killed his captor, seller, owner, is exonerated.
24. Many other non-White groups were persecuted and faced extreme difficulty and genocide at the hands of colonizing Western Europeans (such as the Aztecs and most indigenous people of the Americas, and the people of India, much of Africa, the indigenous people of Australia, and China after it was conquered and divided in the 19th century, and Haiti..., and in more modern times, nations like North Korea, Iran, Palestine, Cuba, Haiti, Venezuela, all faced debilitating Western interference and sanctions...). Thus, all non-White people who faced substantial adversity caused by colonization, or post colonial oppression, should be given a 4-level boost. Also, under this item, any oppressed colonized subject who killed a party who was complicit in his/her subjugation is exonerated.
25. There are also, of course, White nations, such as Russia, that showed great perseverance in the face of isolation and antagonism from the West, brought about because these nations chose a moral path. This isolation caused great economic hardship. The people who suffered in these difficult periods should also receive a 4 level boosts.
 - God and Jesus can adjust these boosts as they see fit.

Special

26. Based on the disgraceful preoccupations that the Elder base revealed humans have with the wide variation and dissimilarity of their genitalia, God, Jesus and Natas will discuss the benefits and consequences of intervening to narrow these parameters.
27. Because Westerners have used disinformation to avoided accountability for generations, Mark Crime #18 should be implemented henceforth, but Westerner Heirs will continue to go to Gehenna (Hell) level 3, in perpetuity, without beginning the 3 or 4 generations of *Heir* punishment, contemplated under this Crime, until the Western nations openly teach their children of the crimes of John W Gardner, and properly attribute the many, many Western works and idea stolen from me. Once they do, the 3 and 4 generations begins tolling. Under this item, if the West wishes to conceal their crimes, they may, at their own expense, and the expense of their children.


Related to Victims Connected to Me

28. ANY person murdered in relation to me (Okokon Okon, the bodies on Chico Avenue, Santa Rosa, Randall Yayayar, Pamela Rossford, Para Yayayar, Harry Yayayar, Erica Corran, Clarrissa Jones, Darnell Mitchell...) must be allowed to enter Heaven, at level 1 or better.
29. Any person named Yayayar who faced difficulty related to me must be allowed into Heaven (with reasonable exceptions).

Related to My Family and Friends

30. I have the right to revise my list of people I can Save until Final Judgment.

On the Gehenna train, God positioned my son's icon (#33, right) above the train, meaning he is exempt. This was done because God knew Satan would target my son. The Elder base also indicates God gave special protection to my nephew Vince, and my niece Mercedes, who Satan was apt to target based on the time I spent with them when they were younger.



31. This is my list of family members and friends to Save:

My son Jiano, my son's mother, my mother (Cecile Lusby), my father (Archie Briggs), Vince Marchbanks, Layla Marchbanks, Brandon Marchbanks and Jackson, Mercedes Marchbanks, Ed, Nexus Assoon, Melvin Jackson, Marquis Jackson, Melvin's daughter, Okokon Okon, Virginia Lusby, Gwen (Gigi) Briggs, Avory, Nicah, Jonnah, Tony Galleguillo (Guileguilo?), Cathlene Brown, Lisa Gleaton Elerby, Shawn and Jeannie and Rider Chernilla, Jacob Bergman; a bunch of the kids I used to work with: Marcos Vega, Bismark, Evan, Keith B, Tony R, Lee S, Billy..., and if Rick E needs help...

- I'll ask Jesus to weigh in on Indy Briggs, and Chris Lusby.

Special Privileges

32. If I am NOT one of the 144,000 deemed worthy to enter Heaven in the Resurrection described in Revelation 14:1-4, I must be resurrected immediately after I die. Not long after I am revived, I will be taken to the place and time of the performance of The Song, described in Revelation 14:1-3, and I will be able to hear The Song and view the performance, as intended. If doing this requires that I listen and view with no visible body, that's fine.
33. Since extremely few humans have yet been resurrected, I can resurrect 4 people to join me in Heaven early; they are: my son, his mother (my son would not be happy without her), her brother O.B., and my best friend Rick E.

- I will probably request that this group be allowed to hear and view *The Song* with me.

Additional Special Privileges and Powers

34. I can double the length of punishment of anyone who has committed Mark Crimes against me, or anyone who has either killed (1) someone in my family, (2) a friend (Darnell Mitchell), (3) someone I care about (O.B.), (4) someone in my family tree named Yayayar (Randall, Harry), or (5) a loved one of a Yayayar (Erica Corran and Pamela Rossford).
35. At Final Judgment, and any applicable time and place, I can raise by four levels or decrease by four levels, the afterlife punishment level of any person who has committed substantial Mark Crimes against me.
- Thus, J Michele Royalty Wilson contributed to killing O.B., so she goes to level 10. David Wilson helped kill O.B., but he's already going to the Lake of Fire, so his LoF time will doubled. Marina's time will also increase. Whoever killed Darnell Mitchell goes two levels deeper. Whoever killed Randall, Para and Pamela goes 3 or 4 levels deeper...
36. All Unforgivable Crimes related to me must be frozen and assessed last. This means these various Mark Crime violations will not be forgiven. I will then be given an opportunity, at my convenience, to learn of each violator's Crimes against me, and decide, if that violator's Gehenna punishment should be increased/worsened by 1 to 4 levels, or if their time should be doubled.
37. I will be allowed to impose up to 100 years in Gehenna level 10 replication/acceleration, with all variables I choose or God or Jesus suggest, upon anyone who knowingly contributes to replicating or digitizing a human soul. This accelerated punishment will feel like up to 100 years in God's replicator/accelerator, but, in the outer reality, when the simulation ends, only an hour, or a month, or a year (or whatever time interval God wishes) will have elapsed. This does not replace one moment of the condemned soul's regular Gehenna punishment, and must be completed before their regular punishment begins.
- Since this is an extreme intervention for an extreme crime, so God and Jesus can advise and moderate, of course.
38. If I am murdered, or my closest family members are murdered, all people involved (all planners, coordinators, drivers...) go to **the hottest parts of the Lake of Fire** for not less than **444 years**.
39. There are, of course, many homosexuals and LGBTQ people who respect the law. Perhaps because I have spoken strongly against Satan's successful efforts to infuriate God, Jesus and Natas by exploding the homosexual/LGBTQ numbers, worldwide, I worry that people who falsely claim to love God will harm homosexual/LGBTQ people, to show their false love through acts of hatred and violence. Thus, for the transitional period of 88 years, anyone who unjustly kills a homosexual/LGBTQ person must go 2 levels deeper into Gehenna. And during this


period, God and Jesus should be twice as slow to forgive anyone who unjustly **harms** a homosexual/LGBTQ person.

40. I will die, like everyone, as God wills. I hope it is God's will that I die peacefully. If it is not, and my death is not accidental, the hand that claims my life must be worthy (and item #37 will still apply to them, and to all involved).
41. I am an immigrant now, and I'm pretty old. For the remainder of my life on Earth, God should take care that I have adequate food and shelter, and enough money to fix my guitar amplifier, and maybe buy a good chair, and help others in need around me.
42. If, in my remaining time on Earth, I find myself in a land where I am not wanted, or not comfortable, or not content, God should get me to a suitable alternative, quickly.
43. This item negates any possible prior undesirable Wager term restrictions, and permits God and Jesus to resurrect, reward or punish, move up or down the afterlife system, as they believe is best, all souls not previously accounted for herein, from the time Satan arrived on Earth until Final Judgment.
44. **Mass collection of benefits in Heaven.** In Ezekiel 1:4-25, the Living Creatures (my alter-egos), get to propel God's throne. Thus, on special events where God might use a representational throne, if a throne driver/propeller/pusher is needed or preferred, unless someone more deserving has earned that right, I get that honor, or I can propel Jesus' or Natas' thrones, if those duties are unclaimed. Additionally, upon my arrival in the next life, beyond my level 10 abilities, I will be granted the right to travel throughout God's universe (which may already be a level 10 privilege), almost without restriction, in any manner I wish (with or without a body), without speed restrictions, far beyond light speed, at the speed of thought or imagination –or beyond, impervious to all heat and cold extremes, augmented by any reasonable powers I request (including the ability to effortlessly change form –no body, invisible body, body...). Should I ever prefer to travel less efficiently in a spaceship, God will provide me a state-of-the-art undetectable, universe friendly, ever-reliable spaceship, which will also be damage-proof and occupant injury-proof, with unlimited energy/fuel, and all other provisions also unlimited, able to travel hundreds of times the speed of light, with expandable interior to accommodate any deserving angels or Deities (or deities). I'll also get a place to park my spaceship, where it won't distract others. Also, upon arriving in Heaven, I will receive 1 to 4 good quality guitars (new or used), preferably electric, and a great amplifier, with tons of different sounds and a self-contained unlimited power source, replacement strings, cords (if needed), etc.

My birth name is/was Steven Kenyatta Briggs (below, left).



For many years I also integrated the last name *Wilson*, which appears on my driver's license (above, right), as seen in *Revelation 2: The Solutions*. While solving God's Elder base revelations, I learned my true family name is *Yayayar*.

Lacking the technology to transfer a signature made with a pen to these terms, to the right, I used my computer mouse to sign my name, (1) under my birth name, (2) under what can be considered my true name, (3) under a hybrid of #1 and #2, and (4) under the name on my driver's license.

These signatures bind me to these terms, and to God's Wager(s) with Satan.

In *Revelation* and in the Elder Badge, for various reasons, God also identifies me with certain numbers, letters, and phrases, including (but not limited to) the following (each of the following numbers, phrases, letters, sequences of letters, etc, represent my signature, by that number, letter, etc.):

These updateable terms were first signed November 19th, 2025.

These terms were last updated on November 21st, 2025.

Mystery Question #15: Why would God allow me, Satan and Himself such great powers, based on a Wager?


The West used these corrupt contracts, for centuries, to degrade the lives of hundreds of millions -likely billions- of people, who were not parties to those contracts.

God used one open contract, with me, to undo the spiritual damage.



Signatures, Authorization & Additional Messages

(Below, “Part 2: **Signatures**” section from chapter 1, continues.)

In Jesus’ second lower canvas confirmation signature, below, the *J* seems to go to the top of the *Nuestra* canvas. I believe this is Jesus telling us He played a substantial role, with His Father, in creating the real *Nuestra Señora de Guadalupe* –which was desecrated and stolen in the 17th, 18th and 19th centuries.



Primary ID Number Confirmation. To confirm God’s signature, God put 7’s in and around His signatures. Notice the three larger 7’s in the *D* below (left), and the eleven smaller 7’s, also in the *D* (below, right).



Outer Signatures and Initials



God and Jesus also put their signatures on the outside area around the badges, in the lower left corner of Nuestra Señora de Guadalupe; pictured to the right.

In the center image, to the right, I've outlined one of God's signatures, which surrounds the badges, in black (ignore the diagonal line connected to the ends of the 7). Notice the signature is situated very close to the badges. This is because God is claiming creation of the badges only –not *Nuestra Señora*, which he originally created in 1531 –but God's work was stolen and desecrated over the next 200 years; today, the only surviving part is the Moon, currently hidden under a coat of black paint. (To learn about the desecration and theft of Nuestra Señora de Guadalupe read *Killing Guadalupe*.)


Next, if you enlarge a high quality photo of this area, between the badges, you see the outline of a single *smiling* eye, pictured center left. This smiling eye represents (1) *Image* crimes of Revelation, Chapter 13, and (2) a character featured in the art in the base of the Elder Badge. This was all done to confirm that God is only claiming Authorship of the badge art.

The hidden signatures and initial around the exterior of the badges confirm the presence of hidden images and messages in the badges, which I've documented in several previous publications.


- In the center and bottom images to the right, notice the 7's, on both side of the images.
- Notice the G is touching the D at the base.



Next, below, God wrote His name/title under or over the badges. Look carefully, the yellow outline against the light blue is hard to see. If you return to the image on page 8, you may agree that this is one of the easier signatures to find –once you know where to look. An amazing thing about this signature, and many of these signatures, is they were created in the nitric acid spill of 1820.







God's 4 Signatures to Identify Me: Steven Kenyatta Briggs

To confirm the Elder Badge as a gift from God to me (although it is also given to the world), and to identify me as His servant (or *volunteer*), God hid four more Signatures in the Elder Badge; presented below, as they rotate upward, toward the Elder, in the central field, an invisible D around him, formed from the image-points around him.




The invisible *D* also forms an invisible *4* around the Elder, in the image below. This is the shape of the *D* in the logo of my high school rock band, *Black Diamond*.




I don't expect anyone to believe the invisible *D* and the invisible *4* are there. One of the reasons God chose me as a servant is I say whatever I know to be true, even if it's *invisible D's and 4's*, no matter how many people disagree or doubt. The importance of standing by one's beliefs is a big part of God's Elder Badge messages.

In my prior Revelation-related projects, God only used numbers to identify me. But in the Elder Badge, God actually printed my full name. On the following page you'll see some of the ways God and Jesus wrote my name in the Elder Badge...



My middle name, Kenyatta, above -written twice, for verification- is the greatest gift. It features an *electric N*, the right arm of which projects an image of me, at about 10 years old, playing baseball, with nappy hair and a crappy glove; this image serves to confirm everything I wrote in *My stepdad Was One of the Zodiac's Santa Rosa Hitchhiker Murderers*.

God and Jesus also wrote two instances of my first and last names near my middle name (upper right), and wrote my first name many more times (lower right).





But this is just the beginning. God used the uniquely designed letters of my name to introduce some of the recurring letter shapes and art elements He utilizes in His hidden base messages. These recurring elements, and others revealed in chapter 2 and *Between the Lines ii*, confirm the messages, my interpretations and God's Authorship.

But the sweetest way that God and Jesus indicated I was their servant volunteer was the inclusion of my son in their identification process. A few inches above the badges is a faded image, which reminded me of a couple family photos, where my son, when he was a baby, crawled onto my chest and fell asleep with his face on mine, with his lips sort of puffed out. That faded image area is presented to the right.



God put a giant G around the badges, and Jesus put a giant J on the left side (further confirming He substantially contributed to Nuestra Señora and the Elder Badge; see below). In the image below, to the right, adding a line or two for my v-neck T-shirt creates the image of me and my young son sleeping, cheek to cheek.



The Meaning of it All

In the coming chapters, virtually every image God and Jesus reveal has more than one meaning and/or purpose, and often refer to other related characters and events. In the interest of efficiency and time, as this book progresses, I won't (and can't) explain all of the layers of meaning; but I may, at times, explain a second or third layer.

Likely, without your awareness, all of aspects of chapter 1 had other related meanings –in some cases the secondary meaning outweighed the principal meaning. In *Part 1*, God's use of signs was to show the power of visual images –and link the Elder Badge to Revelation's *Image Crimes*, perhaps the most effective and far reaching of the various Unforgivable Crimes. And, in showing us how images of people can transform into numbers, and how numerical dates transform into people, God is showing us that He and Jesus may use numbers in the badges (and in the Bible) to refer to people, events, etc.

In the *Signatures* section, God and Jesus made various underlying statements. By rotating His signature toward the Elder counterclockwise –against the direction that clocks tend to move in– God foreshadowed His many revelations in the Elder Badge (and in the Book of Revelation) that He can, and does, reverse time, when necessary.

By positioning their signatures close to the badges and away from Nuestra Señora, God and Jesus confirm the existing Nuestra Señora is a terrible fake, vastly, vastly beneath their flawless, effectively 3-dimenstional, original Nuestra Señora de Guadalupe image.

The Higher Meaning of the Signatures

God and Jesus' many signatures serve as messages to the world to keep accurate records, and back them up, so your histories cannot be erased and corrupted, as the West corrupted the Aztecs', Guadalupe's and Juan Diego's histories.


By showing Their signatures linked by features like a lion and confirmation numbers, spiraling up, small to large, God directs all institutions, banks, newspapers, courts, copyrights, business registrations, etc, to block-chain their records, to prevent falsification.

Family

Because God and Jesus are infinite, so are Their communication options. From what I've observed and reported over the past two years, They are extremely efficient and well organized, this is expressed to a daunting degree in the Juan Diego Badge and the Elder Badge; perhaps particularly in the Elder Badge.

Although the true, original Nuestra Señora de Guadalupe image no longer exists, the battered and faded image we now accept Nuestra Señora still reveals God and Jesus' efficiency and organization: an image of the representational mother of Jesus, hands clasped in prayer, standing on the moon (the winged child was not part of the original *Nuestra Señora*). This simple arrangement conveys meaning and messages enough to fill a book.

Currently, in these days just before the One Hour War, the most important message is the date that God will destroy the United States: December 7th, 2025. This message is carried in the position of Guadalupe's body and hands, and in the lower left corner, in the area of the badges, see below. (See **Revelation 2: The Solutions**, or **Killing Guadalupe**, or the **Destruction Date**, for much more complete information.)



The second expression of the 12/7 confirms the first.


In this corner, as you saw earlier, God and Jesus put several signatures around and in the badges. But They also make an extremely powerful and succinct statement with a single symbol, the number 2.



Efficient in the extreme, God makes many points with this single 2, such as:

1. The badges are affixed to *Nuestra Señora* are the second set.
2. The base of the 2 encompasses the two badges, to tell us the badges should be considered together, as related, a family. This also reinforces the primacy of family (2, often considered the smallest family unit).
3. The composition of the 2 demonstrates that “invisible” art, hidden in the badges, can be revealed by following (1) line and (2) color changes in the art. Other meanings of this 2 are explained later in this Notebook.

To confirm the 2 above, God and Jesus also hid a 2 between the badges (below, right).




Additional Image Messages


The first edition of this Notebook was maybe 40 pages long, or so. This second edition was completely rewritten, with hundreds of new image tracings, and over 400 pages, at breakneck speed, in five months, from late June 2025 to mid-late November 2025. In the middle of my rush to write and publish this, God (in my curtain) began to direct my attention to various parts of the *Nuestra Señora* image. But, in these instances, rather than just gesturing, like a curtain, God moved my computer display image to the exact image area that He wanted me to consider.

Once I realized He was trying to get me to see something, I began to trace whatever I saw at that moment. I probably outlined about 12 images. Five of those images, presented in this section, were worthy of inclusion, for your consideration. HOWEVER, retrospectively, although I think God intended the various messages in these 5 images, I think His larger mission was to get me to see and decode the *Natas messages*, also found on the *Nuestra Señora* surface.

STATEMENT OF FAIRPLAY:

In late 2024, I reported that God and Jesus manifest Themselves to me, in the form of inanimate objects in or near my home. I also explained that They do not use words to communicate to me; rather they use gestures –and I only understand less than 10 of these gestures. In early 2025, I disclosed that the objects through which They presented Themselves to me were two curtains in the living area of my home, in Mexico. In *Killing Guadalupe* and *My Stepdad Was One of the Santa Rosa Hitchhiker Murderers*, I describe God and Jesus' regular communication with me. In *Killing Guadalupe* post section, I explained why God also used this communication to deceive me, regularly.

I address this now to assure readers that God and Jesus continue to communicate with me daily, via my curtains, HOWEVER, in no way did God help with any solution in the Notebook. In fact, God frequently, almost daily, tried to mislead or distract me from completing my work.

Some of you who read the *Killing Guadalupe* “Post” sections know that I allege most of God’s unusual behavioral displays and deceit was related to the terms of the final Wager God made with Satan. Currently, I believe the Revelation Wager ended at some point in or near January 2025 (although I still don’t understand all of the Wager terms), but it’s possible that the Wager does not officially end until December 31st, 2025. But the thing that I believe is most important to God, with respect to this Notebook and the possible end of the Wager, is that people who read this Notebook understand that NEVER did God help me solve any mystery in this Notebook, or *Revelation 2: The Solution*, or *The Wagers*, or *Killing Guadalupe*, or *My Stepdad Was One of the Zodiac’s Santa Rosa Hitchhiker Murderers*, etc.

Conversely, in *The Wagers* and *Killing Guadalupe* we see evidence that once Satan grossly violated the Wager rules, God complied with the specified rules, but He did not comply with what Satan may have assumed or inferred. God’s point in doing this was to instruct humans to take the high road and adhere to all civil rules, contracts, etc; but when dealing with an enemy who does not and will not comply with rules, then respond in kind. This message is intended for us on a personal level, but it also represents how all law-abiding nations should deal with a nation that cheats and/or bullies, like the US. People should also understand that God would never ordinarily stretch or bend rule, this was done as a lesson to humanity. As the Father of all life, on rare occasions God must impart important moral and survival lessons to humanity. Morally, God would never cheat –except to give a moral lesson on how to deal with cheaters and evil people. But if, for demonstrative purposes, we begged God to suspend all morality and engage in a Wager with Satan, the intellectual gap and the ability gap between Satan and God is so infinitely vast, even with all morality suspended, God would never need to cheat.



Notes

Owed to the fact that I completed the body of this Notebook later than I hoped, I had to hastily put this *Notes* section together. In this section, in no particular order, there are a few bullet points, and a few short segments that I wrote for the main Notebook, but later couldn't find an appropriate chapter for those segment, so I tossed 'em in the Notes. I'll update and polish this section when and if time allows. The Notes begin...

Bullet Points

- For years I've publically reported, to no avail, that the US government and certain elites were hacking into my computer, phone, etc (by the way, I specifically named many of these elite parties, and reported their hackers' names, business name, and published the hackers photos, and submitted this, in sworn declaration to US federal court, and the FBI). As I have reported in the past, the parties hack into my various devices to try to steal what I am writing and quickly attribute those ideas to some flunky, so my original source reporting seems derived when it's released. It's brilliantly evil. Many Westerners who have witnessed the truth in my allegations have seemed very pleased with their leaders' activities, as if fancy theft were more honorable than breaking and entering.

These hacks continue to this day. Currently, because this Notebook is infused with so many irrefutable *Revelations* and *revelations* from God, the hackers have to race to get in front of the stories. Although there are bigger stories in this Notebook than the fact that the US President (Donald trump) is (1) a huge and disgusting pedophile who raped children on Jeffrey Epstein's plane, and (2) a huge and grossly promiscuous homosexual, the Trump/Epstein story *is* the biggest story to certain people –especially everyone in positions of great power in US, particularly the child-raping US President.

Although I've heard the Jeffrey Epstein story has been floating around for over a decade , and for all of those years the Republican party has effortlessly delayed and blocked any legal motion on the matter, by bribing US attorneys generals and prosecutors to ignore the matter, then those same Republicans raced

- In earlier versions of the Mark Crimes, I indicated that deliberately contaminating another nation's or group's water supply was a Mark Crime, but later changed that. Contaminating water is one of the most evil things you can do, but if a nation or people is not going to defend their most sacred asset, their water supply, and allows anyone to come in and tamper with it, it's possible that God's view is *any people who are that trusting and thoughtless deserve the trouble they invite*.

Best Parenting And Development Practices

To honor Natas, mother of the universe, I put together some parenting and child development best practices tips, for mothers and fathers alike.

Parenting Tips

1. Try to use a calm, composed tone, or a happy tone, as often as possible. Using an angry, unhappy tone, too often, can lower a child's sense of self-worth.
2. Talk to your child often, and listen to their responses.
3. Avoid spanking and hitting as much as possible. Optimally, you want your child to respond to you because you are a wise and reasonable –not because you are big and inclined to violence.
4. Try to provide a reasonably consistent routine (bedtime a reasonable hour; be on time to appointments, etc).
5. Do not WALK in public, or drive, while using your cell phone. A child can walk into the street or into danger in an instant. Monitor your child. If you must use your cell phone in public, stop walking and hold your child's hand, and watch for dangers.
6. Don't assume your young child exercised enough at school. Try to take him/her out to a park for a while after school, weather permitting.
7. If your child is 6 or under, the best thing for her/him is playing –especially with another child he/she likes.

Best Development Practices for Children 2 to 6 Years Old

The US created Head Start preschool program to stunt the brain development of Black and Brown children, 2 to 6 years old. Head Start lowered children's IQs by 15-18 points. The US then exported these destructive practices around the world, with emphasis on Latin America and Africa. If you attended or witnessed a Head Start program, disregard everything you *learned* and adopt good child development practices, including the following:

1. If possible, teach the child in his/her native language, and **do not introduce a second language until after the child is 6 or 7 years old**. This is key to your child's IQ development, because

his/her IQ development is linked to his early language decoding prediction success.

2. **Don't be fooled!** Many children's TV shows, like *Sesame Street*, were conceived by John W Gardner, and the shows were intended to supplement destructive Head Start programs. The shows are destructive (1) because they encourage children to sit a watch (activity is best for children's brain development), and (2) because they use puppets and cartoons to communicate with children who are developing their language skills, and need to see real lips and tongue to learn how to produce the sounds and words correctly. If you want to allow your child watch some TV puppet and cartoon shows because they are entertaining, that's reasonable, but don't believe those shows are educational.
3. Don't enroll your preschool child (6 or younger) in a highly structured learning program that uses directed teaching, seated learning activities, or teaches logical thinking. For children under 6 years old, these methods impair brain development.

From 1934 to 1941, University of California at Berkeley ¹ studied the best developmental practices for children under 6 years old, and published the results on September 28th, 1941, the Oakland Tribune, "Too Much Supervision Said To Stunt Child's Initiative." Some of UC's findings were:

1. Organized group learning and instruction is bad.
2. **"The child learns more and develops more rapidly where he is free and active."**
3. "The good nursery school and kindergarten encourage the child to exercise his natural inclination to make various tests and trials on his own account."
4. "Children need a very large measure of non-interference in their play." **(Give children ample freedom.)**
5. Don't scold them.
6. "Nursery school and kindergarten methods are far better than those usually used in the ordinary grade class."
7. Each child should have a **choice** of activity, and be free to proceed without interference, as long as he allows the same for other people.
8. "Children can be weakened -made dependent and gullible- by being given too much assistance."

¹ About 20 years after this study, UC Berkeley made extreme and irreversible resource contributions toward the creation of Head Start, and permanently impairing the minds of non-White toddlers and preschool children.

UNFORGIVABLE CRIMES HISTORY

If you read *Revelation 2: The Solutions* you might get the impression God kept the Unforgivable Crimes hidden from public view for thousands of years, until I showed up and revealed them. That's not the case. Well, it might be true for the *Image Crimes* –which didn't come into existence until the 20th century.

Many of the Mark Crimes concern things like administering justice fairly, and not publishing false information, not offering or accepting bribes, fighting poverty and misfortune, not oppressing or mistreating foreigners... But all of this, and much, much more was addressed from the start, in the first 5 books of the Bible. A few examples, just from the Book of Exodus, follow.

Do Not Publish or Spread False Information

Exodus 23:1: You shall not circulate a false report...

Exodus 23:7: Keep yourself far from false matter...

Administer Justice Properly and Fairly

Exodus 23:3: You shall not show partiality to a poor man in his dispute.

Exodus 23:6: You shall not pervert the judgment of your poor in his dispute.

No Bribery

Exodus 23:8 You shall take no bribe...

Be Kind to Immigrants

Exodus 22:21: You shall neither mistreat a stranger nor oppress him, for you were strangers in the land of Egypt.

Exodus 23:9: Also, you shall not oppress a stranger...

Make Adequate Provisions for Fatherless Children, Widows and Unmarried Women

Exodus 22:22-24: You shall not afflict any widow or fatherless child...

If you afflict them in any way... I will kill you with the sword...

As far as *Image Crimes*... Image Crimes were 3500 years in the future, delivered through our eyes, via computer screens, TV and smart-phones. It was pointless to address these future crimes in Moses' ages –although God saw fit to have His Son warn us 2000 years early, in Revelation.

Methods in the War Against God

Over the centuries, Satan has used many tactics in his War, including:

1. As God can't be physically hurt, Satan attacks the people God loves (the *savable*).
2. As the first tribe to know, love and honor God, the Jews are like His firstborn. Thus, Satan devotes considerable time to misleading Jews to violate God's laws.
3. Encouraging people to commit high level sins (murder, sexual immorality...).
4. Using money to corrupt.
5. Satan knows God strongly disapproves of homosexuality; thus, he and the West use their media, politics, education and commerce to promote LGBTQ life.
6. Satan also loves to kill innocent people and young soldiers in wars. Wars are hard to initiate, but once they begin, Satan encourages all possible crimes.
- As Christianity matured, in the 16th century, Satan attacked in new ways:
7. Using the newly invented press to shape social opinion and split the Western Christian Church. (Some of the new false churches altered Bible verses.)
- The 20th century technology also allowed Satan to attack in new ways.
8. 20th century technology allowed Satan to add about 18 new types of Unforgivable Crimes (36 new Crimes when subtypes are added), plus a few new *Worship Crimes*.
- Mark Crimes are, generally, large scale social crimes that hurt many people.
- Worship Crimes, generally, tend to cause people to overly admire others.
- Image Crimes tend to alter human psychology and sexuality, and are usually caused by visual technologies (TVs, computers, pornography...).
9. Satan and the West falsified artifacts and documents for centuries. These schemes became very advanced in the 20th century's Dead Sea Scrolls hoax, which greatly altered the Bible. All news and document falsification are Unforgivable Crimes.
- John Gardner, the original Beast, was instrumental in adding at least 7 new crimes:
10. Creating *Head Start* preschool system to impair children's brain development.
11. Using mass media and film creators to clandestinely promote murder (through such tools as *Boys Beware* videos, gangster rap, etc).
12. Inspired by Satan's efforts to damn Jews, Gardner created a many-pronged plan to encourage non-Whites to do things that would get them damned.
13. Social Cleansing. Gardner launched a secret US state effort to profile all American students, and kill the profiles Gardner did not like –especially open-minded young White women who might be inclined to marry non-White men.
14. Profiling, to get ethical people out of US intelligence and law enforcement.
15. Creating a network of the 666 most powerful corporate and political leaders to dominate international commerce and thought.
16. Using a *board of directors*, and political internships, to corrupt institutions, by creating backdoor communication channels among elite businesses and politicians.

Between the Lines

The Enemy on the Inside:

How the West Uses Freemasonry to Degrade Foreign Lands

Satan is engaged in his War Against God. One of the primary ways Satan expresses this is steering as many nations as possible against God, knowingly or not. Accordingly, since God instructs mankind to treat other people and nations fairly and reasonably, Satan uses his Mason minions to lead their people against that. Masons (or Freemasons) tend to be powerful and wealthy and not inclined to admit their affiliation with Freemasonry. By getting powerful businessmen, politicians and judges as members in his fairly small “church,” Satan can discharge his powerful minions to enact policies that have far-reaching and always harmful, impact.

In the 15th century, Freemasonry likely seemed committed to the enrichment of all of Satan’s elite Western European followers. But, at the end of the 16th century, Freemasonry shifted its center to the UK, the first step in a new divided ranking system, designed to upset everyone but Satan and Mason nations on the top tier.

Once the US came into existence in the 18th century, the UK and the US were on Freemasonry’s top tier. Very fair skinned Western European nations like Germany, Netherlands and France were on the second tier. Slightly darker Southwestern European nations (Spain, Italy, Portugal, Greece...) were on the third tier. The new colonies were on the fourth tier.²

Freemasonry was conceived to gather the wealthy and powerful in a conspiracy to increase their wealth and power, and increase the number of people Satan harmed, enslaved and subjugated in his War Against God.

Today, top tier Freemasonry member nations (US, UK) use Freemasonry in lower tier nations, such as Mexico, to keep the living standard far, far below reason and potential. *This* preserves the rank system, and assures disgruntled Americans that things could always be worse.

Sometimes it’s good to get fresh eyes on a problem. So, Although I’m an immigrant here in Mexico, I’ll share how Freemasonry, here in Mexico, is used by wealthy Freemason, with links to the US, to suppress Mexico.

First, I should explain that almost everything I’m about to say, is said through an eye interested in economic development –expanding work and the economy.

Second, Western agents, who have no idea how independent economies are

developed, will forever insist that economies that are not tied to the dollar will collapse. False. Nobody should be holding dollars right now.

Third, here in Hermosillo, Mexico, there's a Freemasonry lodge. I'm confident Freemasons and US tied interests are responsible for the problems I'll soon describe, but there is no smoking-gun evidence for or against this claim.

Trash Part One. I've been in Mexico for almost two years. One of the first things I noticed when I arrived in Mexico was the trash problem. Because of the lack of trash cans that are regularly collected, people often shove trash in the many vacant buildings, where it is never collected. There is a 300 pound pile of trash down the street from me that has been there for over a year. A few months after I arrived, I started to observe on the TV that seemingly everyday, certainly every week, a different large recycling plant somewhere in Mexico would catch fire. This went on for about a year. I'd guess this happened over 100 times. Once or twice they even showed film of people setting these fires at night.

Trash Part Two. This year there were terrible rains and floods seemingly everywhere in Mexico. The rains caused terrible damage and loss of life. My payers and sympathies to anyone impacted by the rain and floods. That said, the floods washed uncountable tons of trash into the streets and fields of Mexico, further revealing the terrible trash collection and recycling problem in Mexico.

Roads Many of the streets, roads and sidewalks in Mexico are in terrible condition, with giant holes. During the recent severe rains, giant sink holes opened under many streets. The high number of giant holes suggests some shortcuts may have been taken in building the roads.

IN SUM. These problems exist because Freemasonry elites conspired to create the problems –primarily to make life in the US and Western Europe look advanced by comparison; secondarily, to glorify Westerners, by tacitly suggesting the high number of **non**-Whites in Mexico somehow caused the problem.

The Solutions... The *Trash Parts One and Two* sections indicate there's a poorly developed trash and recycling system in Mexico. The Roads section indicates Mexico has an underdeveloped infrastructure repair system. Both sets of problems make zero sense. Mexico is extremely resourceful, about the 12th largest economy in the world. Solving these problems is fairly simple, and represents many hundreds of thousands of good jobs for people around the nation.

The Next Problem: Food Uncertainty

If you walk down the snack or cereal aisles in stores like *Ley* most food brands are American. That may not be good for Mexico. What Mexican products are being replaced? If there is a conflict with the US will the food supply be disrupted?

THE DESTRUCTION DATE

The original date of God's *One Hour War*, of Revelation, Chapter 18 (September 23rd, 2024, in the Western hemisphere: September 24th, 2024, in the East) was *Rescheduled* to December 2025. The rescheduled Date involves *Nuestra Señora de Guadalupe*, and two unusual, rarely seen *badges*, affixed to the lower left corner of *Nuestra Señora*, which went hidden, unexplained and unexamined, for centuries, until I revealed them, in March 2025, in *Killing Guadalupe*. Revelation connects to *Nuestra Señora* because Revelation images fill the *Juan Diego badge*.

Guadalupe's story foreshadows God rescheduling His *hour of wrath*, as Guadalupe had to reschedule the miracle she promised Juan Diego, after he broke their appointment to care for his sick uncle.

In April 2025, I found the rescheduled *Publication Date*, which I mistook for the date of the One Hour War. Once I realized my error, here's how I found the correct *Rescheduled Destruction Date*... The original Publication Date (West), March 12th, 2024, was **195** days before the original Destruction Date (September 23, 2024). So I added 195 days to May 26th, and got **December 7th, 2025**¹ (or **10th Month, 18, 4723**, on the Yin calendar), and found verification of these dates in *Nuestra Señora de Guadalupe*. **195** refers to **Genesis 19:5**, where a group of men try to rape God's male angels. 195 is God's rebuke of the US/West, as going against nature, in creating *Head Start* to impair minority children's brains; in spreading hate, corruption, porn, and normalizing the abnormal –reflected in the West's exploding LGBTQ rates, and in stealing IP and falsely attributing the stolen works to talentless Westerners.

The following 6 pages reveal the Publication and Destruction Dates hidden in Juan Diego's badge and *Nuestra Señora de Guadalupe*.


RESCHEDULED PUBLICATION & ONE HOUR WAR DATES & TIMES

Publication Date

Hidden in Juan Diego's badge are two numbers which usher in the coded date of likely the most catastrophic Event in human history: the *One Hour War* of Revelation, Chapter 18. The numbers 5 and 1 are a *Publication Date* instruction –the date by which formal *notice* or *discussion* of the rescheduled Destruction Date, or the Publication Date, must have been published. A Publication Date was first discovered in my Revelation solutions in March 2024. The Juan Diego badge's rescheduled Publication Date is on the Chinese *Yin* calendar, expressed in letters and positions associated with the numbers **5** and **1**, which refer to **5th Month, 1** (the first day of *Fifth Month*), **4723**, in the Eastern hemisphere; which corresponds to May 27th, 2025, in the East, and May 26th, 2025, in the West –as the West is roughly a day behind the East for half of each day. Only the Publication Date is hidden in Juan Diego's badge –the Destruction Date is hidden in Nuestra Señora de Guadalupe's central image.

Here are the symbolic expressions of Publication Date **5/1** (or 1/5) in Juan Diego's badge (see/read *Killing Guadalupe* to see and learn more about the *badges*):

1. The **I** (Roman numeral 1) in *AMERICAE*, at the base of the central image frame, is askew; rather than pointing down to a 6 o'clock position, it points to 5 o'clock –which represents *5th Month* (*Yin*).
2. Juan Diego Cuauhtlatoatzin only shows 1 foot, and the five toes of that foot are in the 5 o'clock position, pointing at the *A*. Juan Diego's single visible foot represents the first day of the month, as does the letter *A*. The 5 o'clock position represents *5th Month* (*Yin*), so do the 5 toes on Juan Diego's foot.



3. The letters **A** and **E** at the end of the word *AMERICAE*, in the base, are slightly bold and offset. **A** (the 1st letter in the English alphabet) represents the 1st day of the month. **E** (the 5th letter in the English alphabet) represents 5th Month (Yin).




4. Rather than facing forward (6pm), the character in purple faces 5 o'clock (5th Month), and toward the letter **A** –the 1st of the month.


5. The nose of the raccoon image, and the forward arrow on its head, point to the **A** –the 1st of the month.



6. At the top of Juan Diego's badge, the face and eyes of the *Image Beast* face slightly off center, to the 5 o'clock position: 5th Month, Yin.



7. At the bottom of the badge, the square-jawed beast's head faces the 5 o'clock position (5th Month, Yin), and his head seems to tilt forward to 1 o'clock (the 1st of the month).




8. At the base of the tilma (above), the *original angel* faces 5 o'clock (5th Month), with his head tilted forward, to about 1 o'clock –the 1st of the month.



Above, the year of the event is expressed symbolically, at the bottom of Juan Diego's badge. Reading left to right, three 'M' ghosts, outlined in red, left, represent the 3rd millennium, which we are now in; the two wolves in the middle, birds in mouth, represent the first 20 years of the new millennium; thus, each wolf represents a decade. The five common ghosts, outlined in pink, right, represent the first 5 years of the third decade of this millennium. Together, these characters express **2025**, the Publication year –and year of the One Hour War.

To confirm the *Publication Date*, in the base of the *Elder* badge (below), the first two decades of the millennium are represented by 2 squid-like figures or M's, on the upper left side of the base decoration, circled below. [NOTE: the beginning of the 3rd millennium is expressed in the central field of the Elder badge, by the Elder's two hats -his crown and his saint hat- and the thin hood of his cape, similar to a *hoodie* (pictured to the right), representing two full millennia, and the beginning of a third millennium (the thin hood).] The 5th year of the third decade is expressed by 5 symbols/icons, which resemble groups of 3 lines, or M's or W's, right of the base ornament. Together, these symbols express the year **2025**.

The 5 year icons lead down to numbers 5 and 26 (see enlargement below), which represent May, 26th – 5/26, as the date is expressed in the US.



The Destruction Date



The Destruction Date -the day and hour of the One Hour War- is given, primarily, in the central image of Nuestra Señora de Guadalupe, and secondarily in the image of the original angel, which now only exists in the Juan Diego badge.

Nuestra, today, is very faded, damaged and mostly fake, but most 17th and 18th century copies get the details right: 22 stars on the left side of Guadalupe's mantle, 24 stars on the right; representing, Yin calendar year 4722, and Gregorian year 2024 –the original years of *Destruction*. The light blue interior of Guadalupe's mantle, turned out, symbolizes the date of the One Hour War has *changed*. The 4 images above, Nuestra as she appears today (left), and three 17th and 18th century copies, are to verify the following One Hour War dates, times and details.

New Event Year (Yin): The new Event year, on the Yin, is expressed by the 3 stars in the trail of Guadalupe's gown, circled in orange, above, lower left, held in the hand of the winged child (also the original angel). This represents Yin year 4723.

New Event Year (Gregorian): The original event year, Gregorian, was 2024. The X shape in the mantle hem, circled in white above, represents the number 24 (X is the 24th letter of the English alphabet). The single star enclosed in the X represents an added year: 25 – 2025.

New Event Month (Yin): The new month of the Event, on the Yin, is first represented by Guadalupe's **10** fingers, joined in prayer, slightly facing East (the side of her body with 22 stars on the mantle).

- This month is reinforced by the **X** in Guadalupe's mantle hem, circled in white, situated by the moon (word root of *month*). **X** is Roman numeral **10**. Thus, on the Yin calendar, the month is **10th Month**. But this **X** has an extra star (circled in green), to express an extra month –an 11th month, because 2025 (4723, yin) has a leap month in June/July (see page 8), thus 10th Month in 2025 is actually the 11th month.

New Event Month (Gregorian): The Event month is expressed by the **12** stars/prongs of Nuestra's original crown (stolen in 1888); reinforced by Revelation **12:1**, where Guadalupe represents Mother Nature, on the *Moon* (women's monthly cycle), in a 12-star crown: *Now a great sign appeared in the Heaven, a woman clothed with the Sun, with the Moon under her feet, and on her head a crown of 12 stars.*

Thus, the new Event month is the **12th** Gregorian month: **December**.

New Event Day (Yin): The new Event day is expressed by the 18 stars in the unbroken field of the upper left (viewer's) portion of Guadalupe's mantle, covering her shoulder, arm and hip (circled in yellow in the photos on the previous page).

Thus, the day of the month, on the Yin calendar, is the **18th**.

New Event Day (Gregorian): The new Event day, Gregorian, is expressed by Guadalupe's position, she is facing **7** o'clock (directly forward represents 6pm).

Thus, the day of the Event, on the Gregorian, will be the **7th** day of the month.

New Hour of Event (East): The One Hour War begins, in the East, when the East begins launching bombs, at 11pm. 11 is expressed by the 2 pinkies of Guadalupe's hands, held apart from her other fingers (right). 11 is also expressed in the hem of Guadalupe's collar (lower right).

The *launch hour* will end at midnight.

The close of the hour, 12am, is reinforced by black lace arrows under Guadalupe's hands, like clock hands, pointing up to midnight. Guadalupe's hands also point upward toward 11pm and midnight.



New Hour of Event (West): The East's bombs will impact the US from about 9am to 10am, West Coast time, or 12pm to 1pm, East Coast time. Guadalupe's 10 fingers, in prayer, may represent 10am, US West Coast time, when the One Hour War ends. [Other Western nations and allies may also be targeted during this hour.]

Time of Event *Color-Contrast Confirmation* (The Mystery of the Two-Tone Gown: Solved)



The original Destruction Date -the date of the One Hour War- was scheduled to occur on September 23rd, 2024, in the US and the rest of the West –but on September 24th, 2024 in the East. Similarly, the original Publication Date AND the *Rescheduled* Publication Date were all designated at times when the East was on one calendar date but the West was on another.

The date and time of the Rescheduled Destruction Date (or *Rescheduled One Hour War*) departs from the prior pattern, as the Event initiates when the East and West are both in the same date (December 7th, 2025, Gregorian; or 10th Month, 18, 4723, Yin). To confirm this departure, in the image of Nuestra Señora de Guadalupe, Guadalupe wears a gown that is conspicuously 2-tone, dark tone on the viewer's left, light tone on the viewer's right. This color contrast is made to reflect and confirm that it will be night time (dark) in the East (represented by the viewer's left of Guadalupe), and it will be daytime (light) in the West (represented by the viewer's right of Guadalupe). [Moments after the East launches their bombs, China will enter 10th Month, 19, 4723, or December 8th, 2025.]

Complete Destruction Date & Time:

One Hour War date/hour, East (Yin): 10th Month, 18, 4723, 11pm to 12am.

One Hour War date/hour, US/West (Greg): December 7th, 2025 (9a-10a).

Revelation's Hidden D-Date Confirmation Keys

Because Revelation shows us that God knows all things and events (perhaps an eternity before they occur)², I had a feeling God may have hidden 1 or 2 confirmation keys in Revelation –confirming that the *rescheduled* date of His One Hour War had always been His intended Destruction Date; but to prevent Satan and the US from trying to alter His prophecy, God put *false solution clues* in His Bible.³

Here are the *Destruction Date* confirmation keys, on the Yin/Chinese calendar.

#1. Destroy, Destroy! In Revelation 11:18, the word **destroy** is uttered **twice** by the *24 Elders*. These are the only instances of any derivation of the word *destroy*. Here, the chapter and verse (11:18) represent the Destruction Date, on the Yin: 10th Month, 18 (the 18th day). This should cause you to wonder how the 11th verse can represent the 10th month? In 2025 (or 4723, Yin), the Yin lunar calendar had a *leap month* in June and/or July (*leap months* are when an additional month is added to the Yin calendar to correct incongruities; this occurs every 3 years).⁴ **Thus, 6th Month occurred TWICE, in consecutive months, in 2025/4723; thus, although 10th Month was called 10th Month, in 2025/4723, in reality it was the 11th month.** [The fact that the 24 Elders twice utter “destroy” is very significant because, as you will learn later in these solutions, the 24 Elders represent me.]

- In March 2024, I began to refer to the day God destroys the United States as *the Day of Destruction*. I soon also began to call this day *the Destruction Day*, or *the Destruction Date*, and have continued to do so to this date.

#2. Year of Destruction. Revelation's most chilling, out-of-character verse is 2:23, as Jesus says: **“And I will KILL HER CHILDREN with death. And all of the Churches shall know that I and He who searches the minds and hearts...”** In September 2023, I became certain “23” referred to the year God (and Jesus) Destroyed the US. Since I was only familiar with the Gregorian calendar, I thought the year of Destruction was **2023**. Thus, November 17th, 2023, I left the US and moved to Mexico. But “23” did not refer to the 23rd year of the Gregorian calendar; “23” referred to **4723**, current year of the Yin, equivalent to 2025, Gregorian.

With these *keys* God uses a lighter brush, so as not to undermine the slightly more conspicuous *false Destruction Day* clues. Revelation contains additional *arrangements* to reinforce these *keys*; but to conserve time, I will not explore these secondary arrangements.

² Although, in *The Wagers* we learned God is free to temporarily reduce His knowledge of future events, if He wishes.

³ September 2024 I added a *Prophecies Against* section to *Revelation 2*, explaining that Daniel had to use code and omit the truth, in *Daniel 4:20-23*, to prevent the West from erasing those verses from the Bible, in their Dead Seas Scrolls hoax. Similarly, in this case, God included extremely difficult *false Destruction Date clues*, to mislead His enemies. But God knew that at the right time, I'd find the true D-Date, and His confirmation key(s), and explain why all of this was necessary.

⁴ The first *6th Month* ran from June 25th to July 24th, the second ran from July 25th to August 22nd. Some sources say the first month is *leap month*, others sources say the second month (the repeating month) is leap month.
