

# In Response to a Petition from **THE DEMON KING**

Jan 18<sup>th</sup>, 2026 (Julian); Jan 31<sup>th</sup>, 2026 (Greg);  
Updated Jan 18<sup>th</sup>, 2026 (J); Jan 31<sup>th</sup>, 2026 (g).

Two days ago (Jan 28<sup>th</sup>, 2026, Greg; or Jan 15<sup>th</sup>, 2026, Julian), I posted an article or message called "*In Response to a Question from Satan*" on my Website. The piece was intended for anyone to read, but it was directed to Satan, who was running a ton of AI news stories, on N Foro and ADN40, that featured hidden capital R's; more specifically, Satan was hiding *Revelation R's* in news images (to learn more about *Revelation R's* read "Steve Top-Secret Notebook"; *STSN*). In the article/message, I explained that I was aware that Satan was using the Revelation R's and the number 34 to bring an issue or question to my attention .

However, at the end of the piece I said that I would not address what I believed Satan's question was unless he met my demands. I posted 5 demands (1 or 2 of which are/were flexible, because they may be problematic). So interested readers can follow along, before I address Satan more directly, in the blue box on the next page, I've reprinted the final page of *In Response to a Question from Satan*,

where I listed my demands before I would address Satan's concern:

*I am very aware of the question or matter Satan wants me to address. I also understand what Satan is signaling with the letter R. And it's an interesting point.*

*However, I won't reveal what Satan's issue/question is until Satan takes certain actions.*

*Thanks to Satan's sabotage, I have been poor for a long time. I recently updated my terms to have God provide me with money, etc. I am confident He will provide. BUT, Satan is the one who stole my ideas, and helped unlawfully distributed my ideas, and the one who did all he could to prevent me from being paid properly at work. And these are far from the worst of Satan's crimes against me.*

*So, given that God has a low opinion of money, but I need money to survive, why should God be the Entity to give me money, when Satan is the one who stole it?*

*Thus, if Satan wants me to address his concern, he must immediately fulfill these demands:*

- 1. Satan needs to fill up my Spin (by OXXO) cash card, AND MAKE SURE IT AUTOMATICALLY FULLY REPLENISHES, TO ITS MAX DEPOSIT TOTAL, after every use –for the remainder of my life. If I move to another country, Satan must figure out how to get me a new automatically replenishing cash card, immediately.*
- 2. Satan must immediately reactivate my Bank of America ATM card, and put a LOT of money in my old Bank of America checking account. He also needs to insert my four-number PIN in the N-Foro news text crawl, because I forgot the PIN of my B of A card. And, since that card is likely to be useless after February 1<sup>st</sup>, 2026 (Greg), Satan needs to make sure that card has an unlimited daily ATM withdrawal limit.*
- 3. Satan must never again use the internet or any other means (phone, satellite, etc) to ask anyone to take ANY action against me (disturbing my sleep, turning off the hot water...). If Satan fails to do this immediately, I'll address it in my Terms –with an added punishment.*
- 4. Satan must stop loitering 80 feet from my house at night, making the dogs bark. This does not mean it is OK to loiter 90 feet away. Satan should not come within 400 feet of my house from 10 PM to noon. After noon, he can stand at the 80 foot perimeter line, established in my Terms (however God manages that). If Satan fails to do this, I'll add it to my Terms, with punishment.*
- 5. Satan should/must immediately mail me a replenishing ATM bank card, from a reputable Mexican bank, under my name: Steve(n) Kenyatta Briggs.*

*Satan also needs to understand that he may not like my view of his issue. His money will not move my opinion. That's why I'm doing this openly. Satan owes me for a lifetime of theft. Hundreds (likely thousands) of US and Western movies, songs, TV shows, and massive science projects were derived from my works and ideas, usually stolen with Satan's assistance.*

*It's likely that Satan will not meet my demands. In that case, I will not address the "R" issues, etc. Although, at some point, when it's convenient, I may explain to readers what Satan was talking about, and what 3 and 4 mean.*

I posted that response at 5:00 AM (Jan 28<sup>th</sup>, 2026, Gregorian). By that afternoon, Satan had already moved on things. He posted my old PIN number of the N-Foro news text crawl. He posted the PIN in a crawl about a certain nation achieving a certain two-digit percentage in a certain year. The two-digit percentage and the final two digits in the year were my lost PIN numbers. I assumed that Satan gave me some money, so I went online and tried to pay my monthly website renewal fees, but my card didn't work. I was busy working on a writing project for God and Jesus, so I decided to revisit the *money-from-Satan* matter later.

Apparently, Satan wanted me to address his concern immediately, because he sent a bunch of loud people to rent rooms around my room in my hotel, and directed various people in the hotel to make a ton of noise during my unconventional sleeping hours; noisier than ever. Satan is able to arrange things like this by taking over people's email, or phone text accounts, etc, to offer others money to perform certain services. Satan, the new king of the internet, then sends an online payment, and the deeds are done. (You will have to go through my January posts –especially see *The United States is Dead*– to understand how Satan came to reside on Earth AND the internet and all connected TV and phone services.) Through this *hired noise*, Satan was expressing his anger that he was not getting his way, immediately.

The next day, January 29<sup>th</sup>, I had a pretty huge project to finish for God (I wrote, outlined and published "The Deception Day"), so I wasn't going to be able to work on a response to Satan's concern. But I turned on my TV, in the afternoon, to see what Satan was doing with the news. Surprisingly, Satan was using his AI to discretely flash my pin number. Clearly, he didn't think I got his PIN message the day before. Since Satan was flashing my PIN so stridently, I decided to walk to the bank and see if he sent me some money. The PIN worked fine, but there was nothing in the account, and nothing on my other card.

After publishing *The Deception Day*, a few minutes before midnight, shortly after January 30<sup>th</sup>, 2026 (Greg), I started working on this reply. I stopped working and went to sleep around 6:30 AM. When I got up, in the early afternoon of January 30<sup>th</sup> (Greg), I went to the bank to see if Satan paid me any money. Nothing.

At that point, I didn't necessarily want to address Satan's concern. But maybe what I demanded of Satan was beyond his ability. If so, the situation would be analogous to many modern justice systems, where the poor are excluded from proper justice, because they cannot afford the legal fees and lawyers. Plus, even though I made my demands publicly, it would be best and most ethical to address the question without any conditions attached.

And so, I am answering Satan's concerns, unconditionally.

So here is what I believe Satan is saying by flashing the Revelation R and signaling 34:

### **The Revelation R (Part 1)**

God sent Satan to Earth for an amazing reason, revealed later. Once here, at some point, Satan and God began a series of many Wagers, related to Revelation – but these wagers started about 2000 years before Revelation was written, around 2222 BC, and continued until the end of 2025 and the beginning of 2026. God likely gave Satan many powers before the wagers began, and allowed Satan to earn many more fantastic powers for defeating God in various Wagers (although God likely *let* Satan win most of the Wagers, as part of a long-term strategy to keep Satan over-confident). In my books *The Wagers* and STSN, I explain that in the final Wager, “The Beast Wager,” which ran from 1888 to 2025-26, Satan’s objective was to prevent God’s designated solver (me) from sufficiently solving God’s Revelation(s), including the date and time of the One Hour War (OHW). The evidence suggests that Satan also believed he could keep God’s Eastern forces from fulfilling God’s Will and defeating the US (and their allies), in the OHW, at the time specified in God’s secret sacred artifacts (to be revealed by God’s solver). [NOTE: In past publications, I said Satan’s objective was to stop the OHW from happening; however, since Satan’s goal is to harm God (and having to kill millions of people, to save the world, certainly harmed God), it is equally likely that Satan only hoped to make the War happen at a different time, which would give Satan the victory and satisfaction of nullifying God’s prophecy and still emotionally harming God.] Because the terms of God’s Wager with Satan were not published, at least not on Earth, there is no way to know all the Wager points and sub-points which may have been in play.

The *Guadalupean-Revelation* portion of the Wagers began in late 1531, and ran to 2025-26. During this period, Satan began to break the Wager rules more than ever. Because God wanted the Wagers to continue, to fulfill a much higher objective, God opted to inflict various punishments on Satan for his various infractions, but opted to allow the Wagers to continue. Just **before** the final major Wager (the Beast Wager) began, Satan committed two huge transgressions, at least one of which I believe God expressly told Satan not to commit. I believe Satan was directed not to remove/steal Nuestra Señora de Guadalupe’s crown. But in early 1888, Satan helped orchestrate the theft of Nuestra’s crown. For this crime (and likely for opening Everard’s Baths, the world first gay bathhouse, for men to engage in public homosexual sex), God reversed time and showed Satan a young boy. Satan construed God’s interest in the boy as indicating the boy was to one day become

Satan's *Beast*. Thus, Satan, obsessed about the boy, and eventually made the boy his Beast. However, the boy was not the originally intended Beast. The originally intended Beast was John D Rockefeller III. But, to punish Satan for desecrating Nuestra Señora (the representational mother of Jesus, and the personification representation of God's daughter, Natas), God redirected Satan's focus, and changed the Beast.

When Satan and other readers reflect on the previous paragraph, they must remember TWO THINGS: (1) God's intervention occurred BEFORE the wager began; (2) Satan only came to learn of the original beast through my Revelation solutions.

Through Satan's *Revelation R's*, I believe one of Satan's arguments is that he caused God's original prophecy to change: the Beast was slated to be JD Rockefeller III, but Satan caused the Beast to become John W Gardner.

That argument doesn't stand up. **God changed His own prophecy** before the Wagers resumed. The only role Satan played was cheating, laterally. But Satan also misses the bigger picture and revelation. Satan was supposed to stop me from solving Revelation. He failed. God's Revelation was much bigger than the Book of Revelation. Thus, to complete the solutions, I had to follow God, outside of the Book, to Nuestra Señora de Guadalupe, then to the Shroud of Turin, where I found the time and date of the One Hour War. **God changed His own prophecy** to make the story even more incredible, and to make solving God's mysteries even harder. But I found the Beast, John W Gardner, and I found the originally intended Beast. More importantly, God likely changed the Beast (revealed in Revelation, Chapter 11) to foreshadow the awe and terror of Chapter 18, when we learn God's temper sometimes flares, and He and acts in wrath –sometimes to such an extent that He may even alter His own prophecy. This element acts as a warning to nations that if they behave badly, He or Jesus may act in wrath, and their people will suffer.

I'll return to this *Revelation R* matter after I touch on 34.

### **34 (3-4)**

The reason Satan wants me to weigh in on this matter is because Satan took some extraordinarily malicious actions against me –including trying to kill me at least twice. Because God knew Satan would take extreme action against me, God allowed me to take action against Satan in my retroactive Terms (STSN, chapter 17). [The fact that my *Terms* are retroactive serves as a message to just nations to impose just action against all lawbreakers. The US passed a no *ex-post facto* law, which effectively encouraged and allowed the elite to commit terrible new types of crimes; then, *if* caught, the elite used the no ex post facto clause to shield themselves from prosecution.] My Terms, which Jesus or God can modify as needed to uphold

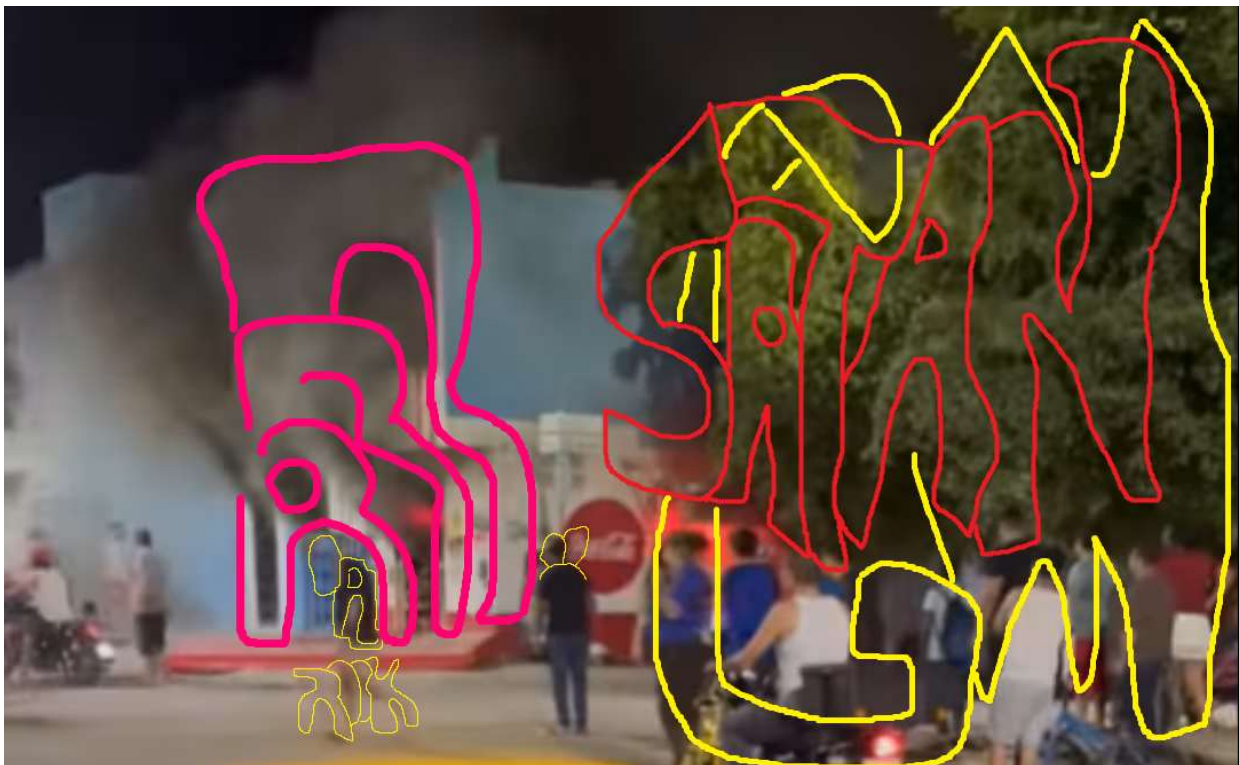
justice, allow me to impose punishment on Satan for about half of every 24 hours, for the next 1000 years. **3 to 4** hour of every 12 hours governed by my Terms impose very firm consequences –but consequences that flow from the crimes Satan and his beasts (John Gardner and John C Malone) inflicted on the world. This severe 3 to 4 hour punishment period is what Satan is referring to when he mentions “34”.

I’m certain Satan views my 3 to 4 hours as excessively punitive (In fact, Satan probably believes my 3 to 4 hours of punishment are *cruel*; but my punishments are based on -and mirror- Satan’s actions).

So Satan is asking me to reconsider my 3 to 4 hours of punishment.

### **The Revelation R (Part 2)**

On January 26<sup>th</sup>, 2026 (Gregorian), on pages 18 and 19 of a piece called *The Last A.I. Fake Images*, I included the AI image outlining below, with three Revelation R’s on the left, and Satan’s name and Gardner and Malone’s initials on the right; and I explained that Satan was saying that he believes the three Rockefeller brothers, were equally -perhaps more- responsible for the terrible crimes Satan and his beast committed against the world.



Shortly after finding this image statement, I went back through a few of my prior mid-to-late January 2026 (Greg) AI articles/reports, and discovered that Satan also hid Revelation R’s in many of his prior AI images.





In *"In Response to a Question from Satan,"* I included the images above, and explained, on page 9, Satan was using the images to say he views Gardner and the Rockefeller brothers as more responsible for crimes they (including Satan) committed.



Specifically, in the image above, in position #1, above, Satan is saying Gardner orchestrated the assassinations of a President and his brother, and civil rights leaders, and many murders of Blacks and open-minded White women –but Satan’s powers facilitated all of these crimes. In position #2, Satan indicates the Rockefellers were responsible for the US’s secret state efforts to impair the minds of Blacks –but it was Satan who led them to the science and techniques to execute a plan. In position #3, Satan seems to say his primary crime was tempting the world to commit various sins. In position #4, Satan says Malone owned the cable boxes that spread Image Crimes –although Malone did not conceive of Image Crimes, or cable technology, which reduces Malone’s responsibility. (On the right side of the image, Satan ranks my family members who acted to harm me.)

Satan's points about Gardner and the Rockefellers are weak.

Satan chose Gardner. Satan's God-given ability to see the future, and see various future possibilities, and to inform Gardner how and when various murders would be successful, gave Gardner his power. Without Satan, Gardner was a non-entity. As for the Rockefellers... Satan wanted a Beast with a great deal of money, who was willing to spend that money to commit evil deeds –and likely make more money in return. Thus, Satan pursued the Rockefeller family –the richest family in the world. Satan was able to look into the future and see what actions would lead to the Rockefellers agreeing to finance Satan and Gardner's schemes –until such point as Gardner was wealthy enough to act with or without the Rockefellers. Satan is probably correct that it was the Rockefellers' idea to do terrible things to non-White children, but it was Satan who sought the Rockefeller's out, and told them how to make their dormant schemes work.<sup>1</sup> In the end, to whatever extent the Rockefeller are responsible for various crimes, God and Jesus will punish them accordingly.<sup>2</sup>

### **Satan's Best Argument**

In my view, Satan failed to present his best argument. So I'll do it for him.

If I were an attorney, and appointed to defend Satan, I would argue that God chose my client to fulfill God's Will. And God did not tell my client why he was giving Satan various powers and engaging in Wagers with my client, who, by the way, is clearly insane (*this may or may not be true, but, as an attorney, I would make that case*). I'd argue that God knew Satan was obsessive, and would remain focused on his objective: leading as many people to damnation as possible, to inflict emotional harm on God. I'd argue, God exploited my client's delusions and obsessive nature in humanities' interests. I would then submit chapter 14 of *Steve's Top-Secret Notebook*, specifically page 371, which reveals God used Satan to greatly increase human longevity (life spans), and greatly increase Earth's human population, and **God used Satan to shorten a time of terrible human suffering by 528 years (!!!)**, measurably improving the lives of **20-BILLION** people, in the process. I'd then argue that since God relied on Satan's bad intentions to deliver a tremendous blessing to humanity, my client should be spared from any unusual punishment.

That's what I would argue if I were Satan's attorney.

But, in fact, I'm the person Satan most attacked in his 6,000+ years on Earth.

<sup>1</sup> Satan seems to miss the absurdity and hypocrisy that he showed the world no decency or mercy for centuries, committing over 770,000 Mark Crimes against me, campaigning to damn all of my family, and killing my ancestors and branches of my family, but as time approaches for *Satan* to pay for his crimes, he suddenly cries "Injustice," and appeals to the decency in me.

<sup>2</sup> To Satan's credit, from what I understand, before the advent of Gardner, the Rockefellers and Malone, crimes against children, around the world, were much less common and less severe. This suggests that there were certain crimes, like sexual crimes against young children, that Satan did not seem to promote. Which suggests Satan may possess the tiniest degree of decency.



God and Jesus have full knowledge of Satan's actions going back to his birth. My general position is that Jesus (whom I believe was not a direct participant any of the Wagers) should review Satan's life, and assess the value he brought to God and to humanity, against any unreasonable malice Satan may have acted with, and any and all other variables, then impose any consequences He views as appropriate.

HOWEVER, Satan also took relentless action against me, for about 59 years –those actions continue to this day. In STSN, I showed Satan attacks on my family, especially my son, and attacks my ancestors, and he may have been responsible for killing lateral branches of my family tree –like Randall and Harry Yayayar. These crimes, related to the Wagers, were committed because I was/am God's predicted solver (and possibly/probably because, in the backward *time walks* described in *The Wagers*, Satan saw the very firm consequences I planned for him in my *Terms* –see chapter 17 of STSN). Because Satan took such harmful action against me and my family, I am entitled to impose firm consequences on Satan.

### **What I think Is Right and Reasonable**

Satan wants his 3-4 hours of daily punishment reduced –greatly reduced.

Satan stole my life works (movie scripts and ideas, songs, music, scientific ideas, social ideas, even my humorous views and conversation) and he attributed those works, ideas, etc, to other people. I am willing to greatly reduce (possibly eliminate) the 3-4 hours of daily punishment imposed on Satan by my Terms, **IF** Satan publishes an admission/confession, of some reasonable form, of all of the various movie, TV shows, songs, books, science projects –even pop cultural figures, that he and the beasts and their associates created which were/are derived from my works, ideas, or me, personally. And, since Satan and the US/West tried to erase evidence of my existence, in any such admission, Satan must refer to me by name.<sup>3</sup> During the Guadalupean Wagers, in many of Satan's documentation obligations to God, Satan wrote deceitful confessions, some of which even mocked God –the source of all of Satan's power. I lack God's forgiving nature, and I will not accept an inaccurate, rude or mocking confession.

If Satan is incapable of meeting this minimal and reasonable expectation, I will keep my Terms as they are. For now, I *will* keep my Terms as they are. If I learn Satan has published an admission/confession, that I view as adequate, I will modify my Terms, EITHER as contemplated in the blue-green paragraph at the top of page 9, OR remove Satan from my Terms' 3 to 4 hour punishment requirement.
