





Confirmation messages, above and below. The image below was created to confirm God put Revelation confirmation images in both badges.








Above: The tilma Juan Diego holds in the center of Juan Diego's Badge.  
Below: the mantle of the Juan Diego Badge.





# Between the Lines

### The Mystery of My Fake Friends, And the Bodies in the Basement

In mid 1988, at 23, I moved into an apartment in Southern California with my younger sister, Kenya, who had recently turned 22. Kenya came out as lesbian in 1990 or 1991, but in 1988 she was still undeclared. While living with Kenya, around September 1988, a gay guy at work suggested we go out as “friends” sometime –although we were co-workers, not friends. I politely declined. Later, I told Kenya the story. She called me a *homophobe*, and urged me to go hang out with the guy, just once. I argued, but eventually conceded. I went to a movie with the guy, and hated every minute of the night. Sure enough, at the end of the night, he tried to get me to go up to his apartment. I refused, sharply, and the guy slammed the passenger door of my car, like a lunatic. Later, I told Kenya I respect gay people’s right to be, and I believe they have and deserve all human rights, but I would never have a gay friend; mostly because I never want to hear about their romantic lives or worry they might develop an interest in me. I would go on to make that declaration many more times.


By 1988, Gardner and Satan had been staging dirty tricks and skits for over 20 years. The fact that I was now declaring I would never have a gay friend was an irresistible challenge. Could Gardner create conditions where I had a new group of friends who were all secretly homosexuals –known to each other but not to me?

In 1992 I was sort of forced to leave the Los Angeles area, because suddenly every agency working with at-risk and emotionally disturbed children required a college credential (this requirement only lasted for about a year –long enough to pressure me to leave Los Angeles). The reason Gardner and his Hollywood brethren wanted me out of the LA area was tied to the fact that the band *Rage Against the Machine* stole the music to one of my songs for their song *Know Your Enemy*. At the time, I was active in the LA music scene, which created a reasonable possibility that I would discover the infringement early. But, if I were out of the area -back in Northern California- I might not discover the theft for a year or more.

After moving around Northern California for a year, in late 1993, I moved back to Berkeley, where Gardner and Satan started their attacks on me a quarter of a century earlier.

For their new skits, Gardner used Pay Rose to get things started. Because my friends, historically, tended to be few in number and pretty masculine, Gardner's plan was to introduce me to some of Pay's masculine LGBTQ friends and see if I connected with any of them. I liked Hugh because he was gritty and had a good sense of humor. Max seemed straight, but I only associated with him because we were in a band together, and he was a very competent musician. Once Pay saw that I really seemed to like Hugh, he informed Gardner (possibly via David Wilson or Lowell Bergman). To that point in my life, I usually only had maybe 2 or 3 close friends at a time, so being able to drop by and see Hugh, or maybe Pay, a couple times a week was perfect.<sup>1</sup>

Pay soon introduced me to his *ex-girlfriend*, who now lived on the East Coast or something, and who, retrospectively, was almost certainly a fake ex-girlfriend. But Gardner correctly calculated that seeing Pay with a woman he identified as his ex-girlfriend would convince me he was straight.

In reality, Hugh was a bi-sexual who was not good with the ladies. But Gardner and Satan resolved to couple Hugh with the most beautiful young White woman they could find: Emily. Gardner likely insisted on pretending Hugh was dating Emily, hoping this would get me to “worship the beast”, and overly admire Hugh –something I hadn’t done since I was 14 years old and overly admired the rock band *Kiss*. However, seeing Hugh with a very beautiful “girlfriend”, on and off, for 6 months or so, caused me to believe he was a ladies’ man. After Emily and Hugh *broke up*, Gardner tried to bolsters Hugh’s image as a ladies man by having three girls (Palmy, Jimena and Amy) at Hugh’s house, when I dropped by after band practice, for 6 months or a year. But the girls, who just sat around the livingroom, while Hugh and I talked, didn’t change my already good opinion about Hugh.

<sup>1</sup> My old friend Rick was probably, technically, still my best friend, But from the time we were 23 (1988) to 35 (2000), our lives were moving fast in different direction. I was involved in music, then being a father; Rick was usually getting in trouble with the law. Eventually he settled down.

Thus, from the beginning of 1994 to mid 1996, the core male friends in my life were Hugh and Pay, and my band mates, Max and Marcus Brown. Although I thought we were all straight, in fact, only Marcus and I were straight. Marcus was also Black.

Gardner and Satan spared no expense for the joy of being able to giggle in their lair every time I told Hugh or Pay that I would never have a gay friend.

That's the solution to the mystery of my fake friends.

As for the reason Hugh was paid to kill four people from 1997 to 2000....

Satan hated me because God wagered I would solve His Revelation –no matter what Satan did, short of killing me.

But *Gardner* hated me because I was half Black –and because my older sister and I had extremely high IQs. This indicated racial mixing led to more intelligent children; a terrifying thought for Gardner. Gardner's hatred of me was so great that in November 1968, in the days just before he and Satan were finally free to commit unrestricted Mark Crimes against me, he ordered Dennis Wilson to try to kill me, in violation of the Wager terms, by poisoning me with strychnine and atropine. When the murder attempt failed, Wilson, on parole for a serious drug felony, was ordered to kill two innocent people –the first two Zodiac murders. A few years later, Dennis was ordered to kill two more innocent people, in the Santa Rosa hitchhiker murders, between 1972 and 1974. These four murders symbolized Gardner's war against the racially mixed, "unclean" boy, with an unusual connection to the number 4, who was predicted by God to solve His Revelation. To emphasize their war against me, Gardner also paid Dennis to bury some of Randall Yayayar's remains of on my family' property. Randall was murdered because he was a distant relative of mine.

Against Satan and Gardner's symbolic war declaration, I was fortunate to have been born healthy and strong. This meant I would likely have children and multiple. But Satan and Gardner resolved to prevent that, by paying Marina and David Wilson, and Pay Rose and Chris Baridieaux to interfere with my dating life.

In 1996, having a child was not an immediate goal. That seemed like something to do a bit closer to 40. Nonetheless, in October 1996, I became a father.

Gardner and Satan were not happy. A few months later, Gardner resolved to pay Hugh, whom I consider a very good friend, to murder four *niggers* over a period of four calendar years –a punishment inflicted upon my race because I had multiplied. To emphasize this new chapter in their war against me, Satan and Gardner resolved to make sure Hugh's first victim shared my true family name: Yayayar. So Harry Yayayar was murdered by Hugh Schreiber in 1997.

# TERMS



As you observed in the previous chapters, God uses the Elder Badge to verify all important matters, and uses two or more images for verification. Above, the word “Terms” (with a giant capital *T*), other than God and Jesus’ signatures, may be the largest word found in the Elder Badge. Around the expression pictured above, God put two or three expressions of His primary identity number, 7, and at least two likenesses of Satan’s triangular head, adjacent to a 7. As the Elder Badge addresses matters related to me, the adjacent expressions of 7 (representing God –*Seven Spirits of God*, etc), and the adjacent representations of Satan, are representational confirmations that I, and my *Terms*, are connected to God’s Wagers with Satan.



The word "Terms" is also found in the Shroud of Turin, above.

## Terms

These are the participation agreement Terms of **Steven Kenyatta Briggs** (whose original and true family name is Yayayar; other names I am known by are included in the *Signature* section of these Terms), related to my involvement/participation in what appears to have been the final *Revelation Wager*, between God and Satan, which began on Christmas Day, **of the Julian calendar**, December 25<sup>th</sup>, 1888 (Julian), and ended on the final second of December 25<sup>th</sup>, 2025 (Julian); which on the Gregorian calendar was January 6<sup>th</sup>, 1889 to January 7<sup>th</sup>, 2026. These Terms can be referred to as my *Wager Terms*, although at no point, ever, have I wagered with God (or Satan or his beasts, etc).

- Note #1: I worked for God for over two years, selling my car and many possessions to fulfill my duties, before I realized He expected me to write “Terms” for my service. When I started working for God, I never thought about asking for some “reward” for the honor of being chosen to help God. But, bit by bit, my financial circumstances have declined. So, currently, I will take advantage of this chance to receive various payments, gifts or favors –for services I would provide God freely.
- Note #2: In the early versions of these Terms (published November 22<sup>nd</sup>, 2025 to January 16<sup>th</sup>, 2026, Gregorian), in great respect for God, I avoided using words like “must” (words which seem disrespectful, foolish and dangerous), in favor of words like “should”. But recently, I’ve surmised that God *wants* me to use more accurate language in these Terms, as He is using these terms for many purposes, including ***to instruct mankind to use clear language in their contracts***. Thus, I will use terms like “will” and “must”, herein.

These are the retroactive Terms of my participation in a Wager between God and Satan, in which God predicted I would accomplish certain things, and Satan requested permission to harm me and prevent me from accomplishing those things, and God granted Satan’s request. Although God may have informed Satan that I would be allowed to enter my Terms later, retroactively, it is also possible (even likely) that Satan was unaware, and God unilaterally provided for these Terms, based on the laws of reason and fairness. In the *Book of Job*, we see God and Satan make private 2-party Wagers (agreements), which impact Job. Thus, I assume Satan initiated a similar 2-party agreement with God, involving me. Thus, these Terms are made with God, but unconditionally impact Satan and all of his *beasts* and subordinate actors, as described.

Although I believe Jesus will help His Father execute these Terms, in the end, God is the party who is responsible for making sure all aspects of these Terms are fulfilled.

I have taken effort to write these Terms clearly and accurately. If any aspect is not clear, that aspect, and all others, must be interpreted to my favor and as I intended, and fulfilled to MY satisfaction and expectation. God knows my mind and intentions.

Should Satan or God prefer or require that Satan, or any subordinate parties, be identified as parties of these Terms, they and all other preferred or necessary parties are hereby made parties of these Terms –although much of or all of their terms will be nullified by portions of these Terms, particularly by items #5 and #8.

Some of the services I provided to and for God, Jesus (and Natas) were/are not related to Satan. Some of the following Terms will reflect this.

All passages of these Terms, from the opening title, to the final word of the closing signature, and every bullet point in between, are enforceable aspects of these Terms. **These terms must only be signed once.**

- **These Terms must not directly negatively impact anyone who is innocent.**

As explained previously in *Steve’s Top-Secret Notebook (STSN)*, to accelerate human evolution, and reduce the duration of one or more periods of massive human suffering, God entered into a series of Wagers with Satan, related to His *Book of Revelation*. The Wagers pertained to God accurately predicting who would solve (or *sufficiently solve*) his *Book of Revelation*. God predicted this somewhere between 1,900 and 4,200 years in advance. I am the person God predicted would sufficiently solve His Revelation.

I was primarily an unwitting participant of the final Revelation Wager, which might properly be called ***The Beast Wager*** (because the Wager gave Satan two human *beast* minions, in succession). Most of the details of the final Wager and the prior Wagers are not known to me. However, I do know:

1. Satan and his minions and/or their subordinate actors were allowed to do harm to me (although I believe acts of violence were not allowed), but they were NOT allowed to kill me, or to *try* to kill me.

From what I've pieced together, there were at least three major pieces to the original Wager, which are (roughly):

- a. Satan bet God that He could not write a book of coded prophecy and revelation AND predict who would solve His Revelation, 1900+ years in advance.
- b. As the Wager allowed Satan to try to harm me, Satan must have had a Wager provision that required God to identify His solver, to allow Satan to harm me, to try to prevent me from solving God's *Revelation*.
- c. Great attention appears to have been paid to the date of the One Hour War (the Destruction Date), as witnessed in *The Zodiac Killer's Identity Revealed*.


After the *Revelation* was finally written and published, Satan appears to have made new Wagers with God, concerning Revelation's various mysteries and solutions.

During the Wagers, God gave Satan the ability to see all or most significant human event up to 274 years in the future, perhaps more. God also allowed Satan to see me, most of my life, and some portion of my Revelation solutions (published online) over 200 years before my solutions were written, and over 140 years before I was born (see *The Wagers*, Wagers #4, #6, #7). Because God allowed Satan to watch most of my life **in reverse** (Wagers #4, #6, #7), Satan was able to follow my ancestors back to between 1777 and 1820. Thus, during this period, we see slave selling and "breeding" in the U.S. explode. Once Satan saw my paternal ancestors were Black, and their true last names were *Yayayar*, Satan inflicted more punishment on Blacks, and killed many of my ancestors. Thus, in my Notebook, we see Satan's minions kill Randall Yayayar, Para Yayayar (an infant), Pamela Rossford (mother of Para, and who loved Randall), Harry Yayayar and Erica Corran (who loved Harry). These attacks represent attacks on my family and race. Thus, my direct involvement in the Wagers dates back to around 1777 (the year God affixed His first set of badges on *Nuestra Señora de Guadalupe*).

At least one of God and Satan's new Wagers, entered into between 1777 and 2024 (most likely after 1888), focused on Mark Crime #18.

Although God and Satan may have had provisions to end the Wager(s) if one party cheated, I had no such option. During the final Wager, Satan and/or his Beast (John W Gardner) tried to kill me, in 1968 and 1993. I believe Satan's and his second beast, John C Malone, also tried to kill me once or twice.

## The Terms

Based on the preceding, and what is fair, reasonable and just, my Wager Terms, which are non-negotiable (except in the interests of justice), follow:

- All of the following items must be implemented immediately, ASAP, or as/when stated.
  - It is only necessary to publish these Terms in one language.
1. My Wager Terms supersede all other Wager terms entered into by God, Satan and/or either of Satan's beasts (John Gardner and John C Malone), and/or any Terms entered by any other unknown Wager participants.
  2. These Terms are "adjustable", and all aspects, including Satan's punishment (items #11 to #21), can be altered in perpetuity, as I see fit –without negotiation. Any changes will/must be accepted, implemented and enforced to my satisfaction, immediately. The concept of *adjustable* contracts comes from contracts introduced in the US, which made the terms of certain home loans (which the US primarily offered Blacks and minorities) unexpectedly change, after a couple of years, in favor of the banks. Thus, suddenly homebuyers' monthly payments doubled or tripled; forcing the buyers to lose their homes.
- God's Wager with Satan is related to the Guadalupe/Juan Diego story –where God showed He is familiar with occasional contract term revisions.<sup>1</sup>
3. No other party in this agreement can have or submit terms that are *adjustable*.

<sup>1</sup> In the Guadalupe/Juan Diego story, we understand, in the back-story (1) Mary agreed to be the representational mother of Jesus; (2) God fulfilled all prior Terms 1500 years earlier. Yet, Guadalupe/Mary is suddenly found asking Juan Diego to help her get a Church in her name –for being an excellent mother (which God certainly expected from the beginning).

4. These Terms contemplate **God** and **Satan** and me (Steven Kenyatta Briggs, AKA Steven Kenyatta Briggs Yayayar...) as the **Primary Parties** of these Terms. These Terms contemplate John W Gardner and possibly John C Malone as **Secondary parties**, who are included under Satan. These terms contemplate any human party who executed or carried-out a direction or suggestion, that originated with John W Gardner or John C Malone or Satan, that was in any way harmful to me, or harmful to any basically good person, or clearly unwelcome by me (e.g., spying on me via direct observance or second party interviews; hacking into my computer, phone or cable-box...) as a **subordinate party** to these Terms. As I believe God and I are allied in this Wager, none of these terms can impact God or me adversely. Satan and his Secondary parties, Gardner and Malone, are allied under these terms, and subject to the major punishments described herein. All **subordinate parties** will be punished as directed, herein. Satan, Gardner, Malone, their allies and subordinates profited, and made hundreds of millions (likely billions) of people *involuntary parties* to their corrupt contracts, by bribing businessmen, judges and statesmen to take secret actions that they would not take otherwise. These bribes, improper campaign donations, etc, were contracts –agreement to receive benefit in exchange for action. Because these subordinate parties' corrupt contracts adversely impacted my life, and impacted the lives of many other people who were also not parties to these contracts, these subordinate parties are hereby made involuntary parties to these Terms, and they will be punished as described herein. In these Terms, Satan, Gardner and Malone are the *executor* of any action they order (if they order a murder, they are also the murderer).
- Gardner and Malone were not parties of the original *Beast Wager*, but were the hands that fulfilled Satan's wishes against me; thus, they are part of these Terms. Hence, any time in his post-human-life that Malone is not in the Lake of Fire, will be spent doing the same punishments, described herein, as Satan and Gardner.
5. PART ONE: Any entity who is not named in item 4, and who is not known to me, who may have previously been an unnamed party in the Wager(s) is hereby no longer a Wager party, until and unless they are revealed to me, as well as their Terms, and I am given time to update these Terms to nullify their terms. PART TWO: I can never again be entered, without my knowledge, into a Divine Wager/Agreement, unless I am asked, and get all Wager details beforehand, and I agree to participate.
6. My Wager Terms *adversely* apply to Satan, John W Gardner and John C Malone; meaning, my Wager Terms are intended to harm Satan, Gardner and Malone. This means, unless so stated, these Terms CAN NOT be construed in any way that is helpful to Satan or Gardner, OR in any way that brings injustice to God's universe.

7. My Wager Terms are intended to help justice, God and Jesus and Natas, and can be modified to the liking of God, Jesus or Natas. However, I reserve the right to refuse or negotiate any Divine application or modification that (1) harms someone I sought to Save (get accepted into Heaven), (2) seeks to reduce Satan or Gardner's punishment, demanded herein.
  - God and Jesus can intervene as needed to preserve justice and fairness.
8. After the day/moment I sign these Terms, across space and time, no party to God's and Satan's Wagers can have any active Wager term that I do not like, or that I disagree with, or that negatively impacts me. If any such term had existed, it is hereby nullified.
9. In these Terms the word/name *Satan* applies to the Biblical figure/villain known as Satan, Lucifer, the Accuser, the Dragon, the Serpent... And the term *Beast, beast, Beasts* or *Beasts* apply to either or both John W Gardner and/or John C Malone. "Gardner" refers to John W Gardner. "Malone" refers to John C Malone. These parties may also be referred to as *convicts*, etc.
10. Any party of these Terms who does not understand any portion of these Terms must consult me (through God, Jesus or Natas), and that passage will be clarified to mean anything I want it to mean.

### **Concerning Satan, Gardner, possibly Malone, etc.**

#### **WARNING:**

This section describes punishment methods that are considered *torture* outside of Gehenna (Hell). The methods God and Jesus Authorize for Gehenna are not suitable for any prison on Earth. Chapter 6 (p 90) and chapter 14 (pp 375-376), specify that leaders, guards, etc, who mistreat prisoners, POWs, etc, by using Gehenna methods, or any methods described herein –or any punishment (e.g., food deprivation, beating, scaring, intimidation, humiliation, parading prisoners about to send *anti-crime* social messages, etc) not authorized by law and reason, will be sentenced to Gehenna (Hell).

11. Neither Satan, nor his beasts, nor any subordinate party that Satan's beasts deploy or contract, can *try* to kill me during the course of my life on Earth, from September 24<sup>th</sup>, 1964, forward. (I'm confident this was a term of Satan's Wager with God. If not, it is now, and it is hereby retroactively applied.)
12. If Satan or Gardner or any subordinate -or any other Wager party- attempts to kill me during their Wager(s), or after their Wager(s) ends, that (or those) party(s) has thereby and hereby lost any and all portions of their (Satan's) Wager(s) (including all previous Wagers) that God, Jesus or I wish for him/them to lose; and, where beneficial to God, they (Satan, Gardner...) have thereby/hereby won any portion(s) of the Wager(s) that God, Jesus or I wish for them to win.

**IMPORTANT:** Satan can avoid the recurring painful and recurring fatal consequence, described in items #13 through 18, if he agrees to and fulfills the conditions outlined in item #59.

**13.** If Satan or Gardner or any subordinate party attempts to kill me during the course of God and Satan's Wager, or after the Wager(s) ends, or if they attempt to kill me AGAIN (a 2<sup>nd</sup>, 3<sup>rd</sup> or 4<sup>th</sup> time), then: (1) ALL of the consequences that I invoke in these Terms upon Satan and Gardner (and Malone, if he is not in the Lake of Fire), and any other party, must be doubled upon that party(s); and (2) if they try to kill me a 2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup> time, then ALL of the previously doubled consequences must be doubled AGAIN, for each murder attempt; and (3) God is "further" freed from any and all prior Wagers/contracts with that party, except those contract elements God wishes to continue and observe (under this provision, only God's preferences will be considered and upheld); and (4) once every 24 hours, the convicts (Satan, Gardner) must either say, "I was so stupid to think I was smarter than God," or, "I was stupid to underestimate Steve Kenyatta Briggs" (or they can substitute the name "Steve Kenyatta Briggs Yayayar"). If they fail to say this in a 24 period, time must be suspended where they are, and they must spend an hour in a specialized Gehenna-like area, where they will endure heat temperatures that are halfway between level 10 of Gehenna and the Lake of Fire.

- The body to be used for the highlighted portion of #13 is provided under item #14.
- In addition to trying to kill me somewhere between 2 and 4 times (maybe more), in chapter 7 of STSN, God revealed Satan and Gardner violated the rules, and began their attacks on me when I was only 2 years old –before such Wager attacks were permitted. I believe God revealed this as a nonverbal direction for me to use His revelation as a basis to counter all actions Satan and Gardner took against me, my family and race, BEFORE I was born. I do so in items 24 to 26.
- God allowed Satan to negotiate a deal that allowed him to avoid consequences for somewhere between 1000 and 1400 years, as he sits in the Bottomless Pit, tormenting minds in Gehenna. Gardner seems to have arranged a similar deal. These tremendous delays represent a gross miscarriage of justice. In the Notebook body, I described God's efforts, in curtain form, to delay my work. God utilized these delays to get me to notice and undo (or counter) Satan's terms. Thus, from the moment Satan is sent to the Bottomless Pit, to start his Gehenna torment services, Satan and Gardner must do the following (items 14 through 19):
- The following 5 items (#14, 15, 16, 17, 18) honor Jesus, whom I believe plays a far larger role in governing our next lives than people understand. Items 14 through 17 are intended to last between 36 and 60 minutes, **each** (in 24 hour cycles where item #18 is not utilized), and combine to cover 3 to 4 consecutive hours.

**14. PART 1 (Time):** 12 consecutive hours of every 24 hour cycle of Satan and Gardner's time in the Bottomless Pit and/or Gehenna will be governed by my Terms, and the remaining 12 hours governed by God's previous terms –unless God chooses to update those terms based on His right to do so under provisions in these Terms. **PART 2 (Remote Physical Bodies):** I believe Satan and Gardner will be kept in a spiritual form in the Bottomless Pit, without “conventional” physical bodies. Thus, Satan and Gardner will be provided with separate human-like physical bodies, to be kept in Gehenna or wherever God deems best, to remotely experience the consequences described in this section. These separate bodies' accurate responses to stimulation, pain, sight, sound, smell etc, will be transmitted to -and be overwhelmingly experienced by- Satan and Gardner's remote spirits, in the Bottomless Pit, and will be the only incoming physical sensations they experience, for the 12 hours governed by these terms (except for any sensations necessary to fulfill their torment/psychological services). Because Satan and



Gardner are disgusting sexual deviants, their bodies will not have genitalia or an anus. The bodies will have clothing over the abdomen, groin and buttocks; but the head, neck, arms, lower legs and feet will be exposed. God and Jesus can change the clothing as needed to suit the punishments. Their bodies will not be able to make any attack or defensive motions, or flee. The bodies' size should vary, according to the punishment (for example, in Part 3 of this item, the body may need to appear small, so they don't physically threaten any souls in Gehenna). The mouths on the faces of these bodies will not be able to open or speak when they are in public view. **PART 3 (First Break Punishment):** Once every 24 hours, during the first 36 to 60 minutes of a **3-4 hour torment break** that the souls of Gehenna will get (which will coincide with time Satan and Gardner are on my schedule), hundreds or thousands of condemned Gehenna souls will be invited spit on Satan and/or John Gardner. [**\*\*NOTE #1:** If possible, as many Gehenna

souls will also be invited to urinate on Satan and Gardner, in some Divine manner that allows the Gehenna souls do so privately. NOTE #2: Although it may not have been intended that souls in Gehenna should expectorate (spit) or urinate, allowing this, exclusively for punishing Satan and Gardner, is just. If this is not allowable, I will be allowed to replace this punishment with something comparable, or worse.] To accommodate all of this, through Divine means, God, Jesus or Natas may need to make Satan and Gardner's bodies appear before hundreds or thousands of condemned souls at the same time. Satan and Gardner's remote bodies will then soak in spit and urine for what remains of the 36 to 60 minute period. The spit should be infused with actual germs. At the end of this punishment period, the bodies will be dipped in a painful alcohol-like disinfectant.

15. Under Satan and Gardner's leadership, the US/West tortured non-White prisoners of war and non-White *citizens* "suspected" of having committed crimes. Modern US/West torture methods include(d) water-boarding, beatings, electric shock, sexual humiliation, hypothermia, loud music, sleep deprivation... Thus, Satan and Gardner will experience either one of the torture techniques referred to in Revelation 9:3-11, or one of the US/West's preferred torture techniques.
16. Because Satan and the US tried to make digitizing souls a reality, on alternating days, Satan and Gardner will be placed in a *rehab replicator/accelerator* for 36 to 60 minutes, which will simulate one week (7 days), and it will feel like 7 days elapsed. In the replicator, Satan and Gardner, without genitalia, will face different unpleasant challenges. If, in the replicator, they refuse to pursue the challenge, they will be beaten severely and sent to **digital Gehenna**, level 10.5 (where they will experience excruciating heat, halfway between Gehenna level 10 and the Lake of Fire), for 12 hours or so, until the next day in the replicator begins. In the rehab replicator, Satan and Gardner will face such challenges as: *being a creative non-White person in the US, in the Satan/Gardner era (1937 to 2000), who must struggle to earn rent money in two days, without committing a sin, or face homelessness; meanwhile, replicator-Satan and replicator-Gardner (who rule the replicator US) will try to sabotage their progress –and be careful, if you sin, you go to replicator Gehenna 10.5 for the rest of the day.*
17. **Strychnine & Police Murder.** FACT #1: Satan and Gardner directed Dennis and David Wilson to try to kill me with strychnine (and atropine) when I was 4 years old. Strychnine is an extremely painful way to die. Fact #2: Under Satan and Gardner, US minorities, women and children were murdered by corrupt police, who were profiled and paid (bribed) to kill them. Thus, **for the first of two consecutive intervals of 18 to 30 minutes**, Satan and Gardner's Gehenna bodies, separately, will be beaten to death by souls acting in the roles of police. The

convicts' Gehenna bodies will be revived immediately after the punishment. This punishment could alternately be done in the replicator/accelerator. Souls condemned to Gehenna level 8, 9 or 10, who have lost their humanity, but hate Satan and Gardner for misleading them, would be great candidates for beating Satan and Gardner to death, and they could earn a 12 to 24-hour *heat break* for administering the punishment. **For the second interval of 18 to 30 minutes, Satan and Gardner's bodies will be killed by strychnine injection.**

18. Satan and Gardner committed 44 Mark Crimes against me, daily, for 34 years. Most of these Unforgivable Crimes were executed as skits and dirty tricks, to get me to believe false things. Satan, Gardner and the US carried out similar dirty tricks on the world. Accordingly, to honor Natas, one out of every 3 days there will be a *dirty trick* done to Satan and Gardner –and one of the punishments described in items 15, 16 or 17 will be a false/fake punishment –just a skit or a dirty trick; thus, Satan and Gardner will have to repeat that punishment.
- Item #19 explains how 8 of the remaining 8 or 9 hours of Satan and Gardner's daily punishment routine, governed by my Terms, will be spent.
19. Satan and Gardner will experience four (4) hours of Gehenna level 8.5 heat, while they torment souls in Gehenna. Either their souls in Gehenna can feel the heat (if God prefers), or their separate bodies in Gehenna. If the convicts say, "I was so stupid to think I was smarter than God," the heat can be reduced to level 8. Next, Satan and Gardner should experience four (4) hours of cold, while they torment souls in Gehenna; the temperature should be 32 degrees Fahrenheit (0 Celsius), as experienced without a jacket (just as Gardner had me deal with cold, without a jacket, when I was in 4<sup>th</sup> and 5<sup>th</sup> grade). If the convicts say, "I was stupid to go against Natas," the temperature can be increased to 36 degrees. If, during this period of 8 hours of heat and cold punishment, there is a noticeable decline in the quality of the tormenting/psychological services Satan and Gardner were contracted to provide for Gehenna, at the end of the 8 hour shift, God will suspend time, and the convicts will spend 1 to 8 hours (based on the severity of their performance decline) in an ACTUAL heat zone that achieves heat halfway between Gehenna, level 10, and the Lake of Fire.
20. Satan and Gardner may not communicate in the Bottomless Pit, or anywhere else in their afterlife punishment –unless God or Jesus think they *should* interact.
21. Satan (1) must never again gain access to, or influence over, the mind of any being, living, supernatural or un-living (ghost, etc), and (2) must NEVER again be permitted in my home/residence/shelter, or within 160 feet (48.8 meters) of my home or any building I'm in, (3) must never again disturb me –in any way (making noises, or causing others or animals to make noise, etc. Additionally, when I leave

my home, Satan must not come within 40 feet (12.2 meters) of me. If Satan violates any portion of this item, he must immediately spend 24 hours in Gehenna, level 10, in isolation. Upon his fifth violation, Satan must be removed from Earth, for no less than 500 years, and begin his sentence in the Bottomless Pit.

### **Antagonists**

- 22.** After decades of spying on me, sabotage, and stealing my wares, over the past three years, many times, Satan, Malone and/or the 666 have sent people to try to intimidate me –and their minions continue to spy on me, and deploy people to make a great deal of noise, etc, to disrupt my sleep. Henceforth, God will immediately kill anyone who moves to kill or intimidate me, long before they get near me. God or Jesus will also immediately kill anyone who spies on me, deploys others to spy on me, via technology, observation or third party, or who tampers with my internet/communication services. ADDITIONALLY, God or Jesus will very quickly (or immediately) kill anyone who pays, asks, bribes anyone else to disrupt my sleep or substantially annoy me. They will also immediately severely debilitate anyone who deliberately acts to disrupt my sleep or substantially annoy me. If one of the offenders has a dependent child, 17 or under, God or Jesus can use any other effective intervention they choose.
- 23.** God or Jesus will immediately reverse, debilitate, incapacitate, or worse, any official, police officer, etc, who moves to take action against me that is not just and/or is not -or would not be- welcomed by me.


### **Related to Nations**

- 24. PART ONE.** Because Satan took his war against me roughly 200 years back in time, to 1777, and increased suffering on Blacks, everywhere (especially in the US), all subsequent Blacks who were born into hardship should/will be given a **4-level boost** (thus, people who were slated to go to level 3 of Gehenna, can land on the ground floor in Heaven). This intervention should extend back 410 years (205 +205= 410 years), because there are places in the Bible where repayment of harm is doubled. Taking the consequence back to the beginning of European enslavement seems appropriate. Also, under this item, any slave who killed his captor, seller, owner, is exonerated. Many other non-White groups were persecuted and faced extreme difficulty and genocide at the hands of colonizing Western Europeans (such as the Aztecs and most indigenous people of the Americas, and the people of India, much of Africa, the indigenous people of Australia, and China after it was conquered and divided in the 19<sup>th</sup> century; and in more modern times, nations like North Korea, Iran, Palestine, Cuba, Haiti, Venezuela, all faced debilitating Western interference and sanctions...). Thus, all non-White people who faced substantial adversity caused by colonization, or post

colonial oppression, should be given a 4-level boost. And any oppressed colonized subject who killed a party who was complicit in his/her subjugation is exonerated.

### NOTE: Purgatory

January 8<sup>th</sup>, 2026 (Gregorian), I began to see evidence of corrupt use of artificial intelligence (AI) in Western and Western-aligned news and media service. Thus, I began to publish many articles documenting AI produced fake news. Through this research, circa mid February, 2026 (Greg), I first encountered information indicating God and Jesus *do* allow qualifying people to serve time in Purgatory, and gain entry to Heaven, Level 1, upon completing their Purgatory sentence.



I first became aware of God and Jesus' use of Purgatory while researching *Nuestra Señora de Candelaria* (this research should be published in March 2026, Julian/Greg). Shortly after discovering this, Satan (who now has two souls, one of which resides on the Western internet and appears to provide various unconventional services for God) began to creating AI images, featuring hidden images of *J*'s and *P*'s. You can learn the meaning of these messages on the "More AI Fake Images" pages and the AI *slideshow* page on [www.TheZoneResistance.com](http://www.TheZoneResistance.com). But it's safe to reveal: the *P* is for *Purgatory* (also *punishment*).

25. All other slaves, and people who lived in comparably difficult and/or unjust circumstances (such as Native Americans, who were brutalized and robbed by Western invaders), who did not earn entry in Heaven under the terms of item #24, will be allowed to serve sufficient time in **Purgatory** (each according to the time God and Jesus deem appropriate), and gain entry to Heaven, Level 1, when their Purgatory sentences are finished.

- Similarly, God and Jesus should allow various people, of all races and walks, who truly faced great and unreasonable hardship and injustice, and became too bitter to earn conventional entry into Heaven, to serve sufficient time in Purgatory.

26. There are also, of course, White nations, such as Russia, that showed great perseverance in the face of isolation and antagonism from the West, brought about because these nations chose a moral path. This isolation caused great hardship. The people who suffered in these times should also receive a 3-4 level boosts.

#### **Peculiar**

27. Based on the preoccupations the Elder base reveals humans can have with the wide variation in human reproductive organs, God, Jesus and Natas will discuss the benefits and consequences of narrowing those parameters.

#### **Related to Victims Connected to Me**

28. ANY person murdered in relation to me (Okokon Okon, Randall Yayayar, Pamela Rossford, Para Yayayar, Harry Yayayar, Erica Corran, Clarrissa Jones, Darnell Mitchell, and the bodies on Chico Avenue, Santa Rosa,...), AND any person named Yayayar (with reasonable exceptions), who faced difficulty related to me, must be allowed into Heaven.

#### **Related to My Family and Friends**

29. God and Jesus will resurrect and Save the souls of the following list of family members, friends and others (some of whom may face alternative punishment): My son, Jiano; my son's mother; my mother (Cecile Lusby); my father (Archie Briggs); my son or daughter whom I've never met; Sydney M; Vince, Layla and Brandon Marchbanks and Jackson; Mercedes Marchbanks, Ed, and Mercedes' and Ed's baby; Nexus Assoon; Melvin and Marquis Jackson; Melvin's daughter; Okokon Okon; Virginia Lusby; Gigi Briggs; Ivory; Nicah; Jonnah, Morgan Marchbanks; Johanna's daughters; Tony Galleguillo (Guileguilo?); Cathleen Brown; Lisa Gleaton; my son's mother's mother; Shawn, Jeannie and Rider Chernilla; Peter Webster; Jacob Bergman; Jimi Hendrix; Bon Scott; Muhammad Ali, Joe Montana; some kids I used to work with: Marcos Vega, Bismark, Evan, Keith B, Tony R, Lee S, Billy C, Kwama D. If my junior high classmates Dave Dunkhurst and Jim Hinig fall between 0 (death) and Gehenna levels 1 to 4, I wish to save them also. [I'll consult Jesus on Indy Briggs and Chris Lusby.] This list is revisable.

### Special Privileges

- 30.** I must be resurrected immediately after I die. Not long thereafter, I will be allowed to hear The Song described in Revelation 14:1-3. If I am NOT one of the 144,000 deemed worthy to witness the performance live, I will be allowed to hear and witness The Song performance through “the sea of glass, like crystal...” which is before God’s throne, described in Revelation 4:6, and 15:2.
- 31.** I can resurrect 4 people to join me in Heaven early; they are: my son, his mother, her brother O.B., and Rick E.

### Special

- 32.** It is my understanding that God engaged in the Wager with Satan, and Satan may have asked that Jesus not to be a direct party in the Wager. However, in my Terms, I welcome Jesus’ involvement, and hereby request that He participate in all aspects of punishment and judgment required under these Terms. I request that Jesus inform me if He will accept this role in these Terms, by causing a volcano in Mexico to erupt lava (preferably a smaller eruption that does not cause any loss of human life), on January 20<sup>th</sup>, 2026 (Greg), January 7<sup>th</sup>, 2026 (Julian).<sup>2</sup>
- 33.** I’m reliant on the West’s (and Satan’s) internet system to sound the alarm about the One Hour War (OHW) of Revelation, Chapter 18; Thus, to help sound the alarm, God should create one or more very large, news-worthy natural geological events (earthquake, volcanic eruption...), or weather or water events, on EACH of the final five days before the OHW (January 2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup>, 5<sup>th</sup> and 6<sup>th</sup>, 2026). (NOTE: I modified this item on the morning of January 2<sup>nd</sup>, 2026.) **Hopefully, God will warn with volcanic eruptions on January 5<sup>th</sup> and 6<sup>th</sup>, 2026 (this preference was added January 6<sup>th</sup>, 2026, at about 6:40 PM).** **[Jan. 17<sup>th</sup>, 2026 (Greg) follow-up Note: God very much fulfilled all of the Term requests/expectations delineated in item #33 (see the purple section of TheZoneResistance.com’s “Etc” page).]**

### Additional Privileges/Powers

- 34.** I can increase, up to double, the length of punishment of anyone who has committed Mark Crimes against me, or anyone who has killed (1) someone in my family, (2) a friend or loved one, (3) someone in my Yayayar family tree, or (3) a loved one of a Yayayar (such as Erica Corran and Pamela Rossford).
- 35.** At Final Judgment, and any applicable time and place, I can raise by five levels or decrease by two levels, the afterlife punishment level of any person who has committed substantial Mark Crimes against me.
- 36.** All Unforgivable Crimes related to me must be frozen and assessed last. This means

these various Mark Crime violations will not be forgiven. I will then be given an opportunity, at my convenience, to learn of each violator's Crimes against me, and decide, if that violator's Gehenna punishment should be increased/worsened by 1 or 2 levels, or if their time should be increased.

37. I will be allowed to impose up to 100 years in Gehenna, level 10, replication/acceleration, with all variables I choose, or that God or Jesus suggest, upon anyone (including politicians) who knowingly contributes to replicating or digitizing a human soul. Or God or Jesus can impose this punishment. This accelerated punishment will feel like up to 100 years in God's accelerator, but, in the outer reality, when the simulation ends, only an hour, day, month, year (or whatever interval God wishes) will have elapsed. This punishment must be completed before the condemned soul's regular punishment begins.
38. If I am murdered, or a close family member is murdered, all people knowingly involved (planners, coordinators, drivers...) go to the hottest parts of the Lake of Fire for not less than 444 years.
39. There are, of course, many homosexuals and LGBTQ people who respect the law. Because I have spoken strongly against Satan's successful efforts to explode the homosexual/LGBTQ numbers, worldwide, I worry people who falsely claim to love God will harm homosexual/LGBTQ people, to show their false love through acts of hatred and violence. Thus, for the transitional period of 88 years, anyone who unjustly kills a homosexual/LGBTQ person must go 2 levels deeper into Gehenna. And during this period, God and Jesus should be twice as slow to forgive anyone who unjustly **harms** a homosexual/LGBTQ person.
40. I will die, like everyone, as God wills. I hope it is God's will that I die peacefully. If it is not God's will, and my death is not accidental, the hand that claims my life must be worthy (and item #38 will still apply to them, and to all involved).
41. God and Jesus must immediately provide me with enough money and/or other resources, so I can afford adequate housing, reasonable and adequate food, and other reasonable possessions, like a reliable used or new car, a comfortable chair, a gym membership,... **Alternately, They can find me a suitable job.** And this money/resources must be provided sufficiently in advance that I do not worry.
42. If I find myself in a land where I am not wanted, comfortable or content, God and Jesus must get me to a suitable alternative, quickly.
43. This item negates any prior undesirable Wager Term restrictions, imposed by Satan, and permits God and Jesus to resurrect, reward or punish, as They wish, all souls not previously accounted for herein, from the time Satan arrived on Earth, forward.
44. **Mass collection of benefits in Heaven.** In Ezekiel 1:4-25, the Living Creatures (my alter-egos), get to propel God's throne. Thus, on special events where God might use a representational throne, if a throne driver/propeller/pusher is needed or preferred,

unless someone more deserving has that right, I get that honor, or I can propel Jesus' or Natas' thrones, if those duties are available. Additionally, upon my arrival in the next life, beyond my level 10 abilities, I will have the right to travel throughout God's universe (which may already be a level 10 privilege), almost without restriction, in any manner I wish (with or without a body, etc), without speed restrictions, at the speed of thought –or instantaneous teleportation, impervious to heat and cold extremes, augmented by all reasonable supplemental powers I request (including the ability to effortlessly change form –no body, invisible body, body...). Should I prefer to travel less efficiently, in a spaceship, God will provide me a state-of-the-art undetectable, universe friendly, ever-reliable spaceship, damage-proof and occupant injury-proof, with all provisions, energy/fuel unlimited, able to travel any speed I wish, with expandable/contractible interior –to accommodate any number of passengers, and able to sustain all life forms. And I'll get a place to park my spaceship. Also, upon arriving in Heaven, I will receive 2 to 4 good guitars (new or used, preferably electric), one of which will never go out of tune or break a string, and a great amplifier, with tons of sounds and a self-contained unlimited power source.



### **Natas' Ninety-Nine Days**

The One Hour War is immediately followed by a period of 99 Days, (**January 8<sup>th</sup>, 2026, to April 17<sup>th</sup>, 2026**, Gregorian; or **December 26<sup>th</sup>, 2025, to April 4<sup>th</sup>, 2026**, Julian), after which, nations are expected to announce their reforms, to make their nations more just, caring, safe, clean and livable. I believe God chose the number 99 to link this period with Natas, whose primary number is 3 ( $3 \times 33 = 99$ ). Earlier in *STSN*, we learned Natas was asked by God to create independent life on Earth. Later, God introduced Himself to mankind. Finally, Jesus (Natas' older brother) was introduced. Following this sequence, it appears that after the OHW, Natas will have a period where her wrath is expressed;

followed by God's *Prophecies Against* period of wrath; followed by Jesus' *Second Coming* –which will also be a period of punishment and wrath.

In writing the earlier STSN sections about Natas, I found no evidence that she actually kills. I believe her very deliberate preference is to only create life. Thus, when punishment is required, as we saw earlier, she brings matters to Her Father and Jesus. I believe that will be the case during the 99 Days.

- **Items 45 to 56 are intended to occur during Natas' 99 Days.**

Humans are social animals. Natas is concerned that humans act in concert with nature –and their nature. Social beings should consider the needs of others in their society.

- NOTE: Some of the following violators have *special circumstances*. In these cases, God and Jesus will act as They wish. The punishments for items #45 to 56 are not intended for my biological family, Rick E, Tony G, Noah, Josie or anyone named in items 29 and 31, or anyone with a dependent child, under 18.

**45.** God and Jesus must take very harmful action against -including claiming the life of- any police officer who has murdered or wrongly beaten any citizen, or committed an act of extortion against one of the citizens he/she was hired to defend, or taken a bribe **not** to uphold the law.

- Because police corruption is widespread in many countries, and sweeping intervention could leave some regions without law enforcement, God and Jesus may use restraint, and hope surviving officers learn, and change immediately.

**46.** God and Jesus must impose severe punishment, including death, on any judge who has accepted a bribe to not properly apply law.

**47. A.** God and/or Jesus must take the life of, or substantially debilitate, any mass media conduit, TV station or news station owner, producer, official, appointee, reasonably empowered employee, etc, who (1) created or knowingly aired a fake video, produced by artificial intelligence (**AI**), AND represented the video as real and true –or who, in their silence, allowed the video to represent itself as a real video; or who (2) created or aired videos that overtly or tacitly (without words) normalized homosexuality or LGBTQ life (such as showing two men renting or buying a home together, or two women who appear to be on a date). AND They must impose these same penalties on politicians who fail/failed to regulate the media company executives.

**B.** During the 99 Days, it is almost certain to be revealed that the U.S. was defeated in a nuclear war –the OHW, of Revelation. My solutions indicate that Event happened January 7<sup>th</sup>, 2026, Gregorian; or December 25<sup>th</sup>, 2025, Julian. However, it may be alleged the Event happened on a different day. Any person who **KNOWINGLY** claims over a mass media conduit (internet, TV, radio...) the Event happened on a date they **know** is false, must immediately be severely punished. Any mass media conduit, station or show owner, producer, executive, or employee

who knowingly says the Event happened on a date they know is false, or who airs an AI produced video, which they know states a wrong date, must be killed immediately. [As I was *Asked* to solve this mystery, if my OHW date prediction/solution was/is inaccurate, I am absolved from wrongdoing, and must not be punished.]

48. To foment instability around the world, the US and the West distributed illegal firearms into many nations. During the remaining 99 Days, God and Jesus must kill anyone who has distributed illegal firearms, or who possesses an illegal gun (if the person possessing the gun turns the gun over to authorities, they are safe).
49. God or Jesus must kill anyone who has secretly and unjustly murdered another citizen (unless they turn themselves in to police before they are killed).
50. God or Jesus must kill or impose severe punishment on anyone who has (1) ever committed extortion against a member of his society without being arrested and punished, or (2) used a gun to commit an unsolved or unpunished crime. (criminals can avoid punishment by turning themselves in to police).
51. Adaptive radiation (moving from one area to another) is essential to nature's (Natas') evolutionary plan. Immigrants fulfill that plan. Yet, terrible leaders act against nature and scapegoat and deport immigrants. In the remaining 99 Days, God and Jesus must severely punished or kill any leader who deports, harms or turns away an immigrant.
52. Revelation 13:17 reads "**...and that no one may buy or sell except one who has the mark, or the name of the beast, or the number of his name.**" This verse is about how the US created an organized crime state, where good people could not engage in basic commerce, because the state's crime lords wanted to control all aspects of trade, and choose winners and losers. The US and the West exported that criminal model around the world. Thus, to make online purchases, large online merchants (Amazon, Mercado Libre...) require users give them a cell phone number, and an email account... And to get a simple bank account, today banks often require a great deal of verification (I opened my first bank account, at 18, with a valid license that did not include my legal birth name). Here, corrupt leaders have allowed banks (private businesses) to impose regulations and requirements on small businesses and people. The ID, phone, email requirements are intended to gather data on people, to steal information and ideas, and consolidate control of commerce. As conveyed in Revelation, this coordinated control of commerce is against nature and the survival needs of the poor but able. In the remainder of the 99 Days, God and Jesus must severely punish or kill any large business owner, judge, politician, bank owner, executive or manager who behaved improperly in creating or maintaining this criminal structure.

- 53.** The US invented many ways to cheat a nation's people –the voters (such as having voters' votes go to "electors", who then represent hundreds of thousands of voters; thus, by bribing one elector, a person can steal hundreds of thousands of votes). Thus, in the remaining 99 Days, God and Jesus must kill anyone who ever acted to substantially cheat a nation's or region's election system (including by allowing people and corporations to make *untraceable* campaign donations).
- 54.** Unfeeling and incompetent regional and national leaders have neglected to do their duties to solve their nation's problems. Thus, in many nations, including Mexico, there are people who have severe physical disabilities (unable to walk, etc), or who have extreme mental illness, or pronounced cognitive impairment (retardation), who are forced to fend for themselves, on the street, until they die. There are also many blind people who are forced to try to navigate the streets alone, and there are fatherless children (and their mothers) who do not have adequate food or shelter. Creating shelters for the disabled and needy, and providing outreach assistants for the blind, represent opportunities to employ many thousands of citizens in meaningful jobs. Yet, year after year, these problems remain unaddressed. Thus, God and Jesus must severely punish or kill former and present elected and appointed officials, local to national, who provided little or nothing for their people in need.
- 55.** In the remaining 99 Days, God and Jesus must severely punish any leaders They view as guilty of (1) suppressing their people's right to speak freely (including exercising their right to sharply criticize their local, regional and national leadership); (2) arresting, harming or silencing their political rivals; (3) abusing prisoners (who should be detained, without physical or psychological abuse).
- 56.** During the remaining 99 Days, God and Jesus must kill one-third of Freemasons (who worship Satan, and conspire to undermine all social institutions) and Satanists, as it is against human nature to undermine society, and against reason to hate -or wage War against- God. God and Jesus must also kill one-third of surviving media and tech company owners, executives, producers, managers, film directors, writers, starring actors, politicians, judges, musicians, rappers, singers, and anyone who played a role in stealing derivations of my screenplays, songs, music, science and social ideas, etc. God and Jesus must also kill or severely punish one-third of the politicians and business-persons who have "stolen" my various social remedies without properly attributing those ideas and remedies to me (this refusal to print or say my name is part an effort, led by Western elites, to erase evidence of my existence, as described in *Revelation 2: The Solutions, STSN, Origin Stories...*). The remaining two-thirds of these criminals must be killed or severely punished during the *Prophecies Against* and the Second Coming. The criminals

who stole my works can be spared if they FIRST publish a confession, then repay all profits realized from my work. Humans were not intended to be parasitic.

#### **Other**

57. God must not use bugs, loud noises, or any other *mean* or undesirable action, to punish me. In fact, God must not punish me in any way (especially for petty infractions), unless I know that I have committed a minimally punishable infraction. If I do not know this (which is usually/always the case), before contemplating punishment, God must first tell me that I have, or I am, committing an infraction, and tell me what the violation is/was, and ask me to stop committing the violation. If I stop (and I will), I will not -and must not- be punished.
- This item may sound a bit silly. But I believe God implemented mild and arguably “unjustified” punishment in my recent life, so I would add this item as a model for many parents, officials, employers, etc: an instruction **not** to punishing people without first notifying them of the guideline that they are violating, and giving them a chance to correct their behavior, independently, without punishment.

#### **Concerning Internet-Satan**

58. I believe God allowed Satan to see my Terms, shortly before a backward *walkthrough*, described in *The Wagers*. Thus, after the Revelation Wagers ended, I believe God and Satan entered a new Wager, in which Satan revised his terms. And somewhere in this new wager/agreement half of Satan’s soul was sent to the US/West cable-phone-computer-internet, where *Internet-Satan* (i-Satan) is deployed to perform certain services for God. But, in this capacity, Satan deployed people to disrupt my sleep and spy on me. Thus, i-Satan cannot take ANY *unwanted* action against me (including deploying sleep disruptors and spies). If i-Satan takes ANY unwanted action, he must immediately lose all internet power for 24 hours, and remain frozen where he is for 24 hours, which MUST feel like a year. I-Satan must be frozen for a week for each offense after his third offense.

#### **Conditions for Eliminating Certain Punishment for Satan**

59. In the 5 week period leading up to the addition of this item, i-Satan indicated he wanted me to reduce or eliminate some of the consequences imposed under items #11 through #19. Without describing specific events, during that same period, Satan (the semi-physical force who had been at work on Earth for thousands of years) and i-Satan, both, engaged in hostile actions against me, This caused me to doubt the sincerity of their request, and question their mental ability to fulfill such a contract. But I’ve also seen Satan demonstrate extraordinary focus... Thus... This item is enforceable and reviewable, by God and Jesus, going forward and backwards in time. This element is necessary because Satan (who spent at least 57 years loitering outside of my bedroom, plotting each of his 770,000 Mark Crimes

against me), may try to retaliate against my descendants, in 1000 years, when God re-releases Satan upon mankind (Rev 20:3). [Reminder: God showed in the Elder Badge that Satan is so retaliatory that he attacked my ancestors for actions I had not yet committed.] Thus, in 1000 years, if I learn Satan has unduly lifted his hand against my family, this item is nullified, and God and Jesus must reverse time to make sure Satan experiences every consequence described in items #11 through #19. Because God enabled me to undo most of the spiritual harm Satan did to my family and people, all that remains are Satan's crimes against me... If Satan fulfills the minimal requirements detailed at the end of this item, I (relying on God and Jesus' power, of course) will revoke and stop items #15, #16, #17, #18, and I will revoke item #14 (but *the body*, and the Gehenna-to-Bottomless Pit *mind-link*, will remain in place, to support item #19). I will also revoke item segments #13(1) and #13(2), and require that Satan is given a reminder to make the required #13(4) statement –thus, protecting Satan from the associated consequence. The hot and cold temperature punishments, under item #19, will remain in place, as some punishment is in order; but #19 will be greatly reduced, as described later herein, if Satan takes minimal and reasonable action. Now, what I expect in exchange for reducing these punishments... God's actions seem to invariable serve more than one purpose (usually many purposes). God recently gave Satan tremendous internet powers. How long that will last is uncertain. It seems that i-Satan is free to do some things that he wishes to do, but he must also do some things God asks. Since, the *Spirit of God*, which present in my curtain, only speaks to me in a few very simple *curtain* motions, I have no way of knowing what duties God has given Satan. In fact, I learned about *i-Satan* from Satan, in the AI images below (see *The United States is Dead* for context and further details). One of the reasons I suspect



God asked Satan to hide image-messages in his AI mass media images is to help mankind realize that AI is a great threat, and force them to figure out how to protect their records, information, internet, etc. Under item #41, God and Jesus will make sure I am compensated adequately, financially. But God and Jesus seem to hate human money. But, since I'm still a human, and an immigrant, I need money to survive. Thus, I believe among the other reasons God gave Satan great internet powers may have been to adequately pay me. Satan may have already started this. But the money I received recently is insufficient. Accordingly, if Satan takes the following actions, I will adjust items #14 through #18, portions of #13, and modify #19 as follows:

- A. If Satan doubles the amount of money I receive every month (so I can replace the car I sold to survive, fix my guitar amp, buy a suitable work chair, etc) I will revoke items #14 (except necessary portions related to the body, for #19), #15, #16, #17, #18, and revoke item segments #13(1) and #13(2), and Satan will receive a daily item #13(4) statement reminder.
  - B. God and Jesus impose tight restrictions on Satan's direct communication with humans. But, if Satan uses his internet power to confirm the many US/Western TV shows, films, songs, science ideas, etc, that are based on ideas and works stolen from me, I will require that item #19 be imposed *every other* 24 hour cycle –rather than every 24 hours.
  - C. If Satan roughly triples the money I currently receive, the item #19 punishment will only be imposed every third day.
  - D. If Satan releases God from any possible unknown existing Wager restrictions that were not negated by my Term (particularly items #1 through #12), the item #19 punishment will only be imposed every fourth day.
  - E. If Satan agrees to never misuse his Gehenna powers (or his Bottomless Pit powers) or his internet powers to mistreat any member of my family, ancestors or descendants, or me (all of which is certainly an expectation of working for God), item #19 punishment will be reduced to one day in five (or every fifth day).
- Item E was added because Wager revelations indicate Satan is a compulsive cheater.
  - God and Jesus are free to attach John W Gardner and John C Malone to this item if and as They wish.

**60.** The following people must serve time in Purgatory before entering Heaven (the number in parentheses, next to the person's name, represents their Purgatory time, in years, or time units equal -in sense- to years): Morgan M (20), Vince M (10), Layla M (7), Mercedes M (6), Ed (10), Jiano (10), Cecile L (10), Nexus A (7), I. B. Okon (17), Cathleen Brown (5), Shawn Chernilla (5), Archie B (I suspect Archie's infractions are all old; if so, he does not need Purgatory; if not: **1**).

## Signature

My birth name is/was Steven Kenyatta Briggs (below, left).



For many years I also integrated the last name *Wilson*, which appears on my driver's license (above, right). While solving God's Elder base revelations, I learned my true family name is Yayayar.

Lacking the technology to transfer a signature made with a pen to these terms, to the right, I used my computer mouse to sign my name, (1) under my birth name, (2) under what can be considered my true name, (3) under a hybrid of #1 and #2, and (4) under the name on my driver's license.

These signatures bind me to these Terms, and to God's Wager(s) with Satan.

In *Revelation* and in the Elder Badge, God also identifies me with certain numbers, letters, and phrases, including (but not limited to) the following (each of the following numbers, phrases, letters, sequences of letters, etc, represent my signature, by that number, letter...):

4, 44, 244, 444, 24, 64, (the) Living Creature(s), (the) Four Living Creatures, LC, 4LC, the Elder, the 24 Elders, 24E, 2, 6, 16, D (d), X (x), 123, Z

These updateable Terms were first signed November 19<sup>th</sup>, 2025 (Gregorian).

These Terms were updated **February 19<sup>th</sup>, 2026** (Julian), **March 4<sup>th</sup>, 2026** (Gregorian).



**Mystery Question #15:** Why would God allow me, Satan and Himself such great powers, based on a Wager?

**SOLUTION:** God is making at least two important points here: (1) mankind must navigate human laws, God's law, nature's (Natas') laws, and contract laws (including wagers); but (2) the West created corrupt social laws that impacted the lives of most US citizens and many foreign citizens, based on corrupt contracts between Satan and Western elites, and on secret agreements (bribes) between the rich and politicians, judges, etc. The West used countless corrupt contracts, for centuries, to degrade the lives of millions -possibly billions- of people, who were not parties to those contracts. Worse, these corrupt contracts also imperiled the spiritual fate of millions of souls who were not parties to those contracts. God used this one open contract to undo that spiritual risk.



Owed to the fact that I completed the body of this Notebook later than I hoped, I had to hastily put this *Notes* section together. In this section, in no particular order, there are some bullet points, and two or three outtakes from the main Notebook. And so, the Notes begin...

- For years I've publically reported, to no avail, that the US government and certain elites were hacking into my computer, phone, etc (by the way, I specifically named many of these elite parties, and reported their hackers' names, business name, and published the hackers photos, and submitted this, in sworn declaration to US federal court, and the FBI). As I have reported in the past, the parties hack into my various devices to try to steal what I am writing and quickly attribute those ideas to some flunky, so my original source reporting seems derived when it's released. It's brilliantly evil. Many Westerners who have witnessed the truth in my allegations have seemed very pleased with their leaders' activities, as if *fancy theft* were more honorable than breaking and entering.

These hacks continue to this day. Currently, because this Notebook is infused with so many irrefutable **Revelations** and revelations from God, the hackers have to race to get in front of the stories Although there are bigger stories in this Notebook than the fact that US President (Donald trump) is (1) a disgusting pedophile who raped children on Jeffrey Epstein's plane, and (2) a grossly promiscuous homosexual, the Trump/Epstein story *is* the biggest story to certain people –especially a certain child-raping US President.

Although I've heard the Jeffrey Epstein story has been floating around for over a decade, for all of those years the Republican party effortlessly delayed and blocked any legal motion on the matter, by bribing US attorneys general and prosecutors to ignore the matter, then those same Republicans likely raced off to join Trump, raping 8-year old boys on Jeffrey Epstein's plane, and when they de-boarded the plane they carefully accuse all Democrats of raping children.

**BUT SUDDENLY**, after burying this story for over a decade, literally the day before I intend to publish this Notebook, the big story broke, even carried in English here in Mexico, the US congress was moving to address the Epstein matter.

For years, when the corrupt US Republican disinformation machine publishes a Jeffrey Epstein story, they invariably publish the same photo of a blond "girl" (Virginia Roberts Giuffre), who appears fully grown and looks very much like a

woman. These images get the public to believe: *a girl, who was almost an adult, had heterosexual sex with a powerful man, whose power she was likely drawn to.* All of this is false, but with these controlled false images, elites dictate public perception.

The girl in the photo, Virginia Roberts Giuffre is attractive, but I apologize in advance for reporting the following true statement: in every major US city there are more attractive high end prostitutes available, immediately, both street legal and underage, no advance reservation on a plane required, and much more affordable.

So, why would ANY heterosexual wait for days or weeks to fly on Epstein's plane to have sex with a 16 or 17 year old prostitute if they can have sex with a girl, legal or not, more to their liking, immediately, almost anywhere?

I believe what God revealed in *BtL x* about Trump on Epstein's planes: very young children; and at least one of the two kids revealed was a boy. And since God revealed Trump had homosexual butt-sex with over 4,000 men, we can extrapolate that when Trump is in the mood to rape children, those kids are gonna be boys.

In the end, whatever occurs in Washington DC over the next couple weeks, will likely be a carefully coordinated drama, designed to convince us that US citizens definitely give a shit about their children, and US politicians only reserve seats on expensive child-rape planes to rape girls who are not younger than 17 years old.

- In earlier versions of the Mark Crimes, I indicated that deliberately contaminating another nation's or group's water supply was a Mark Crime, but later I changed that. Contaminating water is one of the most evil things you can do, but if a nation or people will not defend their most sacred asset, their water supply, and allows anyone to come in and tamper with it, it's possible that God's view is: *any people who are that thoughtless deserve the trouble they invite.*

- **HYPOCRISY.** One of God's many messages that I wasn't able to squeeze into the body of this Notebook was a strong statement against hypocritical world leaders and social policy. In the body of the main Notebook story, we witness God (in my curtain) exhibit all of the worst curtain behaviors; going against all that He Commands and instructs. This was a sweeping statement against hypocrisy. But hypocrisy is a broad idea, which covers both tiny and giant infractions. So here are a couple examples of hypocrisy which may call God's attention when His *Prophecies Against* begin.

**Mexico.** Two months after I arrived in Mexico, an acquaintance told me immigrants cannot legally work in Mexico. Shortly, thereafter I saw a bunch of news reports where Mexico did not appear welcoming to immigrants. If these things are true, hypocrisy can't get much worse than this.

I grew up in California, USA, where, by the time I was a young adult, there was probably over a million Mexican immigrants, and millions more around the US. Mexican immigrants made the US so much better, more productive and wealthier. For a nation to rightly take advantage of their right to go to another country to pursue opportunity and compete, as Mexico did, then turn and restrict immigrants into *their* land, is simply not right.

**The World Against Haiti.** Many nations, East and West, have been impacted by Western Sanctions and isolation. The most powerful of these nations, in the East and Central and South America, have spoken out against Western abuses. But maybe no nation has been more impacted by the Western isolation than Haiti. Yet, as far as I know, no Eastern, or Central or South American nation has reached out to help Haiti break out of isolation and enter new markets.

- **Survival Basics.** If you live in the northern and central US and are reading this before January 7<sup>th</sup>, 2026 (Gregorian), and looking for some tips, here's my best basic advice (although I am **not** a survival expert):

1. First, try to be **50 to 100 miles from any large or medium sized US city when the Event** (the One Hour War) **occurs**; further is even better.
2. Because the Event will happen in December, when it is very cold, try to **pack warm clothes**; then you are probably going to want to go as far south as possible, to the warmer states.
3. Try to get a good amount of **matches or a lighter** (campfires, cooking), ASAP.
4. It is best to **get going as soon as possible**, because after the Event happens, the US power grid may not work, AND many businesses will be closed, and it's uncertain if any businesses that are open will honor the US dollar (which will almost certainly be worthless outside of the US). This means **it may be impossible to get gas and other supplies after the Event**.
5. Because of the cold weather and other variables, one of the best possessions you can have is **plastic tarp** (maybe 8'x6') to cover yourself, if you meet rain or snow (and don't have a car or sturdy tent). Keeping dry will be a chief battle. Putting your clothes in doubled plastic bags, then putting them in your backpack (or whatever you use to carry your clothes) is a good idea.
6. **Once you get to warmer land, traveling near water sources (rivers) is wise**, as the water will attract animals and may contain fish (food), and there is invariable more firewood near water.
7. If you must walk in snow, wearing several pairs of sox with doubled plastic bags over the sox, inside your shoes, can prevent your socks from getting wet.

- Some of you may have noticed Adrian Dilley, the PE teacher revealed to have had butt-sex with 400 underage high school students (apparently all boys) in chapter 7.33, was positioned among the better actors in chapter 12 (The Gehenna Train), slated to enter Gehenna at level 4. This is instructive for parents everywhere. If a man makes a **non**-forcible sexual advance at a young person, female or male, who is over 13 years old, and that young person consents, in God’s eyes, it is not rape. Raise your kids to say, “No.” Rape -forcible sexual assault- where the perpetrator overpowers the victim, is another matter. If Adrian had overpowered 400 boys or girls, he would have been positioned a few levels lower, in chapter 12.

God’s law, in many areas, seems to parallel nature’s (Natas’) law, and views people who are over 13 as accountable for their actions –thus, *adults*, in most respects. But the West has advanced the idea that *young people who consent to have sex (or butt-sex) with someone who is older -and not legally allowed to have sex with someone under 18 years old- are not responsible for their actions; rather, they are “victims,” whom we should feel sorry for.* This creates a situation where Western young people, 13 to 17 years old, may feel they can get away with anything.

- **THE MEANING OF 11...** December 24<sup>th</sup>, 2025, I published *The Shroud of God*, which explained that God predicted I would get the correct One Hour War date on my 11<sup>th</sup> prediction. That passage from *The Shroud of God* (with a reference to my birthday added on Jan 6<sup>th</sup>, 2026 –Gregorian) is pictured in the blue frame below.

#### God’s Prediction

In *Revelation 2: The Solutions*, I demonstrate that in Revelation, God used the *Four Living Creatures* and the 24 Elders to assign me the primary numerical identity **4** (and secondary identities: 2, 24, 44...). In Chapter 1, the word “seven” first appears at verse **4**, and is used **11** times in Chapter 1. God and Jesus say *the Alpha and the Omega...the First and Last* (or *Beginning and End*) four times in Revelation –including at verse 1:**11**. Chapter 4 (where the Four Living Creatures and 24 Elders are introduced) has **11** verses. The Elders (24 Elders) are mentioned **11** times in Revelation. I take these things as God predicting I would correctly predict the date of His One Hour War on my 11<sup>th</sup> -and final- attempt.

11 connects to the fact that on the Julian Calendar my birth date is September 11<sup>th</sup> (not September 24<sup>th</sup>). The meaning of all this is explained in the “Notes” section of STSN.

The reason God made all of these connections to 11 (and got me to notice my birthday, on the legitimate Western calendar, the Julian, is September 11<sup>th</sup>), and the reason God, in *The Wagers*, emphasizes his ability to turn back time (although Revelation and *The Wagers*, both, show God can just as effortlessly move time forward) is God wants nations to return to the Julian calendar (any legitimate improvements added to the Gregorian, can be added to the Julian). In doing so, nations will have to go 13 days back in time.

- The reason Satan persuaded the West to add 10 days to the Gregorian calendar in 1582, and added another 3 days over the next 318 years, was to make God's extremely accurate Julian-calendar-based predictions (which predicted events down to the hour of the day) inaccurate, by shifting the world to a new calendar system.

- In the Prophecies Against period, it is safe to guess that nations outside of the US, which chose to use dollars rather than developing their own monetary systems, will experience difficulties, as the US dollar is apt to be worthless after the One Hour War.


- I believe the reason God chose to start the final major Revelation Wager (*The Beast Wager*) on Christmas, 1888, is because on leap years, like 1888, Christmas falls on the 360<sup>th</sup> day of the year. 360 features Natas' numbers (3, 6) and is divisible by them. 360 is also divisible by Jesus' numbers (5, 8). And 360 represents one full circle, which can represent God. 360 also is divided by Satan's primary numbers (6, 3), and can represent the 360-degree cipher Gardner used (seen in *The Zodiac Killer's Identity Revealed*). Thus, 360 can represent Satan's War Against God –and against God's Family. A few more interesting related facts/dates:

- *The Wagers* explains Satan viewed the 137 year Wagers as running for 50,005 days ( $365 \times 137 = 50,005$ , minus leap years). Thus, Satan viewed the final Wager as ending November 21<sup>st</sup>, 2025 (Julian); December 4<sup>th</sup>, 2025 (Gregorian).

- It is certain that God did not allow Satan's *future-vision* to see the true date of the One Hour War. Thus, I believe Satan's future-vision stopped at November 29<sup>th</sup>, 2025, on the Julian calendar, the 333<sup>rd</sup> day of the year (Natas' primary number is 3); or December 12<sup>th</sup>, on the Gregorian. Satan would have been satisfied with this, as he improperly viewed the Wagers as ending 8 days earlier: 11/21/2025 (Julian), or 12/4/2025 (Gregorian).


- I believe 360 and God's emphasis on 17 (1 and 7) refer to Genesis 17 –the *Circumcision Covenant*.


- **THE (POSSIBLE) REASON GOD POSITIONED THE ONE HOUR WAR ON THE LAST DAY AND HOUR OF THE WAGER...** (This is theoretical.) China and the East initiate the One Hour War at 11pm, the last hour of the last day of the Wager(s). God may have done this because He expected the East to have the courage to liberate the world in the final hour of the Wager. This would be in agreement with nature (mankind saving themselves). However, in the unlikely event that the East failed to act, in the next few hour, with the wager officially over, God would be free to seize all necessary weapon-launching systems, and liberate humanity, Himself. In this unlikely scenario, Satan would be permitted to run free on Earth (but without a "beast" minion), probably until life on Earth ended. In this scenario, God would likely punish nations more firmly, in the Prophecies Against period, for failing to stand and defend themselves..



- God inserted at least two giant expressions of  $E=MC^2$  in the Elder Badge, to confirm Einstein's theory of Relativity was meaningless. Satan used the  $E=MC^2$  to prove he and his Western press could dictate what even the greatest scientific minds believed.



The true meaning of  $E=MC^2$  is  $M$  (13) times  $C$  (3), which equals 39; squared ( $39 \times 39$ ), which equals **1521**. 1521 is the year Satan began to divide God's Western Christian Church, in the **E**dict of Worms. **E** = 5 (Jesus' primary number) and **E**dict and 13:**5** -the Revelation verse that first speaks of Satan and Martin Luther's attack on the Church. **E** also equals **1555**, the year God's Church was officially divided (referenced in Revelation 13:6).








- *Big Bang* Theory is also fraudulent nonsense.
- Disproving widely accepted scientific theories involves more than tracing obscured image lines (although the fact that God made the images makes my position unbeatable). I disputed the Big Bang as trash in past publications, and have long been suspicious of Einstein's fake Relativity Theory. It occurred to me that God may have addressed these bogus theories, concocted by Satan ( $E=MC^2$ ) and Gardner (*Big Bang*), in the Elder badge...
  - The human beasts (Gardner and Malone) could/can only hear and respond to Satan when they were on Stanford University grounds. This is why John W Gardner and John C Malone both lived on Stanford grounds. I believe this was a punishment imposed on Satan sometime between 1968 and 1981.
  - People should understand how corrupt the US's encouragement of stock gambling was... Satan knew which stocks would rise a year in advance, so he instructed 666 business leaders (through Gardner and Malone) where to invest. Thus, 666 members made hundreds of millions of dollars, and looked liked geniuses, as they corruptly stole the common people's life savings.

- In the Elder Badge, God gives us clues about Satan's appearance (see *Dog Vision*, BtL #vii), and indicates Satan's head is shaped sort of like an upside-down triangle. God gives us a more accurate image of Satan, hidden across the Elder Badge's central image area, above. As we'd expect, Satan's eyes are locked on the Elder. As for Satan's grotesque appearance, in Ezekiel 28:1-19, God depicts Satan rise, as Heaven's most beautiful angel, and his fall –becoming grotesque (Ez 28:19). In the larger image, above, on the left, God included a smaller confirmation image.

The smaller representation of Satan (below, left) is flanked by Gardner on the left and Malone on the right (below, center), and their initials (below, right).



## UNFORGIVABLE CRIMES HISTORY

If you read *Revelation 2: The Solutions* you might get the impression God kept the Unforgivable Crimes hidden from public view for thousands of years, until I showed up and revealed them. That's not the case –well, it might be true for the *Image Crimes* –which didn't come into existence until the 20<sup>th</sup> century. But many of the Mark Crimes concern things like administering justice fairly, and not publishing false information, not offering or accepting bribes, fighting poverty and misfortune, not oppressing or mistreating foreigners... But all of these things, and much, much more were addressed from the start, in the first 5 books of the Bible. What follows are just few examples, just from the Book of Exodus.

### Do Not Publish or Spread False Information

**Exodus 23:1: You shall not circulate a false report...**

**Exodus 23:7: Keep yourself far from false matter...**

### Administer Justice Properly and Fairly

**Exodus 23:3: You shall not show partiality to a poor man in his dispute.**

**Exodus 23:6: You shall not pervert the judgment of your poor in his dispute.**

### No Bribery

**Exodus 23:8 You shall take no bribe...**

### Be Kind to Immigrants

**Exodus 22:21: You shall neither mistreat a stranger nor oppress him, for you were strangers in the land of Egypt.**

**Exodus 23:9: Also, you shall not oppress a stranger...**

### Make Adequate Provisions for Fatherless Children, Widows and Unmarried Women

**Exodus 22:22-24: You shall not afflict any widow or fatherless child...**

**If you afflict them in any way... I will kill you with the sword...**

# Between the Lines

## The Enemy on the Inside:

### How the West Uses Freemasonry to Degrade Foreign Lands

Satan is engaged in his War Against God. One of the primary ways Satan expresses this is steering as many nations as possible against God, knowingly or not. Accordingly, since God instructs mankind to treat other people and nations fairly and reasonably, Satan uses his Mason minions to lead their people against that. Masons (or Freemasons) tend to be powerful and wealthy and not inclined to admit their affiliation with Freemasonry. By getting powerful businessmen, politicians and judges as members in his fairly small “church,” Satan can discharge his powerful minions to enact policies that have far-reaching and always harmful, impact.

In the 15<sup>th</sup> century, Freemasonry likely seemed committed to the enrichment of all of Satan’s elite Western European followers. But, at the end of the 16<sup>th</sup> century, Freemasonry shifted its center to the UK, the first step in a new divided ranking system, designed to upset everyone but Satan and Mason nations on the top tier.

Once the US came into existence in the 18<sup>th</sup> century, the UK and the US were on Freemasonry’s top tier. Very fair skinned Western European nations like Germany, Netherlands and France were on the second tier. Second, Western agents, who have no idea how independent economies are developed, will forever insist that economies that are not tied to the dollar will collapse. False. Nobody should be holding dollars right now.

Third, here in Hermosillo, Mexico, there's a Freemasonry lodge. I'm confident Freemasons and US tied interests are responsible for the problems I'll soon describe, but there is no smoking-gun evidence for or against this claim.

**Trash Part One.** I've been in Mexico for almost two years. One of the first things I noticed when I arrived in Mexico was the trash problem. Because of the lack of trash cans that are regularly collected, people often shove trash in the many vacant buildings, where it is never collected. There is a 300 pound pile of trash down the street from me that has been there for over a year. A few months after I arrived, I started to observe on the TV that seemingly everyday, certainly every week, a different large recycling plant somewhere in Mexico would catch fire. This went on for about a year. I'd guess this happened over 100 times. Once or twice they even showed film of people setting these fires at night.

**Trash Part Two.** This year there were terrible rains and floods seemingly everywhere in Mexico. The rains caused terrible damage and loss of life. My payers and sympathies to anyone impacted by the rain and floods. That said, the floods washed uncountable tons of trash into the streets and fields of Mexico, further revealing the terrible trash collection and recycling problem in Mexico.

**Roads** Many of the streets, roads and sidewalks in Mexico are in terrible condition, with giant holes. During the recent severe rains, giant sink holes opened under many streets. The high number of giant holes suggests some shortcuts may have been taken in building the roads.

### IN SUM

These problems exist because Freemasonry elites conspired to create the problems –primarily to make life in the US and Western Europe look advanced by comparison; secondarily, to glorify Westerners, by tacitly suggesting the high number of **non-Whites** in Mexico somehow caused the problem.

The **Solutions...** The *Trash Parts One* and *Two* sections indicate there's a poorly developed trash and recycling system in Mexico.
