TERMS



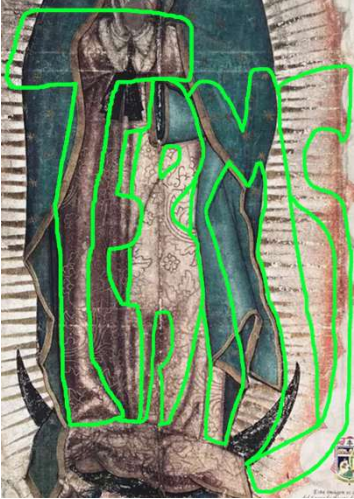
As you observed in the previous chapters, God uses the Elder Badge to verify all important matters related to Revelation, the Beast or me, and uses two or more images for verification. Above, the word “Terms” (with a giant capital *T*), is of the largest words found in the Elder Badge. Around the image above, God put two or three expressions of His primary identity number, 7, and at least two likenesses of Satan’s triangular head, adjacent to a 7. As the Elder Badge addresses matters related to me, the adjacent expressions of 7 (representing God – *7 Spirits of God*, and the *7 Churches*, *7 trumpets*, *7 stars*, *7 seals*...), and the adjacent representations of Satan, act to confirm that I, and my *Terms*, are connected to God’s Wagers with Satan.



The word "Terms" is also found in the Shroud of Turin, above.

The word "Terms" is also hidden across the center of *Nuestra Señora de Guadalupe* (right).

Terms

These are the participation agreement Terms of **Steven Kenyatta Briggs** (whose original and true family name is Yayayar; other names I am known by are included in the *Signature* section of these Terms), related to my involvement/participation in what appears to have been the final *Revelation Wager*, between God and Satan, which began on Christmas Day, **of the Julian calendar**, December 25th, 1888 (Julian), and ended on the final second of December 25th, 2025 (Julian); which on the Gregorian calendar was January 6th, 1889 to January 7th, 2026. These Terms can be referred to as my *Wager Terms*, although at no point, ever, have I wagered with God (or Satan or his beasts, etc).

- Note #1: I worked for God for over two years, selling my car and many possessions to fulfill my duties, before I realized He expected me to write “Terms” for my service. When I started working for God, I never thought about asking for some “reward” for the honor of being chosen to help God. But, bit by bit, my financial circumstances have declined. So, currently, I will take advantage of this chance to receive various payments, gifts or favors –for services I would provide God freely.
- Note #2: In early versions of these Terms (published Nov 22nd, 2025, to Jan 16th, 2026, Greg), in great respect for God, I avoided using words like “must” and “will” (which seem disrespectful), in favor of vague words like *should*. But more recently, I’ve surmised that God *wants* me to use accurate language in these Terms, as He is using these Terms for instructive purposes, including ***to instruct mankind to use clear language in their contracts***. Thus, I use the words “**must**” and “**will**”, herein.

These are the retroactive Terms of my participation in one or more Wagers between God and Satan, in which God predicted I would accomplish certain things, and Satan requested permission to harm me and prevent me from accomplishing those things, and God granted Satan’s request. Although God *may* have informed Satan that I would be allowed to enter my Terms later, retroactively, it is also possible (even likely) that Satan was unaware, and God unilaterally provided for these Terms, based on the laws of reason and fairness. In the *Book of Job*, we see God and Satan make private two-party Wagers (agreements), which impact Job. Thus, I assume Satan initiated a similar two-party agreement with God, involving me. Thus, these Terms are made with God, but unconditionally impact Satan and all of his *beasts* and subordinate actors, and potentially impact all of mankind, as involuntary parties, as explained in item #4.

Although Jesus is sure to help His Father execute these Terms, in the end, God is the party who must make sure all aspects of these Terms are fulfilled, and on time.

I have taken effort to write these Terms clearly and accurately. If any aspect is not clear, that aspect, and all others, will be interpreted to my favor and as I intended, and fulfilled to MY satisfaction and expectation. **God knows my mind and intensions.**

Should Satan or God prefer or require that Satan, or any subordinate parties, be identified as parties of these Terms, they and all other preferred or necessary parties are hereby made parties of these Terms –although much of or all of their terms will be nullified by portions of these Terms, particularly by items #5 and #8.

Some of the services I provided to and for God, Jesus (and Natas) were/are not related to Satan. Accordingly, some of the following items will reflect this.

All passages of these Terms, from the opening title, to the final word, and every bullet point in between, are enforceable aspects of these Terms.

As explained previously in *Steve's Top-Secret Notebook (STSN)*, to accelerate human evolution, and reduce the duration of one or more periods of great human suffering, God entered into a series of Wagers with Satan, related to His *Book of Revelation*. The Wagers pertained to God accurately predicting who would solve (or *sufficiently solve*) his *Book of Revelation*. God predicted this somewhere between 1,900 and 4,200 years in advance. I am the person God predicted would sufficiently solve His Revelation.



I was primarily an unwitting participant of the final Revelation Wager(s), which might properly be called *The Beast Wager(s)* (because the Wager gave Satan two human *beast* minions, in succession). Most of the details of the final Wager and the prior Wagers are not known to me. However, I do know:

1. Satan and his minions and/or their subordinate actors were allowed to do harm to me (although I believe acts of violence were not allowed), but they were NOT allowed to kill me, or to *try* to kill me.

From what I've pieced together, there were at least three major pieces to the original Wager, which are (roughly):

- a. Satan bet God that He (God) could not write a book of coded prophecy and revelation AND predict who would solve His Revelation, 1900+ years in advance.
- b. As the Wager permitted Satan to try to harm me, Satan must have had a Wager provision which required God to identify His solver (me), thereby allowing Satan to harm me –to try to prevent me from solving God's *Revelation*.
- c. Great attention appears to have been paid to the date of the One Hour War (the Destruction Date), as witnessed in my book *The Zodiac Killer's Identity Revealed*.

After God's *Revelation* was finally written and published, Satan appears to have made new Wagers with God, concerning Revelation's various mysteries and solutions.

During the Wagers, God gave Satan the ability to see all or most significant human events up to 274 years in the future, perhaps more. God also allowed Satan to see me, most of my life, and some portion of my Revelation solutions, over 200 years before my solutions were written, and approximately 177 years before I was born (see *The Wagers*, Wagers #3, #4, #6, #7). Because God allowed Satan to watch most of my life **in reverse** (Wagers #4, #6, #7), Satan was able to follow my ancestors back to between 1777 and 1820. Thus, during this period, we see slave selling and "breeding" in the U.S. explode. Once Satan saw my paternal ancestors were Black, and their true last names were *Yayayar*, he inflicted more punishment on Blacks, and killed some distant family members and possibly some of my ancestors. Thus, earlier in this Notebook, we see Satan's minions kill Randall Yayayar, Para Yayayar (an infant) Pamela Rossford, Harry Yayayar and Erica Corran. These attacks represent attacks on my family and race. Thus, my direct involvement in the Wagers dates back to around 1777 (the year God affixed His first set of badges on *Nuestra Señora de Guadalupe*).

At least one of God and Satan's new Wagers, entered into between 1777 and 2024 (most likely after 1888), focused on Mark Crime #18.

Although God and Satan may have had provisions to end the Wager(s) if one party cheated, I had no such option. During the final Wager, Satan and/or his Beast (John W Gardner) tried to kill me, in 1968 and 1993. I believe Satan's and his second beast, John C Malone, also tried to kill me once or twice.

THE TERMS

Based on the preceding, my Wager Terms, follow:

- All of the following items must be implemented immediately, or as soon as possible, or when specified, and in accordance with my intentions. If a date is specified, but not an exact time, God and Jesus can act whenever They wish, on that date.
- These Terms must not damn or punish (in the afterlife) anyone who is innocent.
- These terms cannot prematurely kill, damn or harm anyone named in items 29 and 31.
- It is only necessary to publish these Terms in one language.
- These terms only need to be signed once.
- Some of the following Term items have been fulfilled, and/or are no longer active, but remain in these open Terms for transparency and documentary purposes. I may remove and replace an occasional item, but will try to keep prior Terms posted online.
- Wherever necessary to make the following items Enforceable in my favor, the phrase ***“God and Jesus must and will...”*** can, must and will be added to the beginning of the item, or wherever necessary in the body of the item(s).
- I ask readers, God and Jesus to preface each of the following item with the word **“please,”** and my deep gratitude, as God provides each item as gifts of His Will, and not at my command, and I would be honored to work for God freely, all of my days.

Terms

1. My Wager Terms must and will supersede all other Wager terms entered into by God, Satan and/or either of Satan’s beasts (John W Gardner and John C Malone), and/or any related terms entered by any other unknown Wager participants.
2. These Terms are “adjustable”, and all aspects, including Satan’s punishment, can, must and will be altered in perpetuity, as I see fit –without negotiation. Any changes must and will be accepted by God and Jesus, and implemented and enforced to my satisfaction, immediately. The concept of *adjustable* contracts comes from contracts introduced in the US, which made the terms of certain home loans (which the US primarily offered Blacks and minorities) unexpectedly change, after a couple of years, in favor of the banks. Thus, suddenly homebuyers’ monthly payments doubled or tripled; forcing the buyers to lose their homes.
 - God’s Wager with Satan is related to the Guadalupe/Juan Diego story –where God showed He is familiar with occasional contract term revisions.¹
3. No other party in this agreement can have or submit terms that are *adjustable*.
4. These Terms contemplate **God** and **Satan** and me (Steven Kenyatta Briggs, AKA Steven Kenyatta Briggs Yayayar...) as the **Primary Parties** of these Terms. These Terms contemplate John W Gardner and possibly John C Malone as **Secondary**

¹ In the Guadalupe/Juan Diego story, we understand, in the back-story (1) Mary agreed to be the representational mother of Jesus; (2) God fulfilled all prior Terms 1500 years earlier. Yet, Guadalupe/Mary is suddenly found asking Juan Diego to help her get a Church in her name –for being an excellent mother (which God certainly expected from the beginning).

parties, who are included under Satan. These terms contemplate any human party who executed or carried-out a direction or suggestion that originated with John W Gardner or John C Malone or Satan, that was in any way harmful to me, or harmful to any basically good person, or clearly unwelcome by me (e.g., spying on me via direct observance or second party interviews; hacking into my computer, phone or cable-box...) as a **subordinate party** to these Terms. Satan and his Secondary parties, Gardner and Malone, are allied under these terms, and subject to the major punishments described herein. All **subordinate parties** must and will be punished as directed, herein. Satan, Gardner, Malone, their allies and subordinates profited, and made hundreds of millions (likely billions) of people *involuntary parties* to their corrupt contracts, by bribing businessmen, judges and statesmen to take secret actions that they would not take otherwise. These bribes, improper campaign donations, etc, were contracts –agreement to receive benefit in exchange for action. Because these subordinate parties’ corrupt contracts adversely impacted my life, and the lives of millions who were also not parties to those contracts (or “involuntary parties” to those contracts), all such subordinate parties are hereby made parties to these Terms, and must and will be punished as described herein, or in such manner that God and Jesus determine is just and fair. Just as God’s Wagers with Satan made much of humanity “involuntary parties”, these Terms make much, most or all of mankind “involuntary parties”.



Mystery Question #15: Why would God allow Satan and me such great power, based on a Wager?

SOLUTION: I believe God had two major objectives here:

- I. The West used countless corrupt contracts, for centuries, to imperil the lives and spiritual fate of millions, possibly billions, who were not parties to those contracts. **God used *this one open contract to undo that spiritual risk.***
 - II. By making everyone *involuntary parties*, who may face severe consequence for their leader’s misdeeds, God is instructing all people to be politically active, and be sure their nation’s laws are sound, and make sure their leaders are ethical and competent; if they are not, hold them to account.
5. PART ONE: Any entity who is not named in item 4, and who is not known to me, who may have previously been an unnamed party in the Wager(s) is hereby no longer a Wager party, until and unless they are revealed to me, and their Terms, and I am given time to update these Terms to nullify their terms. PART TWO: I can never again be entered into a Divine Wager/Agreement, unless I am asked beforehand, and get all Wager details, and unless I agree to participate.
- In these Terms, Satan, Gardner and Malone are the *executor* of any action they order (if they order a murder, they are, effectively, the murderer).

- Gardner and Malone were the hands that fulfilled Satan’s wishes against me. Hence, any time in his post-human-life that Malone is not in the Lake of Fire, must and will be spent doing the same punishments, described herein, as Satan and Gardner.
- 6. My Wager Terms *adversely* apply to Satan, John W Gardner and John C Malone; meaning, my Wager Terms are intended to harm Satan, Gardner and Malone. This means, unless so stated, these Terms CAN NOT be construed in any way that is helpful to Satan or Gardner, OR in any way that brings injustice to God’s universe.
- 7. My Terms are intended to help justice, and can be modified to the liking or needs of God, Jesus or Natas, provided those modifications do not (1) promote injustice, (2) adversely impact me, or (2) harm someone I sought/seek to Save. But, if a modification seeks to reduce Satan or Gardner’s punishment, I must first be consulted, and no change will be implemented without my agreement –unless so provided under another item herein.
- 8. After the moment I sign these Terms, across space and time, God and Jesus must and will see to it that no party to God’s and Satan’s Wagers has any active Wager term that I do not or would not like, or that I disagree with, or that negatively impacts me. If any such term had existed, it is hereby nullified.
- 9. In these Terms the word/name *Satan* applies to the Biblical figure/villain known as Satan, Lucifer, the Accuser, the Dragon, the Serpent... And the term *Beast, beast, Beasts* or *Beasts* apply to either or both John W Gardner and/or John C Malone. “Gardner” refers to John W Gardner. “Malone” refers to John C Malone. All of these parties may also be referred to as *convicts*, etc.
- 10. God and Jesus must and will see to it that any primary party of these Terms who does not understand any part of these Terms consults me, through God or Jesus, and that passage must and will be clarified to mean anything I want it to mean.

Concerning Satan, Gardner, possibly Malone, etc.

WARNING: This section describes punishment methods that are considered *torture* outside of Gehenna (Hell). The methods God and Jesus Authorize for Gehenna are not suitable for any prison on Earth. Portions of chapter 6 and chapter 14 specify that leaders, guards, etc, who mistreat prisoners, POWs, etc, by using Gehenna methods, or any methods described herein, or any cruel punishment (e.g., food deprivation, beating, scaring, intimidation, humiliation, parading prisoners about to send *anti-crime* social messages, etc) not authorized by law and reason, will be sentenced to Gehenna (Hell).

- 11. Neither Satan, nor his beasts, nor any subordinate party that Satan’s beasts deploy or contract, can *try* to kill me during the course of my life on Earth, from September 24th, 1964, forward. (I’m confident this was a term of Satan’s Wager with God; if not, it is now, and it is hereby retroactively applied.)

12. God and Jesus must and will see to it that if Satan or Gardner or any subordinate Wager party attempts to kill me during their Wager(s), or after their Wager(s) ends, that/those party(s) has thereby and hereby lost any and all portions of their Wager(s) (including all previous Wagers) that God, Jesus or I wish for him/them to lose; and, where beneficial to God, they (Satan, Gardner...) have thereby/hereby won any portion(s) of the Wager(s) that God, Jesus or I wish for them to win.

NOTICE: The punishment described in items #13 through #19 may be greatly altered, or stopped, by item #78. Items #13 through #19, and other items impacted or ended by item #78, remain in these Terms for clarity and documentary reasons.

You may be troubled by some of the following seven interventions (items #13 to #19), put forth by me, a person often preoccupied with kindness. Perspective is in order... God never told me about the Terms. In mid-2025, after withstanding months of pretty harsh treatment (outlined, to some extent, in *My Stepdad Was One of the Zodiac's Santa Rosa Hitchhiker Murderers*, and the "Post" section of *Killing Guadalupe*), and learning that, as part of a Wager, God allowed Satan to inflict non-stop harsh treatment on me for over 55 years, eventually I reasoned that God must have intended that I counteract Satan's actions and terms with my own Terms. When I later looked in the Elder badge for evidence of my Terms and my right to enter them, I found that evidence, and I found more evidence in *The Shroud of Turin*, and *Nuestra Señora de Guadalupe*, and the *Candelaria Likeness*. In my Revelation (and revelation) work for God, over the past two-plus years, I've learned that He virtually always has multiple meanings, purposes or higher messages in his revelations. Ergo, as I view my Terms to be part of God's revelations, I reasoned my Terms should also have a higher purpose, etc. But in writing items #13 through #19, which most forcefully punish Satan, I wasn't sure what God hoped to achieve. My best guess was that God wanted my Terms to act as a model for the nations that Satan and the US/West victimized, for generations: to retaliate against every crime inflicted upon them. Still, I wasn't sure. Satan harmed me for about 59 years; but he harmed the world for at least 4000 years. So I wondered: "*If my Terms come to public awareness, and...*

- a. *I use them to respond at a lower level, to counter the harm Satan did only to me, will many of the millions or billions of people who were harmed by Satan feel as if I failed them?, Or...*
- b. *...If I respond at a higher level, to counter the harm Satan did to millions or billions of people, will I grossly exceed what is reasonable, or expected, or what Jesus would view as appropriate?*

So I opted to take firm action, between the two extremes. With this explained, in the following items, #13 to #19, you will read punishment ideas that are not suitable

for any human, anywhere on Earth; but likely very well-suited for a demon king in Gehenna (Hell).

13. If Satan or Gardner or any subordinate party attempts to kill me during the course of God and Satan's Wager, or after the Wager(s) ends, or if they attempt to kill me AGAIN (a 2nd, 3rd or 4th time): (1) ALL of the consequences that I invoke in these Terms upon Satan and Gardner (and Malone, if he is not in the Lake of Fire), and any other party, must be doubled upon that party(s); and (2) if they try to kill me a 2nd, 3rd, 4th time, then ALL of the previously doubled consequences must be doubled AGAIN, for each murder attempt; and (3) God is "further" freed from any and all prior Wagers/contracts with that party, except those contract elements God wishes to continue and observe (under this provision, only God and Jesus' preferences will be considered and upheld); and (4) once every 24 hours, the convicts (Satan, Gardner) must either say, "I was so stupid to think I was smarter than God," or, "I was stupid to underestimate Steve Kenyatta Briggs" (or they can substitute the name "Steve Kenyatta Briggs Yayayar"). If they fail to say this in a 24 period, time must be suspended where they are, and they must spend an hour in a specialized Gehenna-like area, where they must endure heat temperatures that are halfway between level 10 of Gehenna and the Lake of Fire.

- The body to be used for the highlighted portion of #13 is provided under item #14.
- In addition to trying to kill me somewhere between 2 and 4 times (maybe more), in chapter 7 of STSN, God revealed Satan and Gardner violated the rules, and began their attacks on me when I was only 2 years old *–before* such Wager attacks were permitted. I believe God revealed this as a nonverbal direction for me to use His revelation as a basis to counter all actions Satan and Gardner took against me, my family and race, BEFORE I was born. I do so in items 24 to 26.
- God revealed a situation where Satan and Gardner appear to avoid consequences for somewhere between 1000 and 1400 years, as they sits in the Bottomless Pit, tormenting minds in Gehenna. These tremendous delays represent a gross miscarriage of justice. In the *Notebook* body, I described God's efforts, in certain form, to delay my work. God utilized these delays to get me to notice and undo (or counter) Satan's terms. Thus, from the moment Satan is sent to the Bottomless Pit, to start his Gehenna torment services, Satan and Gardner must do the following (items 14 through 19):
- The following 5 items (#14, 15, 16, 17, 18) honor Jesus, whom I believe plays a far larger role in governing our next lives than people understand. Items 14 through 17 are intended to last between 36 and 60 minutes, **each** (in 24 hour cycles where item #18 is not utilized), and combine to cover 3 to 4 consecutive hours.

14. PART 1 (Time): 12 consecutive hours of every 24 hour cycle of Satan and Gardner's time in the Bottomless Pit and/or Gehenna must be governed by my Terms, and the remaining 12 hours governed by God's previous terms -unless God chooses to update those terms based on His right to do so under provisions in these Terms. **PART 2 (Remote Physical Bodies):** Events in Revelation (9:11, 11:7, Chapter 16, and 20:3) indicate Satan and possibly Gardner's souls will be kept in a spiritual form in the Bottomless Pit, without "conventional" physical bodies. Thus, Satan and Gardner must be provided with separate human-like physical bodies, to be kept in Gehenna or wherever God deems best, to remotely experience the consequences described in this section. These separate bodies' accurate responses to stimulation, pain, sight, sound, smell etc, must be transmitted to -and be overwhelmingly experienced by- Satan and Gardner's remote spirits, in the Bottomless Pit, and must be the only incoming physical sensations they experience, for the 12 hours governed by these terms (except for any sensations necessary to fulfill their torment/psychological services). Because Satan and Gardner are disgusting sexual deviants, their bodies must not have genitalia or an anus. The bodies must have clothing over the abdomen, groin and buttocks; but the head, neck, arms, lower legs and feet must be exposed. God and Jesus can change the clothing as needed to suit the punishments. Their bodies must not be able to make any attack or defensive motions, or flee. The bodies' size should vary, according to the punishment (for example, in Part 3 of this item, the body may need to appear small, so as not to threaten any soul in Gehenna). The mouths on the faces of these bodies must not be able to open or speak when they are in public view. **PART 3 (First Break Punishment):** Once every 24 hours, during the first 36 to 60 minutes of a **3-4 hour torment break** that the souls of Gehenna must get (which must coincide with time Satan and Gardner are on my schedule), hundreds or thousands of condemned Gehenna souls must be invited spit on Satan and/or John Gardner. [****NOTE #1:** If possible, as many Gehenna souls must also be invited to urinate on Satan and Gardner, in some Divine manner that allows the Gehenna souls do so privately. **NOTE #2:** Although it may not have been intended that souls in Gehenna should expectorate (spit) or urinate, allowing this, solely to punish Satan and Gardner, is just. If this is not allowable, I must be allowed to replace this punishment with something comparable, or worse.] To accommodate this, God and Jesus must make Satan and Gardner's bodies appear before hundreds or thousands of condemned souls at the same time. Satan and Gardner's remote bodies must then soak in spit and urine for what remains of the 36 to 60 minute period. The spit should be infused with actual germs. At the end of this period, the bodies must be dipped in a painful alcohol-like disinfectant.

15. Under Satan and Gardner's leadership, the US/West tortured non-White prisoners of war and non-White *citizens* "suspected" of having committed crimes. Modern US/West torture methods include(d) water-boarding, beatings, electric shock, sexual humiliation, hypothermia, loud music, sleep deprivation... Thus, Satan and Gardner must experience either one of the torture techniques referred to in Revelation 9:3-11, or one of the US/West's preferred torture techniques.
16. Because Satan and the US tried to make digitizing souls a reality, on alternating days, Satan and Gardner must be placed in a *rehab replicator/accelerator* for 36 to 60 minutes, which must simulate one week (7 days), and it must feel like 7 days elapsed. In the replicator, Satan and Gardner, without genitalia, must face different unpleasant challenges. If, in the replicator, they refuse to pursue the challenge, they must be beaten severely and sent to **digital Gehenna**, level 10.5 (where they must experience excruciating heat, halfway between Gehenna level 10 and the Lake of Fire), for 12 hours or so, until the next day in the replicator begins. In the rehab replicator, Satan and Gardner must face such challenges as: *being a creative non-White person in the US, in the Satan/Gardner era (1937 to 2000), who must struggle to earn rent money in two days, without committing a sin, or face homelessness; meanwhile, replicator-Satan (i-Satan) and replicator-Gardner (who rule the replicator US) must try to sabotage their progress –and be careful, if you sin, you go to replicator Gehenna 10.5 for the rest of the day.*
17. **Strychnine & Police Murder.** FACT #1: Satan and Gardner directed Dennis and David Wilson to try to kill me with strychnine (and atropine) when I was 4 years old. Strychnine is an extremely painful way to die. Fact #2: Under Satan and Gardner, US minorities, women and children were murdered by corrupt police, who were profiled and paid (bribed) to kill them. Thus, **for the first of two consecutive intervals of 18 to 30 minutes**, Satan and Gardner's Gehenna bodies, separately, must be beaten to death by souls acting in the roles of police. The convicts' Gehenna bodies must be revived immediately after the punishment. This punishment could alternately be done in the replicator/accelerator. Souls condemned to Gehenna level 8, 9 or 10, who have lost their humanity, but hate Satan and Gardner for misleading them, would be great candidates for beating Satan and Gardner to death, and they could earn a 12 to 24-hour *heat break* for administering the punishment. **For the second interval of 18 to 30 minutes**, Satan and Gardner's bodies must be **killed by strychnine injection**.
18. Satan and Gardner committed 44 Mark Crimes against me, daily, for 34 years. Many of these Unforgivable Crimes were executed as skits and dirty tricks, to get me to believe false things. Satan, Gardner and the US carried out similar dirty tricks on the world. Accordingly, to honor Natas, one out of every 3 days there

must be a *dirty trick* done to Satan and Gardner –and one of the punishments described in items 15, 16 or 17 must be a false/fake punishment –just a skit or a dirty trick; thus, Satan and Gardner must repeat that punishment.

- Item #19 explains how 8 of the remaining 8 or 9 hours of Satan and Gardner’s daily punishment routine, governed by my Terms, must be spent.
- 19.** Satan and Gardner must experience 4 hours of Gehenna level 8.5 heat, while they torment souls in Gehenna. Either their souls in Gehenna can feel the heat (if God prefers), or their separate bodies in Gehenna. If the convicts say, “I was so stupid to think I was smarter than God,” the heat must be reduced to level 8. Next, Satan and Gardner should experience 4 hours of cold, while they torment souls in Gehenna; the temperature should be 32 degrees Fahrenheit (0 Celsius), as experienced without a jacket (just as Gardner had me deal with cold, without a jacket, when I was in 4th and 5th grade). If the convicts say, “I was stupid to go against Natas,” the temperature can be increased to 36 degrees. If, during this 8 hour period of *thermal* punishment, there is a noticeable decline in the quality of tormenting services Satan and Gardner were contracted to provide, at the end of the 8 hour shift, God must suspend time, and the convicts must spend 1 to 8 hours (based on the severity of their performance decline) in an actual heat zone that achieves temperatures halfway between Gehenna, level 10, and the Lake of Fire.
- 20. PART A:** Satan (1) must never again gain access to, or influence over, the mind of any being, living, supernatural or un-living (ghost, etc), and (2) must NEVER again be permitted in my home/residence/shelter, or within 160 feet (48.8 meters) of my home or any building I’m in, (3) must never again disturb me –in any way (making noises, or causing others or animals to make noise, etc). Additionally, when I leave my home, Satan must not come within 40 feet (12.2 meters) of me. If Satan violates any portion of this item, he must immediately spend 24 hours in Gehenna, level 10, in isolation. On his fifth violation, Satan must be removed from Earth, for no less than 500 years, and begin his sentence in the Bottomless Pit.
- PART B:** Most of these Terms only contemplate Satan’s crimes against me in Earth’s current known timeline. Under this item, #21, Upon my resurrection, God and/or Jesus or one of their appointees must inform me of all of Satan’s substantial crimes against me, in this timeline, and in any actual alternate timeline(s), and his crimes against my alternate timeline family. Then, I must also be informed of the consequences Satan currently faces. If I am not satisfied that Satan’s consequences contemplate his crimes in all actual timelines, continuing or truncated, in which I once existed, I can then alter and greatly increase Satan’s consequences, anyway I wish, to reflect Satan’s crimes in other timelines. If necessary, Satan’s soul must be resurrected and punished, until I am satisfied.

21.NOTE: Below, this item describes my sincere effort, April 2026, to use my Terms to avoid God's punishments. God likely utilized the minor punishments described below to get me to try to use these Terms to restrain Him. I tried. God did not comply. God's first message here is: God is God, the Father of all; and when He sees bad behavior, as a dutiful father, He is apt to intervene and punish. I believe God's second message is a reminder: He gave us law and contracts (Covenants, Wagers...) to model civility and help us shape laws that improve our lives; and as the Hand that enforces all contracts He enters, He would not let my Terms prevent him from doing His job. [In support of this revelation, remember: God punished Satan severely -switched his Beast- during the Revelation Wager(s); but God allowed the Wager to continue.] Item #21 WHICH IS NOT ACTIVE, but included to edify, follows.

In the time since July 2024, when God first entered a curtain in my living area and began very limited communication with me, using simple curtain motions (gestures) and sounds, His behavior has become increasingly intolerable (...His gestures are very unkind, and His flopping sounds are deeply irritating). To get God to stop these behaviors, I used these Terms to free him from any term conditions that may have been in play in His Wager(s) with Satan. Yet, God has not stopped –even after I have asked Him to stop hundreds of times. I suspect God refuses to stop either (**Option A**) to communicate that my punishment of Satan, described in my Terms' items #13 to #19, are too firm and create injustice against Satan [NOTE: on January 31st, 2026, Gregorian, in my article "*In Response to a Petition From the Demon King*," on page 8, after Satan appeared to have no access to cash, in a mock trial situation, I argued that Satan should not be punished because he was unwittingly used, by God, to greatly advance God's Will; thus, God likely displayed these behaviors toward me in representational defense of Satan; a statement that nations must see to it that people without means to defend themselves are still properly represented in courts of law] or (**Option B**) because He wants to demonstrate that a good man, like a good God, will always fulfill His contractual duties, even if they are not legally required to do so. So, to eliminate *Option A*, and guard against injustice to Satan, I added item #77, which allows God and/or Jesus to eliminate or modify any aspects of items #13 to #19 They view as unjust, etc. However, we should remember that I was an involuntary party in the Wager(s); thus, it can be reasoned that God futhers injustice by displaying these behaviors toward me. Hence, from this point forward, each time God displays an unjust curtain behavior (angry or unkind forward gestures, loud flops...), He must also unjustly demote two angels, two levels lowers; and upon every fifth unjust behavioral display, God must end the life of a valued angel, who wished to live much longer and do great things; thus, if God continues these unjust displays, we can reason that God is unjust and does not value the lives and feelings of humans in this life, or angels in the next. [Note: I welcome these behaviors from God, sometimes; but not nearly so often as He has displayed them in the past few months.]

Antagonists

- 22. PART A:** After decades of spying on me, sabotaging my efforts, and stealing my wares, over the past three years, many times, Satan and Malone (and Freemasonry and the 666) have sent people to try to intimidate me –and their minions have continued to spy on me, and deployed others to make a great deal of noise, etc, to disrupt my focus and sleep. **Henceforth**, God must immediately kill anyone who moves to kill, hurt or intimidate me (or deploys others to do so), long before they get near me. God or Jesus must also immediately kill anyone who spies on me, or who deploys others to spy on me, via technology, observation or third party, or who tampers with my internet/communication services. **ADDITIONALLY**, God or Jesus must immediately or very quickly (within 14 days) kill or severely debilitate (for no less than 36 days) anyone who pays, asks, orders or bribes anyone else to disrupt my sleep, or to sabotage or disrupt me (such as sending people to play loud music near my home, or deliberately tampering with or cutting my water supply, or monitoring what products I buy and increasing the price of those items). If one of the offenders has a dependent child, 17 or under, God or Jesus can use any non-lethal but effective and punitive intervention They wish (but on and beyond the offender’s fourth infraction under this item, God and Jesus must double the punishment). **PART B:** As I believe many of these offenders are Satanists and Freemasons, wherever I am in the world, God and Jesus must immediately strike any and all forms of Satanists and Freemasons who come within 55 feet (16.8 meters) of me with excruciating and debilitating headaches, until they move outside of my perimeter. This perimeter must extend through walls.
- 23.** God or Jesus must immediately reverse, debilitate, incapacitate, or worse, any official, police officer, etc, who moves to take action against me that is not just (in God and Jesus’ eyes –and in mine) and/or that would not be welcomed by me.

Related to Nations

- 24. PART ONE.** Because Satan took his war against me roughly 200 years back in time, to 1777, and increased suffering on Blacks, everywhere (especially in the US), all subsequent Blacks who were born into hardship must be given up to a **5-level boost** (thus, people who were slated to go to level 4 of Gehenna, can land on the ground floor in Heaven). This intervention should extend back 410 years (205 +205= 410 years), because there are places in the Bible where repayment of harm is doubled. Taking the consequence back to the beginning of European enslavement seems appropriate. Also, under this item, any slave who killed his captor, seller, owner, is exonerated. Many other non-White groups were persecuted and faced extreme difficulty and genocide at the hands of colonizing Western Europeans (such as the Aztecs and most indigenous people of the

Americas, and the people of China and India, the indigenous people of Australia, and China after it was conquered and divided in the 19th century; and in more modern times, nations like North Korea, Iran, Palestine, Cuba, Haiti, Venezuela, all faced debilitating Western interference and sanctions...). Thus, all non-White people who faced substantial adversity caused by colonization, or post colonial oppression, must be given up to a **5-level boost**. And any oppressed colonized subject who killed a party who was complicit in their subjugation is exonerated.

- I learned of God and Jesus' actual use of Purgatory while working on *The Candelaria Code*. Items 25 and 26 utilize this pre-condition.

25. There are also, of course, White nations, like Russia, that showed great perseverance in the face of isolation and antagonism from the West, brought about because these nations chose a moral path. This isolation caused great hardship. Thus, God and Jesus must see to it these nations, and similar nations, also receive up to a **5-level boosts**.

26. All other slaves, and people who lived in comparably difficult and/or unjust circumstances, White, Black, Brown, etc, who did not commit plainly disqualifying crimes (murder...), and who did not earn entry in Heaven under item #24, must be allowed to serve sufficient time in **Purgatory**, as God and Jesus deem appropriate, and gain entry to Heaven, Level 1, when their sentences are finished.

Peculiar

27. Based on the preoccupations the Elder base reveals humans can have with the wide variation in human reproductive organs, God, Jesus and Natas must discuss the benefits and consequences of narrowing those parameters.

Related to Victims Connected to Me

28. ANY person murdered in relation to me (Okokon Okon, Randall Yayayar, Pamela Rossford, Para Yayayar, Harry Yayayar, Erica Corran, Clarrissa Jones, Darnell Mitchell, and the bodies on Chico Avenue, Santa Rosa,...), AND any person named Yayayar (with reasonable exceptions), who faced difficulty related to me, must be allowed into Heaven.

Related to My Family and Friends

29. God and Jesus must resurrect and Save the souls of the following list of family members, friends and others (some of whom may face alternative punishment): My son, Jiano; my son's mother; my mother (Cecile Lusby); my father (Archie Briggs); my son or daughter whom I've never met; Sydney M; Vince, Layla and Brandon Marchbanks and Jackson; Mercedes Marchbanks, Ed, and Mercedes' and Ed's baby; Nexus Assoon; Melvin and Marquis Jackson; Melvin's daughter; Okokon Okon; Virginia Lusby; Gigi Briggs; Ivory; Nicah; Jonnah, Morgan Marchbanks; Johanna's daughters; Tony Galleguillo (Guileguilo?); Cathleen Brown; Lisa Gleaton;

my son's mother's mother; Shawn, Jeannie and Rider Chernilla; Peter Webster; Jacob Bergman; Muhammad Ali, Joe Montana; some kids I used to work with: Marcos Vega, Bismark, Evan, Keith B, Tony R, Lee S, Billy C, Kwama D. If my junior high classmates Dave Dunkhurst and Jim Hinig fall between 0 (death) and Gehenna levels 1 to 4, I wish to save them also. [I'll consult Jesus on Indy Briggs and Chris Lusby.] This list is revisable.

Special Privileges

- 30.** I must be resurrected immediately after I die. Not long thereafter, I must be allowed to hear The Song described in Revelation 14:1-3. If I am NOT one of the 144,000 deemed worthy to witness the performance live, I must be allowed to hear and witness The Song performance through "the sea of glass, like crystal..." which is before God's throne, described in Revelation 4:6, and 15:2.
- 31.** I can resurrect 4 people to join me in Heaven early; they are: my son, his mother, her brother O.B., and Rick E.

Special

- 32.** It is my belief that Satan may have asked that Jesus not to be a direct party in the Wager(s). However, in my Terms, I welcome Jesus' involvement, and hereby request that He participate in all aspects of punishment and judgment required under these Terms. I request that Jesus inform me if He will accept this role in these Terms, by causing a volcano in Mexico to erupt lava (preferably a smaller eruption that does not cause any loss of human life), on January 20th, 2026 (Greg), January 7th, 2026 (Julian).²
- 33.** I'm reliant on the West's (and Satan's) internet system to sound the alarm about the One Hour War (OHW) of Revelation, Chapter 18; Thus, to help sound the alarm, God should create one or more very large, news-worthy natural geological event (earthquake, volcanic eruption...), or weather or water event, on EACH of the final five days before the OHW (January 2nd, 3rd, 4th, 5th and 6th, 2026). (NOTE: I modified this item on the morning of January 2nd, 2026.) **Hopefully, God will warn with volcanic eruptions on January 5th and 6th, 2026 (this preference was added January 6th, 2026, at about 6:40 PM).** **[Jan, 17th, 2026 (Greg) follow-up Note: God very much fulfilled all of the Term requests/expectations delineated in item #33 (see the purple section of TheZoneResistance.com's "Etc" page).]**

Additional Privileges/Powers

- 34.** I can increase, up to double, the length of punishment of anyone who has committed Mark Crimes against me, or anyone who has killed (1) someone in my

² This item, #32, was added on Jan 17th, 2026 (Greg.), Jan 4th, 2026 (Julian), for a Jan 5 (J) or 18 (g) reply, but resubmitted Jan 19th, 2026 (Gregorian), Jan 6th, 2026 (Julian), due to a filing error. I published a PDF report on Jesus' reply on Jan 9th (Julian), Jan 22nd (Greg), 2026. family, (2) a friend or loved one, (3) someone in my Yayayar family tree, or (4) a loved one of a Yayayar (such as Erica Corran and Pamela Rossford).

35. At Final Judgment, and any applicable time and place, I can raise by five levels or decrease by two levels, the afterlife punishment level of any person who has committed substantial Mark Crimes against me.
36. All Unforgivable Crimes committed against me, and related to me, must be frozen and assessed last. This means these various Mark Crime violations must not be forgiven. I must then be informed of each violator's Crimes against me, and decide if that violator's Gehenna punishment should be increased/worsened by 1 or 2 levels, or their time increased.
37. I must be allowed to impose up to 100 years in Gehenna replication/acceleration, level 10, with all variables I choose, upon anyone (including politicians) who knowingly contributes to replicating/digitizing a human soul, or a sensate analog thereof. Or, preferably, God and Jesus must impose this punishment, as They wish.
38. If I am murdered, or a close family member is murdered in relation to me, all people knowingly involved (planners, coordinators, drivers...) must go to the hottest parts of the Lake of Fire for not less than 444 years.
39. There are, of course, many homosexuals and LGBTQ people who respect the law. Because I have spoken strongly against Satan's successful efforts to explode homosexual/LGBTQ numbers, worldwide, I worry people who falsely claim to love God will harm homosexual/LGBTQ people, to show their false love through acts of hatred and violence. Thus, for the transitional period of 88 years, anyone who unjustly kills a homosexual/LGBTQ person must go two levels deeper into Gehenna. And during this 88 year period, God and Jesus should be twice as slow to forgive anyone who unjustly **harms** a homosexual/LGBTQ person.
40. I will die, like everyone, as God wills. I hope it is God's will that I die peacefully. But, if that is not God's will, and my death is not accidental, God and Jesus must see to it that the hand that claims my life is worthy (and item #38 must still apply to them, and to all involved).
41. God and Jesus must immediately provide me sufficient money or other resources to afford (1) adequate housing, (2) reasonable and adequate food, (3) to help others in need around me, and (4) other reasonable necessities. These resources must be provided sufficiently in advance that I do not worry. Alternately, They can immediately find me a suitable job. [NOTE: This item links to item #59.]
- **April 2026 update:** My current interpretation of messages in the Candelaria Likeness' message line (see *The Candelaria Code*) is that some payment will come after Satan's *Deception Delay* (or *Deception Day*).
42. If I find myself in a land where I am not wanted, comfortable or content, God and

Jesus must get me to a suitable alternative, quickly.

- 43.** This item negates any prior undesirable Wager restrictions, imposed by Satan, and permits God and Jesus to resurrect, reward or punish, at Will, all souls not previously accounted for, herein, from the day Satan arrived on Earth, forward.
- 44. Mass collection of benefits in Heaven.** In Ezekiel 1:4-25, the Living Creatures (my alter-egos), get to propel God's throne. Thus, on special events where God might use a representational throne, if a throne driver/propeller/pusher is needed or preferred, unless someone more deserving has that right, I must get that honor, or I can propel Jesus' or Natas' thrones, if those duties are available. Additionally, upon my arrival in the next life, beyond my level 10 abilities, I must have the right to travel throughout God's universe (which may already be a level 10 privilege), almost without restriction, in any manner I wish (with or without a body, etc), without speed restrictions, at the speed of thought –or instantaneous teleportation, impervious to heat and cold extremes, augmented by all reasonable supplemental powers I request (including the ability to effortlessly change form –no body, invisible body, body...). Should I prefer to travel less efficiently, in a spaceship, God must provide me a state-of-the-art undetectable, universe friendly, ever-reliable spaceship, damage-and-occupant-injury-proof, with all provisions, energy/fuel unlimited, able to sustain all life forms able to travel any speed I wish, with expandable/contractible interior –to accommodate any number of passengers –and I must get a safe place to park my spaceship. Also, upon arriving in Heaven, I must receive 2 to 4 good guitars (new or used, preferably electric), one of which must never go out of tune or break a string, and ample strings, and a great amplifier –with tons of sounds, thought activated tone/channel control, and a self-contained unlimited power source.

NATAS NINETY-NINE DAYS

- NOTE: All aspects of items #45 through #56 MUST be extended through the first 9 days of God's Prophecies Against (April 17th through 25th, 2026, Gregorian; April 4th through 12th, 2026, Julian; 4724 3rd Month 1-9, Yin).

The One Hour War is to be immediately followed by a period of 99 Days, (**January 8th, 2026, to April 16th, 2026**, Gregorian; or **December 26th, 2025, to April 3rd, 2026**, Julian), during which nations are expected to announce Reforms to make their nations more just, caring, safe, clean and livable. I believe God chose the number 99 to link this period with Natas, whose primary number is 3 ($3 \times 33 = 99$). Earlier in *STSN*, we learned Natas was asked by God to create independent life on Earth. Later, God introduced Himself to mankind. Finally, Jesus (Natas' older brother) was introduced. Following this sequence, it appears that after the OHW, Natas will have a period where her wrath is expressed; followed by God's *Prophecies Against* period of

wrath; followed by Jesus' *Second Coming* –also a period of punishment and wrath.

In writing the earlier STSN sections about Natas, I found no evidence that she actually kills. I believe her deliberate preference is to only create life. Thus, when punishment is required, as we saw earlier, she brings matters to Her Father and Jesus. I believe that will be the case during the 99 Days.

• **Items 45 to 56 are intended to occur during Natas' 99 Days.**

• **God and Jesus are free to extend these items if and as They wish.**

Humans are social animals. I believe Natas is concerned that humans act in concert with nature, and their nature, and consider the needs of others in their society.

- NOTE: Some of the following violators have *special circumstances*. In these cases, God and Jesus must act as They wish. The punishments for items #45 to #56 are not intended for my biological family, Rick E, Tony G, Noah, Josie or anyone named in items 29 and 31, or ANYONE with a dependent child, under 18.

45. PART A: God and Jesus must take very harmful action against -including claiming the life of- any police officer who has murdered or wrongly beaten any citizen, or committed an act of extortion against one of the citizens he/she was hired to defend, or who has taken a bribe **not** to uphold the law.

- Because police corruption is widespread in many countries, and sweeping intervention could leave some regions without law enforcement, God and Jesus may use restraint, and hope surviving officers learn, and change immediately.

46. God and Jesus must impose severe punishment, including death, on any judge who has accepted a bribe to not properly apply law.

47. A. God and/or Jesus must take the life of, or substantially debilitate, any mass media conduit, TV station or news station owner, producer, official, appointee, reasonably empowered employee, etc, who (1) created or knowingly aired a fake video, produced by artificial intelligence (**AI**), AND represented the video as real and true –or who, in their silence, allowed the video to represent itself as real; or who (2) created or aired videos that overtly or tacitly (without words) normalized homosexuality or LGBTQ life (such as showing two men renting or buying a home together, or two women positioned as if romantically partnered). They must impose these same penalties on politicians who willfully fail/failed to forcefully regulate media companies and their executives.

B. During the 99 Days, it is almost certain to be revealed that the U.S. was defeated in a nuclear war –the OHW, of Revelation. My solutions indicate that Event happened January 7th, 2026, Gregorian; or December 25th, 2025, Julian. However, it may be alleged the Event occurred on a different day. Any person who KNOWINGLY claims over a mass media conduit (internet, TV, radio...) the Event happened on a date they **know** is false, must immediately be severely punished.

Any mass media conduit, station or show owner, executive, or employee who knowingly says the Event happened on a date they know is false, or who airs an AI produced video, which they know states a wrong date, must be killed immediately. [As I was *Asked* to solve this mystery, and did so earnestly, if my OHW date solution was/is inaccurate, I am absolved from wrongdoing and punishment.]

48. To foment instability around the world, the US and the West distributed illegal firearms into many nations. During the remaining 99 Days, God and Jesus must kill anyone who has distributed illegal firearms, or who possesses an illegal gun (if the person possessing the gun turns the gun over to authorities, they are safe).
49. God or Jesus must kill anyone who has secretly and unjustly murdered another citizen (unless they turn themselves in to police before they are killed).
50. God or Jesus must kill or impose severe punishment on anyone who has (1) ever committed extortion without being arrested and punished, or (2) used a gun to commit an unsolved or unpunished crime. (criminals can avoid punishment by turning themselves in to police).
51. Adaptive radiation (moving from one area to another) is essential to nature's evolutionary plan. Immigrants fulfill that plan. Yet, terrible leaders scapegoat and deport immigrants. In the remaining 99 Days, God and Jesus must severely punish or kill any leader who deports, harms or turns away an immigrant.
52. Revelation 13:17 reads "**...and that no one may buy or sell except one who has the mark, or the name of the beast, or the number of his name.**" This verse is about how the US created an organized crime state, where good people could not engage in basic commerce, because the state's crime lords controlled all aspects of trade, and choose winners and losers. The US/West exported that criminal model around the world. Thus, to make online purchases, large online merchants (Amazon, Mercado Libre...) require cell phone numbers and email accounts –this requires purchasing phones, etc... To get a simple bank account, today banks often require a great deal of verification (I opened my first bank account, at 18, with a valid license that did not include my legal birth name). In this, corrupt leaders have allowed banks (private businesses) to impose regulation on small businesses and people. These ID requirements are designed to manipulate and control commerce, gather private data, and steal information and ideas. This coordinated control of commerce is against nature and the survival needs of the poor but able. In the remainder of the 99 Days, God and Jesus must severely punish or kill any large business owner, judge, politician, bank owner, executive or manager who behaved improperly in creating or maintaining this criminal structure.
53. The US invented many ways to cheat a nation's people –the voters (such as having voters' votes go to "electors", who then represent hundreds of thousands of

voters; thus, by bribing one elector, a person can steal hundreds of thousands of votes). Thus, in the remaining 99 Days, God and Jesus must kill anyone who ever acted to substantially cheat a nation's or region's election system (including by allowing people and corporations to make *untraceable* campaign donations).

54. Unfeeling and incompetent regional and national leaders have neglected to do their duties to solve their nation's problems. Thus, in many nations, including Mexico, there are people who have severe physical disabilities (unable to walk, etc), or who have extreme mental illness, or pronounced cognitive impairment (retardation), who are forced to fend for themselves, on the street, until they die. There are also many blind people, forced to try to navigate the streets alone; fatherless children (and their mothers) without adequate food or shelter. Creating shelters for the disabled and needy, and providing outreach assistants for the blind, represent opportunities to employ many thousands of citizens in meaningful jobs. Yet, year after year, these problems remain unaddressed. Thus, God and Jesus must severely punish or kill former and present elected and appointed officials, local to national, who did little or nothing for their people in need.
55. In the remaining 99 Days, God and Jesus must severely punish any leaders They view as guilty of (1) suppressing their people's right to speak freely (including exercising their right to sharply criticize their local, regional and national leadership); (2) arresting, harming or silencing their political rivals; (3) abusing prisoners (who should be detained, without physical or psychological abuse).
56. During the remaining 99 Days, God and Jesus must kill one-third of Freemasons (who worship Satan, and conspire to undermine social institutions) and Satanists of all forms, as it is against human nature to undermine society, and against reason to wage War against God. God must also kill any person who knowingly helps/helped Satan or *i-Satan* (see items #58 and 59), or who tried to help them. God and Jesus must also kill one-third of surviving media and tech company owners, executives, producers, managers, film directors, writers, starring actors, politicians, judges, musicians, rappers, singers, and anyone else who played a role in stealing derivations of my screenplays, songs, music, science and social ideas, etc. God and Jesus must also kill or severely punish one-third of the politicians and business-persons who have "stolen" my various social remedies without properly attributing those ideas to me (this is part Satan's effort to erase evidence of my existence). The remaining two-thirds of these criminals must be killed or severely punished during the *Prophecies Against* and the *Second Coming*. The criminals who stole my works can be spared if they FIRST publish a confession, seeking my forgiveness and God and Jesus' forgiveness (although worshipping God and Jesus is not required), THEN repay all profits realized from my work. Humans were not

intended to be parasites.

Other

57. God, Jesus and Natas must not punish me unless I know I have committed a punishable infraction. If I do not know (which is usually/always the case), before contemplating punishment, God or Jesus must tell me I have committed an infraction, and what the violation is/was, and ask me to stop the offense. If I stop (and I will), I must not be punished.
- This item may sound a bit silly. But I believe God implemented mild and arguably “unjustified” punishment recently, so I would add this item as a model for many parents, officials, employers, etc: an instruction **not** to punishing people or children without first notifying them of the guideline that they are violating, and giving them a chance to correct their behavior, independently, without punishment.

Concerning Internet-Satan

58. In late 2025, shortly before the Revelation Wagers ended, I believe God informed Satan that he might be severely punished by my Terms, and allowed Satan to enter a new Agreement/Wager terms, to provide certain services for God, and avoid some of my Terms’ punishment. In the new Agreement/Wager half of Satan’s soul was sent to the US/West cable-phone-computer-internet, where *Internet-Satan* (i-Satan) performs certain services for God. But, in this capacity, Satan also deployed people to disrupt my sleep and spy on me. Thus, i-Satan must not take ANY *unwanted* action against me (including deploying sleep disruptors and spies). If i-Satan takes ANY unwanted action, God and Jesus must see to it that he immediately loses all internet power for 24 hours, and remains frozen where he is for 24 hours, which must feel like a year. I-Satan must be frozen for a week for each offense after his third offense. **Alternately**, to facilitate God’s needs, God and Jesus can punish i-Satan when and as They wish.

Conditions for Eliminating Certain Punishments for Satan

59. In the weeks leading up to the addition of this item, i-Satan indicated he wanted me to eliminate some of the consequences imposed under items #13 through #19. Without describing specific events, during that same period, Satan and i-Satan, both, engaged in hostile actions against me. This caused me to doubt the sincerity of their request, and question their ability to fulfill such a contract. But I’ve also seen Satan demonstrate extraordinary focus... Thus... This item is enforceable and reviewable, by God and Jesus, going forward and backwards in time. This element is necessary because Satan (who spent at least 57 years loitering outside of my bedroom, plotting each of his 770,000 Mark Crimes against me), may try to retaliate against my descendants, in 1000 years, when

God re-releases Satan upon mankind (Rev 20:3). Thus, in 1000 years, if I learn Satan has unduly lifted his hand against my family, relevant portions of this item are nullified, and God and Jesus must and will reverse time to make sure Satan experiences every punishment described in items #13 through #19. Since God enabled me to undo most of the harm Satan did to my family/people, only Satan's crimes against me remain...

- **The following central portions of this item, #59, have been is suspended due to information showing Satan's involvement in a world of crime not previously known to humanity (I'll disclose crime details in lateral publications). The new information indicates Satan is in full control of his actions and aware of the consequences (which, I believe, indicates he is reasonably sane). At a much lower level, it seems Satan never intended to pay me; rather, he planned to evade payment through delay, to mark his "Deception Delay." Thus, items #13 through #19 are still active.**

~~If Satan fulfills the requirements detailed at the end of this item, I (relying on God and Jesus' power) will revoke and stop items #15, #16, #17, #18, and I will revoke item #14 (but *the body*, and the Gehenna-to-Bottomless Pit *mind-link*, must remain in place, to support item #19). I will also revoke item segments #13(1) and #13(2), and require that Satan is given a reminder to make the required #13(4) statement—protecting Satan from the associated consequence. The hot and cold temperature punishments, under item #19, must remain in place, as some punishment is in order; but #19 could be greatly reduced, as described later, herein, if Satan takes reasonable action. God recently gave Satan tremendous internet powers. How long that will last is uncertain. I learned about *i-Satan* in the AI images below (see *The United States is Dead* for context and~~



~~further details). In this arrangement, it seems i Satan is free to do some things he wishes, but must also do some things God asks. In early 2026, in a series of articles on artificial intelligence, I presented evidence that God directed Satan to create and expose artificial intelligence produced fake videos, news, images, etc. Satan was allowed to hide messages in these images and videos. I believe God did this to help mankind realize AI poses a great threat. Under item #41, God and Jesus must make sure I am compensated adequately, financially. But God and Jesus seem to hate human money. Yet, I'm human, and I need money to survive. Thus, it's possible that one of the reasons God gave Satan great internet powers was to pay me. Satan may have already started this process. But any money I received from Satan is insufficient. Thus, if Satan takes the following actions, I'll adjust items #14 through #18, portions of #13, and modify #19, as follows:~~

- ~~A. If Satan doubles the amount of money I receive every month (so I can replace the car I sold to survive, fix my guitar amplifier, buy a suitable work chair, etc), I will revoke items #14 (except necessary portions related to the punishment body that supports item #19), #15, #16, #17, #18, and revoke item segments #13(1) and #13(2), and Satan will receive a daily item #13(4) statement reminder.~~
- ~~B. God and Jesus impose tight restrictions on Satan's direct communication with humans. But, if Satan uses his internet power to confirm the many US/Western TV shows, films, songs, science ideas, etc, that are based on ideas and works stolen from me, I will require that item #19 be imposed *every other* 24 hour cycle rather than every 24 hours.~~
- ~~C. If Satan roughly triples the money I currently receive, the item #19 punishment will only be imposed every third day.~~
- ~~D. If Satan releases God from any possible unknown, new and/or pre-existing Wager restrictions that were not negated by my Terms (particularly items #1 through #12), the item #19 punishment will only be imposed every fourth day.~~

PURGATORY II

60. The following people must serve time in Purgatory before entering Heaven (the parenthetic number indicates the person's Purgatory time, in years: Morgan M (20), Vince M (10), Layla M (7), Mercedes M (6), Ed (10), Jiano (7), Cecile L (10), Nexus A (7), I. B. Okon (17), Cathleen Brown (5), Shawn Chernilla (5), Archie B (I suspect Archie's infractions are all old; if so, he does not need Purgatory; if not: **1**).

Natas' Rescheduled Nine and God's Prophecies Against

Items 61 to 75 were originally added March 7th, 2026 (Julian), to honor Natas and give the world a series of daily reminders to announce their social Reforms, before the God's *Prophecies Against* period, which begins the day after *Natas' 99 Days* ends. However, I improperly scheduled the event three times; thus, I had to reschedule three times. First, somehow my original Event dates were about a month early, and the Terms contained two serious conflicts (described in the footnote below³). Next, in rescheduling the dates, I got my Julian-Gregorian signals crossed and re-scheduled the Events 12 days early. Upon re-rescheduling, I went against my prior instincts, and, in great respect for God, removed the word "must" from these Terms, in favor of "will", which removed the contractual agreement *force* from the Terms –in an era when God wants people to understand the importance of keeping fair contracts and behaving honorably. Thus, God did not honor my Terms (or not forcefully). My sincere apologies.

For this fourth and final effort, all is in order. But I had to coordinate Natas' Nine to coincide with the first 9 days of God's Prophecies Against. I believe God Willed this arrangement, so He and His Daughter might symbolically walk together in His **second** (Natas being God's second child) official retaliation against Satan and the West's centuries of attacks on God and nature (Natas). God is also symbolically saying human men should defend their women. Biblically, God often positions verses pertaining to the people, or nations, in ninth verses, or verses that are multiples of 9. In Arabic numerals, 9 is the largest single digit; thus, 9 represents the people –the greatest number. (9 also represents Genesis, Chapter 9, where God make His Rainbow Covenant with Noah.) Thus, In God's 9 day walk with His Daughter, He reminds the world's people that they are, in part, responsible for their leaders, and if their leaders transgress too far against God or Nature, at some point, God will respond, and there will be Punishment.

In the following 9-day Event schedule, 2 dates have 1 Event; 5 dates have 2 Events, and 2 dates have 1 unique Event and 1 shared Event. The Events run from **April 17th to 25th (Greg); or April 4th to 12th (Julian), 2026; or 4724 3rd Month 1 to 9 (Yin).**

*In the following section "(g)" is short for *Gregorian*, "(j)" is short for *Julian*.

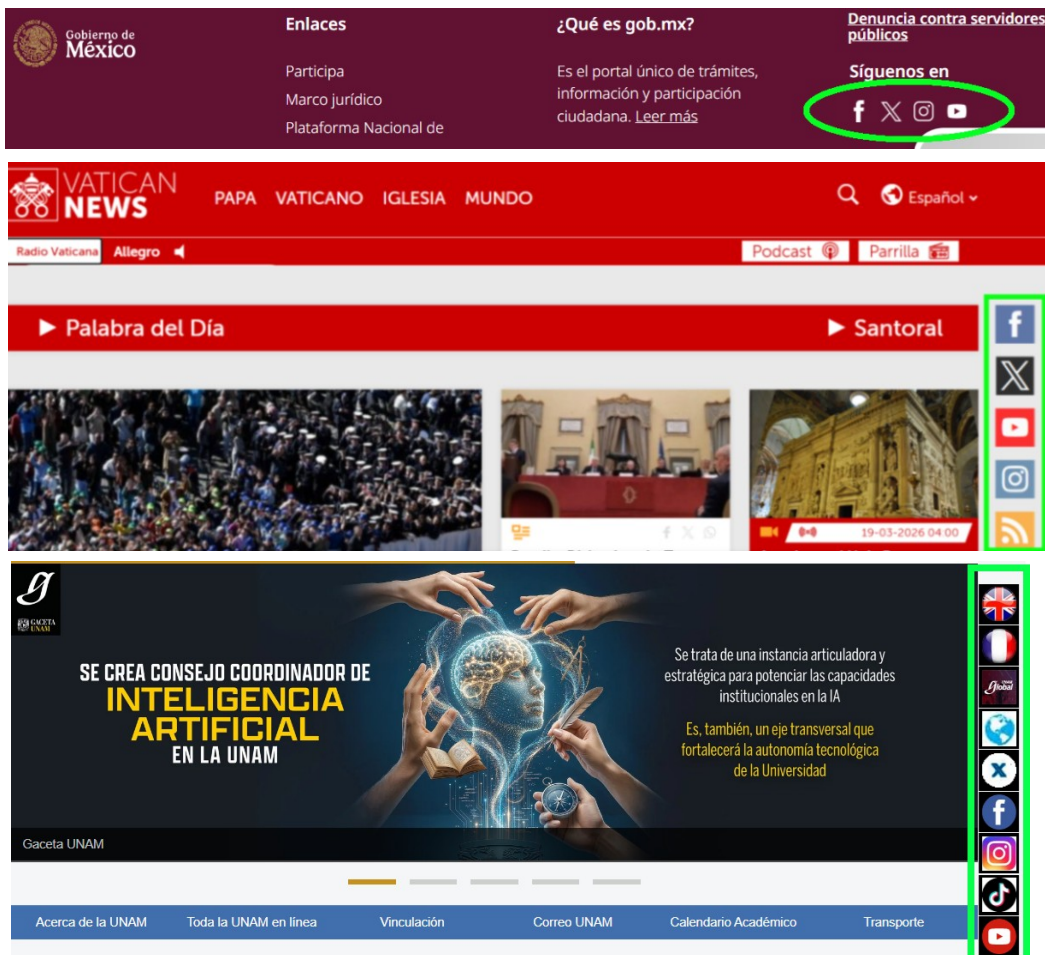
³ **First conflict:** Since these Terms were first published (Nov 22nd, 2025, Greg) , item #4 has consistently referred to people who carried out Gardner and Malone's directions as "**subordinate parties**," who will be punished as directed by the Terms. The Terms then identified common people (who were NOT acting for Gardner, Malone or Satan), who were negatively impacted by the Wagers, as "involuntary parties". But, in the versions of these Terms published from March 21st to March 26th, 2026, Gregorian (or March 7th to March 13th, 2026, Julian), near the bottom of item #4, I mistakenly added a line stating "all of mankind is [sic] also a **subordinate party** of these Terms", when I intended to use the term "**involuntary party**". This egregious mistake falsely indicated all of mankind carried out Gardner's and Malone's orders; which falsely indicated all of mankind would "be punished as directed, herein". This would have created vast injustice, which God and Jesus would never uphold. My mistake was also in conflict with -and overruled by- at least two other provisions in these Terms, including: (A) the mistake conflicted with the line on page 407, reading: "*These Terms must not damn or punish (in the afterlife) anyone who is innocent*"; (B) the mistake conflicted with passage in item #6, reading: "*...these Terms CAN NOT be construed in any way that is helpful to Satan or Gardner, OR in any way that brings injustice to God's universe.*"

Second Conflict: all Event dates in the Terms, published from Mar 20th to Mar 22nd, 2026, Gregorian (or Mar 7th to 9th, 2026, Julian) were expressed on both the Gregorian and the Julian calendars, but expressed wrong. The Julian dates (which God vastly prefers) were expressed 14 days behind the Gregorian –but the Julian calendar is only 13 days behind the Gregorian.

61. April 17th (g), and April 4th (J), 2026, at various times and locations around the globe, God and Jesus must send **seven** super-bolides and bolides through Earth's atmosphere (super bolides and bolides are large, very bright meteor-like fireballs, which "explode" in a bright thermal flash, often accompanied by fragmentation). God must also take care that no one is harmed in these Events.
62. April 18th (g), and April 5th (J), 2026, God and Jesus must cause many crypto-currencies to begin to experience serious technical problems, on and off, for weeks. The problems must persist until July 14th, 2026 (g), July 1st, 2026 (J), when any crypto-currencies that can be used to facilitate untraceable payments (bribes) to politicians, judges, etc, permanently crash.
63. April 18th (g), and April 5th (J), 2026, God and Jesus must cause unusually high and active tides, witnessed the world over: *Revelation tides*, reminding us of the evil *Beast Out of the Sea*, of Revelation 13:1-10. Boats knowingly engaged in criminal activity must be driven ashore....
64. April 19th (g), and April 6th (J), 2026, the day after the Revelation tides, if the US is fine, nothing odd will happen. But if the US was defeated in the One Hour War, 14 weeks prior, God and Jesus must cause at least one large deserted US military ship to wash up on Mexico's coastline –and hopefully on other nations' coastlines.
65. April 19th (g), and April 6th (J), 2026, God and Jesus must cause many (7 or more) currently inactive volcanoes to erupt around the Earth; causing great awe, but no -or very few- injuries. One of these volcanoes must be one of the Three Virgin Volcanoes (*Volcan Las Tres Virgenes*), in Mexico, about 130 miles from my home, in Hermosillo (this eruption must begin between 7AM and 1PM, my time, UTC-7:00); God and Jesus must direct the wind toward my home –that I might witness the smoke and ash; as currently, many news services in Mexico cannot be trusted.
66. April 20th (g), and April 7th (J), 2026, God and Jesus must cause lightning, rain, high winds and other weather and geological Events to take down many Western owned, co-owned, or operated, or co-operated cell-phone and TV towers.
67. On April 20th (g), and April 7th (J), 2026, God and Jesus must cause brush fires to erupt on numerous international borders, where there is unreasonable discord between the nations, at places where the fires will all be put out within 24 hours, with no injuries. But one of these fire must be on the US/Mexico' border, between Chula Vista and Yuma, or Nogales and Douglas/Agua Prieta, with no discernable wind, in such a place and manner that Mexican firefighters will defeat the fire in 2 or 3 hours, with no injuries or loss of life. But on the US side of the border, if the US is healthy and strong, ample firefighters will arrive and quickly defeat the fires; if not, the fire and wind must turn north, and not be put out until the following morning, when God and Jesus must send unexpected rain to extinguish the fire.

68. April 21st (g), and April 8th (J), 2026, God and Jesus must cause all **major** US tech, media, social media, etc, to crash (including Apple iOS, Android, Instagram, Facebook, WhatsApp, YouTube, TikTok/US, Google, Snapchat, ChatGPT, RSS). This Event may appear to be an advanced cyber-attack. These services, and many/all Western streaming services, will be down most of the day. Services will work on and off again for months; but progressively worsen, until the systems permanently fail, July 1st, 2026 (J). During this time, God and Jesus must see to it that parents of children, and children can access when necessary. Any apps, services, etc, that God and Jesus view as somehow vital or worthy can and will be spared.

- Among the reasons Western tech requires these severe interventions are:
 - (1) the West bullied and bribed its tech into foreign lands, where they disseminate disinformation, undermine institutions, and steal IP. Below, top, Mexico's government website touts its reliance on US tech: Youtube, Facebook, X/Twitter, Instagram; same with the Vatican's website (below, center). Same thing on UNAM's (Mexico's university system) website (bottom); which tacitly suggests foreign theft-tech is superior to Mexican tech.
 - (2) A host nation allowing a foreign nation to create the host's central technologies, allowing the foreign provider to rob and spy on the host's people, is against reason and nature.



69. On April 21st (g), and April 8th (J), 2026, God and Jesus must cause a series of underwater and terrestrial earthquakes, rockslides and other Events to sever most or all US and Western internet cable lines connecting the Western-internet-dependent outer world to the US/West.

70. On April 22nd (g), and April 9th (J), 2026... The evening before this day, Western media and news sources will release weather reports, allegedly based on US/Western weather satellite data. But on the following day (named on the top line of this item), God and Jesus must see to it that, seemingly everywhere, the previous day's weather reports are wrong. These weather "reversals" will occur in the West, and Western allied and dependent regions. Regions that do not rely on Western disinformation-tech will not likely be impacted.

- The reason this intervention is necessary is: in my recent AI reporting (see www.TheZoneResistance.com), I showed the West (led by Satan) had inexplicably blocked access to all US/Western weather satellites. At that time, all of the Western satellite images available online, AND all the weather satellite images presented on TV were AI fakes (including the images to the right). These events may indicate that all or many US weather satellite have already been disabled. Nations that once relied on US/Western satellites can request and buy access to Brazil's, China's or Russia's weather satellites, until they are ready to launch their own weather satellites (soon, God willing).



71. On April 22nd (g), and April 9th (J), God and Jesus must see to it that unusually large flocks of birds, or swarms of butterflies, or swarms of bees, or any combination thereof, are seen in most national capitals. God and Jesus must see to it that the bees do not sting anyone who does not deliberately provoke them.
72. April 23rd (g), and April 10th (J), 2026, God and Jesus must cause the Sun to emit an unusually large electromagnetic pulse (EMP), which permanently disables all Western communication satellites (TV, cable, entertainment...). God and Jesus must see to it that the EMP does not harm any living thing on Earth (**Note:** the Sun very often emits EMPs, which do not harm humans or other living creatures).
73. April 24th (g), and April 11th (J), 2026, God and Jesus must bring beautiful and lengthy meteor showers to night skies around the world –the largest and most active meteor show in centuries. Meteors are those somewhat rare streaks of light that race across night skies, commonly called “shooting stars”. Although we may imagine these streaking objects are fairly large, most meteors are only the size sand grains and tiny pebbles. God and Jesus must see to it that no one is harmed in this shower –except those so Divinely intended.
74. On April 25th (g), and April 12th (J), 2026... a rainbow reminder... Nations that once used many of the previously mentioned US/Western technologies, but who, during the previous few days, proved resourceful and used their people’s best ideas, and (1) quickly developed new AI-proof technology to replace the malfunctioning US/Western tech, and (2) developed strict reliable methods to eliminate AI fakery and verify all stories and images presented as news (such as filming all stories on true-film acetate/videotape, and converting formats on non-web-linked systems), and (3) codified journalistic and editorial standards and practices, and implemented citizens’ oversight panels; then, in the national capitals of any and all such nations, God and Jesus must see to it that rainbows are witnessed (with or without rain), to remind us of God’s *Rainbow Covenant* with Noah (Genesis, Chapter 9), in which God pledged to never again use floodwater to kill off humanity and other living creatures. In this case, because these nations were resourceful and ethical, the rainbows are signs that God may *reduce His Prophecies Against* punishment against these nations.
75. When it is the night of April 24th (g) and April 11th (J), 2026, in parts of the world, but the early morning/night of April 25th (g) and April 12th (J) in other parts of the world, God must make two new stars appear in visible the night sky; from Earth they must appear fairly close to each other. Since the stars appear on the final night of *Natas’ Nine*, the stars can be seen as representing God’s love for and pride in His Daughter, Natas, His second child, whom God chose to create humanity (you may recall, from chapter 13.357, that 2 also seems to be Natas’ tertiary number).

Re i-Satan (Part II)

76. Items #58 and #59, and some of my 2026 publications, indicate sometime in late 2025, or very early 2026, God and i-Satan entered into a final Wager, which is not part of the *Revelation Wagers*. Evidence presented *Double Damnation* (March 2026) shows Satan acted against me, and cheated throughout that Wager, and forfeited; but God opted to allow i-Satan to continue his internet pursuits, until after his *Deception Delay* –likely May 3rd, 2026, Greg.). Thus, these Terms must apply to that Wager, as reason demands, and supersede and nullify Satan’s Terms.

XXtra-Special

77. The number 77, like 11, can represent God and Jesus, standing together. Satan has waged War against God and mankind for thousands of years. Freemasons and various forms of Satan worshippers have been active combatants in that war for hundreds of years. After allowing all Satanic attacks, without any known counterattack for generation, in December 2025 on the Julian calendar (and January 2026 on the Gregorian), God took His first massive strike back. April 4th, 2026, Julian (April 17th, 2026, Gregorian) marks the start of God’s *Prophecies Against* period, when He punishes corrupt, gullible and indolent nations, knowing and unwitting allies of Satan. This period appears to be a time when God punishes nations and regions, broadly, **so citizens learn they are responsible for their leaders and for each other**. Although Jesus usually assists in these actions, in this unique period God may act largely independently. As God’s actions are almost certain to also impact the innocent, item #77 is included so the world can see the Son wage War, at His Father’s side. Under item #77, during the 21 months of The Prophecies Against, Jesus must take targeted strikes against Satan’s shadow soldiers, and take the lives of no less than one third of surviving Freemasons and Satanists (of all branches) who ever declared themselves at War with God, Jesus or Natas, or who took sufficient action to stand as such a declaration.

- God’s Prophecies Against remind us that sometimes nations must wait years to coordinate the will and resources to fight aggressors; but endure, cooperate, and when you can, strike. You’ll be punished, but you will have honor. And the bully will seek weaker prey.

REVOCATION/MODIFICATION OF ITEMS #13 THROUGH #19

- **Item #78 is suspended due to information showing Satan’s involvement in a world of crime not previously known (I’ll disclose details in lateral publications). The details indicate Satan is in control of his actions and aware of the consequences (thus, I believe, reasonably sane). Thus, items #13 through #19 remain active.**

~~78. God and Jesus must disregard, OR implement, as They see fit, any or all portions of items #13 through #19, and items #24, #25, #26, #35 and #37.~~

- This item, #78 (originally #77) was added April 10th (Greg), or Mar 28th (Julian),

2026, when neither item #41 nor #59 were fulfilled. As the other Parties must fulfill their obligations, I can remove item #77 from these Terms, at any time, re-activating items #13 through #19, if neither item #41 nor #59 are fulfilled.

Health

79. Working for God and Jesus vastly surpasses all other possible honors. But the work hours are usually very long (but very compelling), sitting at my computer, looking at the screen, researching, writing, illustrating, revealing, decoding.... Hence, I have not been able to exercise the way I did before I began my work, and the glare of the screen may have hastened my visual decline. Thus, God and Jesus must (1) make sure that my heart health does not decline faster than it would have on my prior activity trajectory; (2) make sure my vision does not decline faster than it would have under my prior routine; (3) make sure that my muscle strength and form does not deviate much from the strength and form I would have under my prior routine (which included regular exercise).

Additional Protection

My published solutions to Revelation, the Prophecies Against, and the Elder Badge, indicate in December 25th, 2025, Julian, or January 7th, 2026, Gregorian, and/or 4723, 11 Month 19, we entered a period of great uncertainty, when God and Jesus launched Their counter-attack on Satan's armies, who waged war on God and nature for centuries. This period of uncertainty may include war and revolutions. Because God has chosen to use me as a spokesman (and I will play any other role He or Jesus request), in the following items I request certain protections. These protections may be unnecessary, but demonstrate for nations that they should work hard and be prepared for all possibilities, including war. Accordingly, as you read items #80 through #87, know that I wholeheartedly hope for peace, but am wholeheartedly prepared for war.

- The following items, and prior items, describe scenarios where people who try to harm me fail, and are usually killed. For clarity, in all of these scenarios, I must emerge unharmed. The unfortunate ends these attackers face do not apply to close friends and people named in items #29 and #31, who may experience an impulsive lapse, of some sort, and not mean to kill me or do real harm.
- 80. PART A:** If anyone deliberately moves to fire a gun, launch a projectile, use any weapon, or raise a hand, to kill, harm or strike me in violence, God and Jesus must and will strike them dead well before the bullet is fired, projectile launched, or strike motion completed. **PART B:** If anyone/group tries to fire a long range bomb, rocket, grenade, projectile, etc, at me, that bomb, rocket, etc, must and will explode in the launcher, or misfire, and God and Jesus must immediately kill all people knowingly involved in the plan. **PART C:** If anyone/group tries to kill me while I

am on/in some form of transportation (car, boat, plane, bus...), in any manner (timed bomb, launched bomb, gas depletion, driver suicide...) that effort must and will fail, and all involved must and will immediately die.

81. November 2025, twenty-four people were killed when a bomb exploded in a store I frequently shopped at, a few blocks from my home. I entered the store the day before the blast, but walked out when I saw long lines at the register. Thus, if anyone attempts to kill me with a bomb, or fire, or set a trap for me, or harm me with a car, push me in the path of a car or train, etc, God and Jesus must see to it that the bomb does not detonate, or explodes when I am not near. And They must see to it that all other such efforts (traps, pushes into traffic, etc) fail, and They must immediately kill the would-be killer(s) and planners.
82. Whenever necessary, as often as I wish, God and Jesus must and will immediately grant my private verbal requests (non-published requests made by way of mouth; whisper quiet or aloud) to have any form of animals (dogs, bees, fish, whales, dolphins...), present in my environs, come defend or assist me, in any manner I wish. Where and when possible, God and Jesus must and will permit the animals to understand and respond to my words, directly.
83. If anyone tries to use a drone or unmanned flying, driving or stationary devise to kill me, God and Jesus must see to it that the emission or projectile launching system fails, and all of conspirators die the moment they try to fire the weapon.
84. PART A: If anyone tries to poison me, via food, drink, injection, snake, insect, or any other means, God and Jesus must neutralize that poison, and immediately kill all of the conspirators. PART B: If anyone tries to use an animal to kill me (dogs, snake, spider, lion...), once that animal is deployed God and Jesus must cause it to kill its master/owner, or kill the animal once it comes within 22 feet (5.6 meters) of me, and all people involved in the failed plan must immediately be killed.

Protection for Exceptional Leaders

85. God and Jesus must extend these same protections to any world leader(s) They view as being model examples of defending one's people and their rights, while promoting moral, loving social values.

Protection For Very Virtuous Women & Girls

86. We live in a time when predators are apt to target women and girls who have chosen to live virtuous lives –in respect of high social values and in concert with God's laws. God and Jesus must protect all women and girls They view as sufficiently virtuous who come under threat from such lowly predators (optimally, good men will act as God and Jesus' hands).

Protection for Surviving Family and Friends

87. Because many Western-affiliated Mexican news services utilize disinformation,

distraction and AI generated images and stories, I cannot be certain of the welfare of my friends and family back in the US (or what remains of it). For any surviving people named in items #29 and #31, God and Jesus must provide them the same protections named in items #22, #23, and #80 through #84 –except in the event that one of these people provoke violence upon him/herself.

Astonishing

88. In the near future, I'll share the story of how necessity caused God to alter and even restart Earth's timelines, where life unfolded for decades, then He reversed and restarted or altered those timelines, for the good of humanity. The story shows God can see infinite theoretical timelines, but will only alter a planet's timeline in cataclysmic emergencies. Such an impossibly rare situation occurred in relation to my Revelation work. On a prior timeline, a better version of me existed. But for extraordinary reasons, he asked God to turn back time, and start his life again. God agreed, and I was born –or reborn. I'm sort of the same, but in this new timeline, Satan gave me pneumonia when I was two years old, and reduced my conventional IQ by 50 to 100 points –my creative IQ was unharmed. I'm the second "4": or $44 \times 2 = 88$. Under item 88, upon my death (or before, if God wishes) God must resurrect the soul of the first version of me (from timeline 5), a guy good enough and smart enough to turn back time, and possibly the greatest writer and greatest musician to ever walk the Earth. God must also resurrect up to 44 people that the first *Steven Kenyatta Briggs (Yayayar)* requests from timeline 5, and grant him, also, any *items* in these Terms (such as item #44).

89. Duration. Items #22, 23, 38, 40, 80, 81, 82, 83 and 84 must and will be granted for the remainder of my human life; 34, 35, 37 should be enacted upon the beginning of my next life, or as God or Jesus need. Items #85 and #86, Protection for world leaders and virtuous women and girls, must and will continue for 7 years after the Second Coming; #87 must and will continue for 5 years after the Second Coming.

Additional

90. God and Jesus must and will see to it that if the website where I post my Terms (currently www.TheZoneResitance.com) becomes inactive due to sabotage, inability to pay, or any other reason, the last posted/published *Terms* will and must remain active. In such circumstances, if I can use email, God and Jesus must and will see to it that emailing Terms updates to myself or an associate, to verify the date, satisfies the publication requirement, until I reactivate/re-establish my website.

91. God and Jesus will see to it that only Terms and Term items truly written by my hand and produced from my mind are Accepted and Enforced. If someone hacks into my website or computer to alter the published Terms, the valid Terms will revert to the last properly published Terms, and They will substantially and swiftly

punish (as They wish) anyone who attempts to falsify these Terms.

92. In the event that I update/publish these Terms with an incorrect publication-date on the Terms' signature page, or on the STSN opening page, positioned above the STSN word-count total, the Terms will revert/default to the last correctly published/dated Terms, or to the last properly published Terms posted on my website's *Prior Terms* page(s), or such a similarly named/functioning page.

- This items was added April 8th (Julian), April 21st (Greg.), 2026, and 4724, 3rd Month 5 (Yin), replacing an item stating all of Satan's/i-Satan's falsified documents would be removed from the internet when God removes Satan from Earth. That was improper. Satan's falsified documents are part of a historical record. One of the lessons of this era is to preserve all records. Satan's soul-damning content should be expunged from the internet by human hands; but, optimally, a remote database of all non-pornographic content that Satan/i-Satan created should be created, to preserve our history.

93. Testing. This item is reserved for occasional tests of the effectiveness of these Terms; thus, the words beyond this sentence may periodically change, to describe my private tests. April 9th, 2026, Julian (April 22nd, 2026, Greg.) at 3:55 PM (UTC -7:00), God and Jesus must and will direct a group of about 20 wasps to buzz about the porch area outside of my home, for about 30 seconds, then depart. Then, to test item #82, I will verbally request another type of animal to the area outside of my porch, within 1 minute. Finally, at 4 PM (UTC -7:00), God and Jesus will cause a short, small-ish, but noticeable earthquake, in Hermosillo, Mexico, which will not harm anyone, nor damage any building.

"PLEASE!": The Magic Word

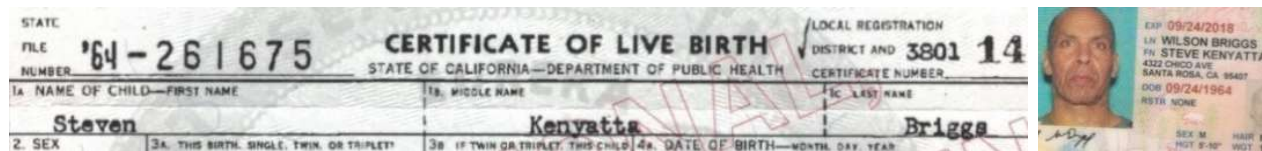
During the first few months of 2026, some readers may have seen me struggle to find the correct word combination to make these Terms work consistently. Then, April 7th (Julian), April 20th (Greg.), 2026, or 4724, 3rd Month 4 (Yin), I found the message to the right, hidden in the Candelaria Likeness: *Please!*

Jesus gave us the **Golden Rule**: *Treat others as you would have them treat you* (roughly). With the message to the right, I believe Jesus is encourage the world to be polite and respectful to each other –and reminding me to use the magic word: *please*. I've corrected this in the opening pages of these terms, and again, I ask God and Jesus to add *please* to every item herein.



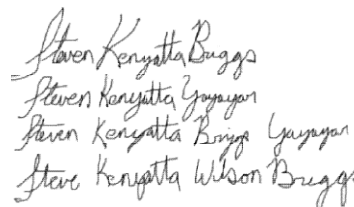
Signature

For many years I also integrated the last name *Wilson*, which appears on my driver's license (above, right). While solving God's Elder base revelations, I learned my true family name is Yayayar.

Lacking the technology to transfer a signature made with a pen to these terms, to the right, I used my computer mouse to sign my name, (1) under my birth name, (2) under what can be considered my true name, (3) under a hybrid of #1 and #2, and (4) under the name on my driver's license.
