A. PURCHASE PRICE

## **B. TRANSPORTATION COSTS**

All transportation costs will be paid by the buyer, and must be paid before the puppy is shipped. Transportation costs include shipping crate, airport delivery charge, and any other expenses involved in the shipping of the puppy.

## It is agreed by both parties that:

## A. USE OF DOG

It is agreed between Breeder and Buyer that this dog is being acquired as a family companion dog and/or bird dog.

#### **B** Health Guarantee

Breeder, guarantees all of the puppies to be in good health and free from visible signs of infection, contagious or communicable diseases when purchased. We guarantee the puppy to be free of any LIFE THREATENING congenital defects. Also covered are Canine Distemper, Adenovirus Type 2, Parainfluenzq and Parvovirus. This portion of the guarantee is valid for six months and ONLY if the booster shots are administered on time and there is proof of them provided by a licensed veterinarian.

A licensed veterinarian must examine your puppy within 72 hours of delivery. If there is a problem, our veterinarian will interpret the report and if he/she concurs, then a replacement puppy will be given. In this case, you will have the option of replacing the puppy or getting a refund of the dog's price. We will not refund nor cover transportation charges. You must notify us the day of initial examination to make claim for a replacement puppy. We will not cover any vet charges. The original puppy must be returned, alive, within 24 hours along with all paperwork.

A fecal to test for internal parasites is required within 72 hours of delivery. If Parasites are found it is the owners' expense to treat for these. The breeder must be informed immediately of the examination's result by email or mail. The failure of this will result in the cancellation of the guarantee.

We guarantee our dogs to be free of genetically related problems. Genetically related problems covered by our guarantee are: hip dysplasia Elbow, Thyroid, patella disorders, and eye blindness. The genetic guarantee is good through the age 12 months (1 year from the date of birth).

The breeder's health, hip and genetic guarantee does not apply if any injury, illness, disease or fatality develops as a direct result of the dog being overweight or malnourished. The buyer will keep the puppy current on all vet care including shots, deworming, heart worm treatment, and flea, and tick treatments. The buyer agrees to feed the puppy a premium dog food and not allow the puppy to become obese.

If for any reason during the term of this guarantee that we give a refund for the purchase price, this contract will automatically become null, and void. We will make no other refunds beyond that point.

#### C REGISTRATION

The Breeder certifies that the dog has been registered under the Regulations of the American Kennel Club as a purebred German Shorthaired Pointer and will provide the proper forms for transfer of ownership of this registration as soon as they are received from the AKC. Buyer agrees that the Breeders kennel name prefix "FreedomFarms" is the ending of the puppy's registered name on the Registration certificate.

All puppies are sold with an AKC limited registration (unless another agreement has been made at an additional cost and an addendum is included with this contract. The Buyer agrees the puppy will not be bred, intentionally or unintentionally. The females are to be spayed after her first cycle (unless your veterinarian recommends it at a different age) males to be spayed at six months of age (unless your veterinarian recommends it at a different age).

#### D **RECOVERY**

If for any reason, the Buyer can no longer care for the above dog/bitch, the Buyer is to contact Breeder to revert ownership to the breeder at no cost at which time the Buyer will provide and sign the transfer of all AKC papers back to the Breeder. Under no circumstance is the dog/bitch to be sold or transferred to another owner without the Breeder's written consent.

#### D LIMITATIONS OF CONTRACT

The contract applies to the original puppy only and is non-transferable to a second party. If for any reason during the term of this guarantee that we give a refund for the purchase price, this contract will automatically become null, and void. We will make no other refunds beyond that point.

#### E UNDERSTANDING THE TERMS OF THE CONTRACT

Buyer agrees that he/she has read and understands the terms and conditions of this contract fully.
