#### Exhibit Space

- An approximate 12' x 12' space will be provided (allowing space between booths)
- Easy up tents are discouraged as they do not stand up to the wind. No permanent fixtures or fixtures that require ground bolts. Non-damaging anchors are allowed.
- Vendors must provide their own tents, panels, display units, materials, tables, chairs, covers, drop cords, electrical cords, etc.
- Limited electricity is available and must be requested at the time of application.

- A brief written description of your business and products to be sold and/or promoted.

- Set up vehicles must vacate the permit street festival area by determined time given based off game time.
- No additional parking spaces will be made available in the CCA permit area.
- No refunds will be given unless the University of Oklahoma cancels the home football game. Campus Corner Game Days Street Festivals are rain or shine.
- NO outside food or beverage sales or samples
