

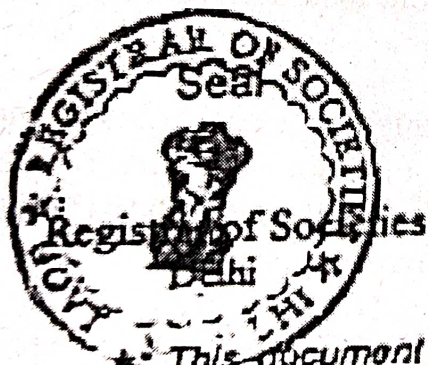

Sub: Permission for Registration of Association in the name of District & Sessions Courts Employees Welfare Association : Delhi

Permission is hereby granted to the District & Sessions Courts Employees Welfare Association: Delhi for registration of Association with the Registrar of Societies on the following conditions:-

1. The Association shall be formed primarily with the object of promoting the common service interest of its members.
2. Association shall not be formed on the basis of any caste, tribe or religious denomination or any group within or section of such caste, tribe or religious denomination.
3. The executive of the Association shall be appointed from amongst the members only.
4. The funds of the Association consist exclusively of subscriptions from members only.
5. The Association shall not espouse or support the cause of individual Govt. servant relating to service matters.
6. The Association shall not maintain any political fund or lend itself to the propagation of the views of any political party or a member of such party.
7. A list of members and audited statement of accounts of Association shall be furnished to the Govt. Authorities annually.
8. The Association shall abide by and comply all the provisions of its Constitution / bye - laws.
9. The Association shall not do any act or assist in the doing of any act which would contravene any of the provision of CCS (Conduct) Rules, 1954.
10. The Communication shall not contain any disrespectful or improper language.
11. The Permission so granted can be withdrawn at any time.
