Respected Sir,

With the beginning of this year, the Delhi District Courts have not only seen the change of the year but also witnessed the transformative, pivotal move led by your good self in transitioning from paper-based circulation of circulars and orders to digital communication via individual emails and the official website. This significant breakthrough has not only drawn the attention of the media but has also been appreciated by higher authorities.

However, despite the progress, the darker side of reality in the office cannot be ignored. There is still much more to be done to advance in this digital era. Delhi District Courts are spread all over in different corners of Delhi in 7 different complexes controlled and managed by the Headquarters at Tis Hazari. Be it an inter-district transfer request, matters related to seniority, promotion, MACP etc. or the issues pertaining to the addition of name, purchase of movable/immovable properties, addition of qualification all are dealt with at Tis Hazari being Headquarters. In such scenario, I would like to draw kind attention of your goodself towards a Mission Mode Project (MMP) called "eOffice" under the National e-Governance Programme of the Government, which would certainly make a revolutionary change in Delhi District Courts. The product is developed by National Informatics Centre (NIC) and aims to usher in more efficient, effective,

and transparent inter-government and intra-government transactions and processes. The product is built as a single reusable system by bringing together independent functions and systems under a single framework to enhance transparency, increase accountability, and transform the government work culture and ethics.

It is worth mentioning that the office has already created the GoI/NIC email ID and DSC (Digital Signature Certificate) of all the employees, which is a pre-requisite of implementing the e-office project. Hence, advancing towards implementation of e-office in Delhi District Courts is need of hour in order to

- 1. Enhance transparency
- 2. Increase accountability
- 3. Assure data security and data integrity
- 4. Promote innovation by releasing staff energy and time from unproductive procedures.
- 5. Transform the government work culture and ethics.

It is, therefore, humbly requested to kindly issue necessary directions to the quarter concerned IT Cell or the Computer Branch to initiate implementation of e-office in Delhi District Courts as well.
