Grave Keepers Report – Remembering Our Ancestors

"A Journey of one thousand miles, starts with a Single Step."

Chinese Proverb



February 20, 2023, marked the end of such a journey.

It has taken several years, lots of resources, many talented people, and a lot of grit and determination to make this journey. I am referring to the headstones that were installed in section 43 in Old City Cemetery, Tallahassee Florida, to honor the memory of the men who died at the battle of **Natural Bridge Florida**, on March 06, 1865.

Kelly V. Crocker is a man of strong will and moral compass. Like many of us with deep southern roots, Kelly is a staunch defender of Southern heritage and history. One of his most fervent passions, is to identify un-marked

Confederate Soldier's graves, and secure a proper marker to identify their resting place. For many of these forgotten souls, the grave marker is the only thing they have to tell their story and give us a glimpse into the lives they lead.

The battle of "Natural Bridge" occurred on March 06, 1865, in what is now called 'Woodville', fifteen miles from Tallahassee, and was a victory for the Confederates. This battle prevented the Florida state capital of Tallahassee from being captured. In fact, Tallahassee was the only Confederate capital not captured by Union forces during the war. Although the battle had no significant impact on the war as a whole, it was a resounding victory for the South. Three Confederate soldiers died as a result of that engagement. The soldiers fated to die that day were **John Grubbs, Eli Triplett Jr, and John B. Ellis**. Kelly was determined to locate these men and insure their final resting place had appropriately identified them and recognized their actions. Years, and long hours of research went into this project.







The National Cemetery Administration, a branch of the U.S. Veterans Administration, oversees a program whereby a grave marker is provided at no charge to qualifying veterans. There are specific criteria that must be met, and the documentation must be irrefutable. Sadly, some of the required evidence to secure markers for these men was missing.

Undaunted, Kelly forged ahead. This project was obviously going to require many more volunteers and

financing to come to fruition. Rallying like-minded and equally determined people to this noble cause was paramount. Meeting together in a small restaurant, these intrepid souls devised a plan of action, and so was born the "Historic Cemetery Preservation of North Florida" (HCPNFL).

The HCPNFL is a 501(c)(3) not for profit corporation, organized to "Restore, preserve, and maintain historic cemeteries in North Florida." Its first project would be securing markers for these men. It was estimated that the cost of the project would approach \$1,000.00. Friends, family, and anyone who would listen were approached for donations. The "Natural Bridge Historical Society" quickly answered the call with a substantial donation, along with many individuals, too numerous to name. With financing secured we were ready to begin.

Enter Charles Hall, owner of "Hall's Monuments" in Donalsonville Georgia. Charles is a jovial, hardworking, and friendly man, who also respects and supports Southern heritage. Having worked with Sons of Confederate Veterans, Finley's Brigade, Camp 1614 on other projects, Charles was approached and readily agreed to assist in this project. Charles worked closely with the HCPNFL in purchasing, designing, and preparing the markers. His knowledge and skills were indispensable in accomplishing the project.

Finally, after several years of 'Treasure, Blood and Toil," long hours of research and preparation, the day had arrived to place the markers. Even after all those years and hours of research, the final resting place(s) of these men could not be absolutely identified. There was much reflection and thought, on where better to honor these men. The "Confederate" section of the "Old City Cemetery" in Tallahassee, Florida, the Capital they fought and died to defend, was the obvious choice. "Old City Cemetery" is located at #400 West Park Dr. Tallahassee, Florida, 32301 (entrance is on Martin Luther King Jr. Blvd).

The 'Confederate' section of the cemetery protects the remains of Confederate soldiers/sailors who died in and around Tallahassee during the war and post war years. Records indicate that there is at least one hundred and eighty-six souls interred there, possibly more. Sadly, many are unmarked and unknown, dying of wounds or disease in area hospitals, their identities having never been known by those caring for them.

What better place to put these markers? This place certainly puts them in good company. February 20, 2023, marked the end of the long journey to honor these men. Finley's Brigade members Kelly Crocker, Mark R. Bess, John W. Bess and Stan Willis, set the markers in block #43 of the "Confederate" section.

On April 23, 2023, the Anna Jackson Chapter, United Daughters of the Confederacy, will hold their "Confederate Memorial Day" services, in Old City Cemetery, starting at 03:00pm. In conjunction, the markers for John Grubbs, Eli Triplett Jr and John B. Ellis will be unveiled, with military honors rendered by Finley's Brigade Honor Guard.

May their souls rest in peace.

FLORIDA DIVISION SCV GUARDIAN



1. **Purpose:**

The purpose is designed to honor the memory of our Confederate ancestors and through its implementation will provide the preservation of their final resting places and will document for future generations their sacrifices.

2. Eligibility:

Any Florida Division camp member in good standing, who is at least 12 years of age and who has demonstrated his desire and ability to serve as a GUARDIAN. All compatriots are encouraged to participate in the program to honor our ancestors and to protect their final resting place.



3. <u>DUTIES & RESPONSIBILITIES:</u>

- (A) He shall care for and protect the grave(s) of a Confederate Veteran, ensuring that the gravesite is kept clean and well-maintained year-round. He shall perform these duties personally unless he is physically unable because of health reasons. At no time shall these responsibilities be passed on to another without the approval of the GUARDIAN committee for the Florida Division.
- **(B)** He will be responsible to appropriately mark the grave, so it is designated as a final resting place of a Confederate Veteran. This can be by stone, plaque, Cross of Honor, etc.
- (C) He will also be responsible for replacing or repairing any marker that is worn, damaged or destroyed.
- (D) He shall personally visit the grave a minimum of four times a year to include Confederate Memorial Day or at least a week prior. He shall place a wreath or a small Confederate flag or both on the grave.

4. APPLICATIONS, REVIEWS & APPROVAL:

- (A) <u>Multiple Gravesites:</u> GUARDIANS may care for more than one gravesite and will be recognized by the Guardian Review Committee. Cost of additional certificates are \$3 each.
- **(B)** <u>Forfeiture of Guardian position:</u> A Guardian who cannot meet the requirements of his position due to relocation, health or other reasons must notify the Review Committee. All fees are non-refundable.
- (c) <u>Bequeathing of GUARDIAN position</u>: A Guardian may transfer his responsibilities as a Guardian to another SCV member in good standing with the prior approval by the Review Committee. There is a \$10.00 fee for transferring the Guardianship. This fee will cover the new Guardian's membership pin and certificate. If he is already in the Guardian program, there will be a \$3.00 fee to cover the certificate designating the new guardianship he is undertaking.
- (D) <u>Revocation of GUARDIAN status</u>: The Review Committee may revoke the status of a participant in the Guardian program if he fails to carry out his duties and responsibilities as outlined. The committee reserves the right to inspect, with or without notice, any GUARDIAN'S Confederate Veteran's gravesite to confirm compliance with all the rules and regulations specified in the program.

Chaplain's Corner

But he turned, and rebuked them, and said, 'Ye know not what manner of spirit ye are of.'

Luke 9:55

I have begun rereading the gospels again as of January 1st. On January 17th, I read this portion of scripture and knew immediately around which February's Chaplain Corner would center... 'Ye know not what manner of spirit ye are of.' I told no one but mused on this for days. I cannot change these words into red on this computer; however, these are the words of the Lord Himself.

The day following our Lee-Jackson Banquet, my pastor, Bro. Todd Hill, preached a sermon (from a series he is beginning on GENEROSITY) that he prefaced with this: He said that the word GENEROSITY in the Webster's 1828 dictionary meant having to do with one's birth or origin... where one comes from or to what family one belongs. He said to us, and now I say to you, "Now you see where this is heading." Well, I went

to Webster's 1828 Dictionary to see if what he said was true and by the way, you should always check behind me to see if I am telling the truth. The following is what I found: <u>Primarily, being of honorable birth or origin; hence, noble;</u>

honorable; magnanimous

Now, compare that with the words of Jesus. Gentlemen, this is obviously applied to Christianity and how a Christian should conduct himself/herself. That being said, even people who are not Christians can and should apply it to their walk in this world. I would hope that as GENTLEMEN—and especially SOUTHERN gentlemen, that we would keep this in mind every day.

Ungodliness abounds in today's world, and truth is attacked relentlessly. I know of no other group of individuals (whose beliefs, whose convictions, whose rock on which they stand) who are attacked and berated more, and against whom eradication of beliefs, thoughts, and heritage is the goal, than the person with Confederate ancestors. We are hated with a vitriol, the likes of which I have not seen in my lifetime. Yes, we can say that law enforcement is hated or that white people are hated, but I have not seen the other side trying to erase their heritage. No statues of policemen are being removed; no schools bearing the names of white people are being renamed. That is of course unless they were Confederate veterans or if they happened to own slaves. Jesus once told His disciples that the world would hate them BECAUSE they hated Him. He was and still is truth. Truth is hated, because it contains absolutes, and absolutes are hated, because they expose sin. While NOTHING is or should ever be put on the level with the Lord Jesus Christ, I will say that truth, no matter what truth, is still and always will be hated. We have truth on our side, and I want you to remember that.

With that being said, I want to encourage you to remember the words of the Master and remember "... what manor of spirit ye are of." One of Gen. Lee's generals was talking very badly about him, and it was known of by many. One day, a certain general asked Gen. Lee what he thought about this general. Gen. Lee replied in a favorable manor stating that he believed him to be a very capable and knowledgeable leader. When this officer heard Gen Lee's response, he replied, "But general, do you not know the manner in which he is slandering your name in this army? Gen. Lee replied, "You did not ask me his opinion of me but mine of him."

We should learn a lesson from Gen. Lee. The Bible tells us that the Lord, in like manner, when He was reviled, He reviled not. It IS difficult not to get angry and lash out at our foes, and I wish I could say that I never have, but that is not the case, and I was wrong! God help us to follow the examples of Gen. Lee and the Lord Jesus Himself. Help us to pray for them to study that they would understand the TRUTH of our history and especially the TRUTH of the gospel. Remember, "what manner of spirit ye are of."

Tallahassee Veterans Village



Veterans Chairman: Reginald Roddenberry Since I was absent from the last camp meeting February 14th (due to a medical procedure), I missed out on the information about the Veteran's Village by **Tori Callan**, Program Manager for the

Village. The following is a brief report I received from the meeting notes:

The village is in need of full-size bed sheet sets, blankets, towels, laundry detergent (liquid, powder or pods), cleaning supplies and boxed or powdered milk. The village residents currently number 48 men and 2 women. Veterans can stay there no more than 2 years, but, usually, they only stay 7 to 10 months.

I have not been able to schedule an appointment to interview a village veteran as yet. I endeavor to conduct such an interview and report to the camp members next month. There were no donations this time period.

An appointment with a local Publix store is being scheduled for next month to ascertain if they will donate food sources to the Veteran Village. Our

Lee-Jackson Event was a great success on the 28th of February with plenty of donations given to the village.

We are always grateful to those who donate to the ones that gave their service to our nation! The following is a recipe by Wilma Scofield, one of our OCR ladies.

FLANNEL CAKES

A recipe from the Hartley's cookbook "Serving Up History: 1776-1860."

Flannel cakes are plain pancakes made with flour but leavened with yeast instead of baking soda or powder.

Original: To 2 oz of butter add one pt of hot milk to melt it. Add one pt of cold milk, 5 eggs, 1c flour, one tsp salt, and two tbs yeast to make a stiff batter. Let it rise in a warm place 3 hours. Fry on a griddle and serve warm with butter and maple syrup or molasses.

Modernized: 1 tbs butter, 1 lg well-beaten egg, 1 c milk, 1 c flour, 1 tsp fast-acting dry yeast, ¼ tsp salt.

In small kettle, heat milk and butter just until small bubbles form around the edge. Remove from heat, pour into large bowl, and cool until lukewarm. Sprinkle dry yeast over milk and let stand 5 minutes to soften. Stir in beaten egg. Mix together flour and salt. Stir milk mixture into flour and beat 200 strokes. Cover bowl and set in warm place to rise for approximately 2 hours.

When the batter has risen, stir gently. Heat greased griddle until drops of water sizzle when sprinkled upon it. Pour ¼ cup batter onto griddle, cook until light brown on the underside. Turn pancake and brown other side. Serve warm with butter and maple syrup or molasses.

Yield: 7 to 8 pancakes.
