- Secretary

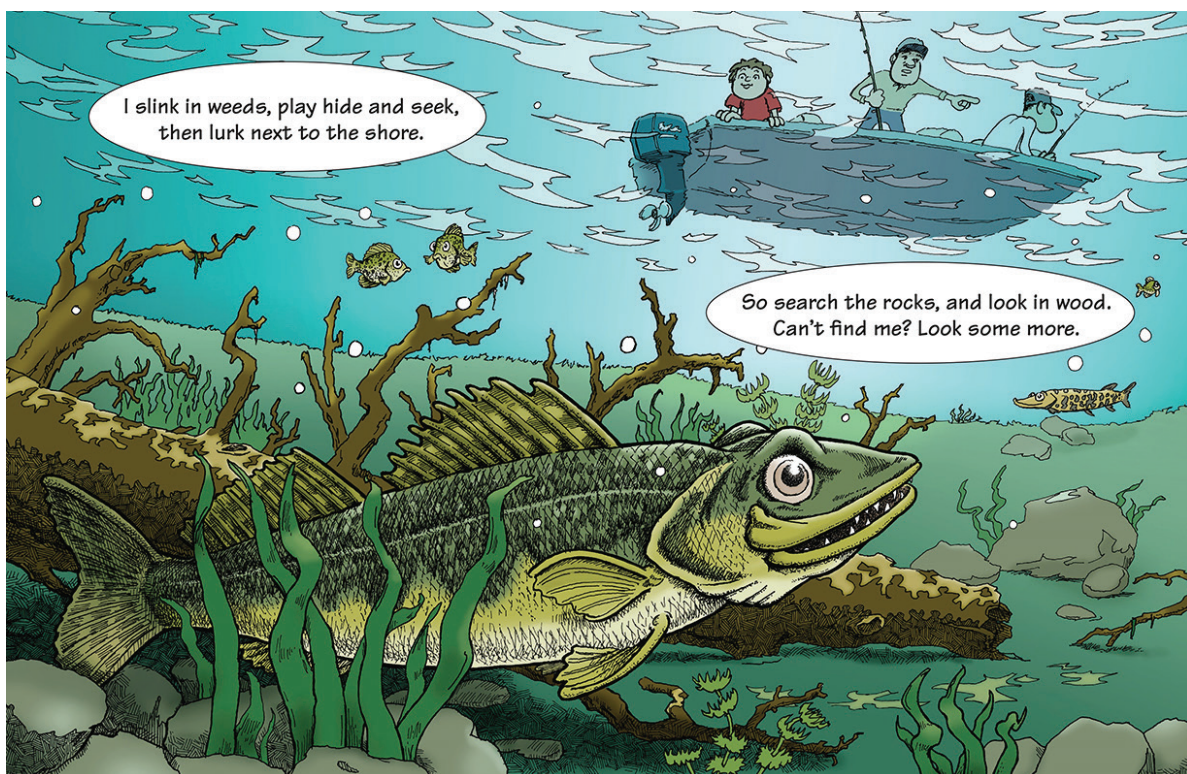
Procedure:

- ***NOMINATION DEADLINE IS MAY 17, 2020***
- Members can nominate another member with their consent.
- Member can also make a self-nomination.
- Both nominated and nominating members need to be a member in good standing. Member in good standing means those who have paid their membership dues and marked 'Active' in the NPWU Membership Roster.
- New members who have paid their membership dues for 2020 are also eligible to nominate/vote.
- Nominated members can call and speak to a current officer for clarifications on the Election Process.

- The Nominations either be emailed to: npwalleyes@gmail.com or mailed to: NPWU, P.O. BOX 1362, CASPER, WY 82602
- Once the nomination deadline is reached, the Officers will review the nominations and send out the slate to the members of the club.
- The slate will contain the name of each nominee, for each officer position
- For any post if more than one nomination is received, an election process shall decide the winner.
- If for any post only one nomination is received, that candidate shall be declared winner on the day of the election.
- If only one nomination is received for every position, this constitutes a 'slate' and the committee can be elected thereof.
- At any point of time, only the candidate may withdraw his/her nomination, even if this candidate was nominated by another member.
- Any candidate may be nominated for more than one post, however he/she may take over only one officer role, even if he/she wins the election for both the officer roles
- ***ELECTIONS WILL BE HELD ON 6/4/2020***, at the June monthly club meeting. The members present will constitute the quorum for the meeting and those members will vote in the 2020 officers.

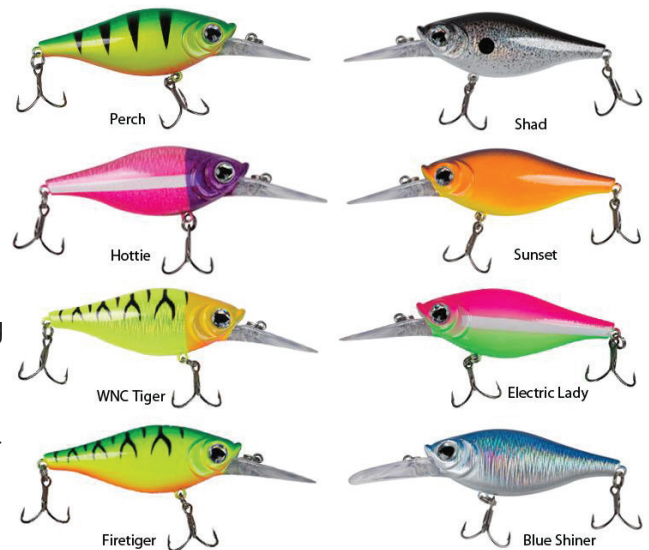
Fishing Report:

The ice is finally gone! It's time to get out of your houses and get that boat all cleaned up and ready to go!

Pathfinder: Fishing has been excellent! Stop by one of our local bait shops and get yourself some minnows and maybe even some shiny new sharp 1/8 ounce to 1/4 ounce jig heads to tease those pre and post spawn eyes. Right now is the time of year you can find those big female gravel lizards on the hunt for food either cruising shorelines, hanging on deeper river cuts or even sunning in the sand flats. Don't forget to pay attention to the ever changing Wyoming weather... If it has been warm for a few days or so don't be afraid to throw some plastics a little more aggressively than you normally would. If you are headed out just after a winter storm you might want to slow down your retrieve and cadence to entice those low pressure eyes!

Glendo:

The spawn is and has been in full swing for about a week or so... With ever changing weather patterns this can be challenging. The bite has been great! Don't be afraid to troll or pitch cranks this time of year especially if you are marking fish! Shallow water has been king this spring. Berkley snap jigs with minnows and WNC Shaky Shad #5's have been killer this year already. Pay attention to humps, edges, gravel points and sandy flats as the fish will tend to move to these spots directly after the spawn to fill their empty bellies and recover their health!
