### Regaining Our Lost Power in A.D.O.C.

As most of you are already aware, AZCPOA has decided to initiate a campaign, within the department of corrections, that will focus on addressing the broken locks that are plaguing Lewis Complex, and as we are learning, other complexes as well. We are also focusing on security breaches, staffing levels violations, classifications violations, staff assaults and other administrative errors that has endangered our staff and convicts alike.

The cat is out of the bag!

There is something terribly wrong with the Arizona department of corrections, isn't there?

You have no doubt watched us make a televised statement at the state capital along with other coverage from ABC Channel 15.

The gloves have come off. No more Mr. nice guy.

We have made our intentions clear to this director and to Governor Ducey that we are no longer going to sit idly by while policies are being violated and crimes are being committed by this administration.

An officer was severely beaten by inmates because this administration will not fix the broken locks. One inmate was murdered by other inmates because this administration will not fix the broken locks and the inmates were able to let themselves out to commit the crime.

An officer was nearly killed yesterday when a convict from Buckley Unit, who should have been max, stabbed him in the chest with a sharpened stinger.

Yeah! We've had enough and are doing something about it.
