## Clarification on Proposition 125

Recently, a demon has reared its ugly head threatening to attack the unity, integrity, dignity and mental welfare of our correctional staff and leaving in its wake chaos, doubt and distension. This demon, like all demons, accomplishes its nefarious tidings by filling the mind with false information and doubt, taking over the mind like an infection that is easily spread to others by simply passing on "that"

false information through word of mouth.

This demon has been with us since the dawn of time and rears its ugly head, now and then, in an obvious attempt to bring ruin to otherwise sane men and woman.

No, I'm not talking about Proposition 125, that recent Proposition that will address problems with the Public Retirement System.

No.

The demon I address here is "FEAR".

### **FEAR**

If I said it once, I will say it a hundred times more: "Fear will kill you faster than a bullet!"

"Fear", and its close cousin "Rumors" are the cause for more deaths than the Black Plague.

It infects the mind, turning its victim into a host, much like a virus does, allowing them to spread the fear amongst those who believe and accept such "things" without personal verification.

# Proposition 125: What it is and isn't

Case in point. Proposition 125. The information concerning this proposition, which will affect the Public Retirement system, is readily available on the internet for all to read and understand and while it is admittingly, sometimes difficult to decipher such political articles, there are further resources that can help clarify such confusion.

So that is what we did. We also had questions concerning the meaning and intent of this Prop so research conducted from trusted sources revealed the following, in a nutshell, and in a clear language that eliminates confusion and doubt:

# "Prop 125 will change the formula used to calculate pension increases for retirees."

That's it!

Previously, pension increases for retirees were calculated with a formula based on how much the C.O.R.P. investments had earned coupled with some other factors, –

(the C.O.R.P. website has a more detailed explanation)

The proposed change will base the increase on the C.P.I. (consumer price index for Maricopa county). C.P.I. is the inflation rate. The yearly increases are capped at 2%.

P.S.P.R.S. made the exact same change last year.

The C.O.R.P./P.S.P.R.S. board (that owes a fiduciary duty to the members) strongly supports 125 to keep it solvent into the future. Both Republicans and Democrats in the legislature supported this and voted to refer the Prop for the fall ballot.

However, a "fear" stemming from the fact that the C.O.R.P. retirement system turned into a 401k for new A.D.O.C. hires recently, has raised a false alarm amongst the ranks.

This fact has generated an unsupported "fear" that proposition 125 aims at eliminating the current C.O.R.P. pension.

This is false as confirmed by research into the matter.

So, let us reiterate once again, as to eliminate fear and misunderstandings:

Proposition 125 will not eliminate the current C.O.R.P pension.

It will only change the way increases are calculated.
