WHEREAS, the State Legislature passed House Bill 1016, effective July 25, 2021, establishing the nineteenth day of June, recognized as **Juneteenth**, as a state legal holiday in remembrance of the day news of the Emancipation Proclamation and the end of the Civil War reached Galveston, Texas and all enslaved persons were released from bondage; and

WHEREAS, Manchester Water District has established policy recognizing other State and Federal holidays as a paid fringe benefit under Section 8.01, 1.) of the Manchester Water District Employee Manual, and:

WHEREAS, the Board of Commissioners wish to amend Section 8.01, 1.) to include the nineteenth day of June, commonly referred to as Juneteenth as a paid holiday.

NOW, THEREFORE, BASED ON THE FOREGOING IT IS HEREBY RESOLVED AS FOLLOWS:

 Amendment. Section 8.01, 1.) of the Manchester Water District Employee Manual shall be amended to read as follows:
