

MANCHESTER WATER DISTRICT **Resolution No. 2024-13**

A RESOLUTION AMENDING SCHEDULE OF FEES & CHARGES

WHEREAS, the Manchester Water District ("District") Board of Commissioners ("Board") adopted Resolution 2012-01, which established a Schedule of Fees & Charges for various services the District provides; and

WHEREAS, the District Board has reviewed the fees and charges for services it provides and determined they should be adjusted to better reflect the present cost of providing these services; and

WHEREAS, the Schedule of Fees & Charges has been created that displays the current costs of the listed services and that the designation "TMO" is meant to establish a fee or charge by computing the actual time, materials, equipment, and overhead costs of the named service; and

WHEREAS, any act consistent with the authority and prior to the effective date of this Resolution is hereby ratified and affirmed; and

WHEREAS, the provisions of this Resolution are declared separate and severable. The invalidity of any clause, sentence, paragraph, subdivision, section or portion of this resolution or the invalidity of the application thereof to any person or circumstances, shall not affect the validity of the remainder of the resolution, or the validity of its application to other persons or circumstances; and

WHEREAS, this Resolution shall become effective immediately upon adoption and signature as provided by law.

NOW THEREFORE BE IT RESOLVED by the District Board that Resolution 2012-01 and any other Resolutions that set fees and charges covered by this Resolution are hereby terminated, and replaced by the following Schedule of Fees and Charges which are hereby adopted and which shall be effective January 1, 2025:


