(1) **Heat Resistance Test**

- The submitted sample was placed in an oven pre-heated at 50°C for 30 minutes. 1.
- 2. The sample was removed from the oven and left in ambient temperature until it was completely cooled down.
- 3. The above steps were repeated with increasing the oven temperature by 50°C until 300°C was achieved.
- 4. Observation was made for any visible change or damage.


