That there shall be reservation of seats SC/ST/OBC and other categories etc. as per policy of State Govt.

That the supporting and other staff will be appointed as per the guidelines of the State Govt./Affiliating Body.

- xi) That the institute charge only such fee as prescribe by the State Govt./Affiliating Body concerned in accordance with provision of NCTE(guidelines for regulations of tuition fees chargeable by unaided teacher education institutions) regulations 2002 as amended from time to time and shall not be charge donations, capitation fees etc. from the students.
- xii) That the academic and other staff of the institution (including part time staff) shall be paid such salary as may be prescribed by the concerned State Govt./University from time to time through Bank.
- xiii) The management shall discharge the statutory obligations relating to provident fund , pension, gratuity etc. in respect in all employees.
- xiv) That the management make adequate fund available providing for the satisfactory facilities and for proper programme implementation.
- xv) The accounts of the account of the institution will be properly maintained and audited annually audit authorities or a Chartered Accountant and will be open for inspection.
- xvi) The management will be strictly follow all conditions and norms prescribed by NCTE from time to time, conduct the programme in all earnestness and submit it self to inspection by the NCTE.

(XXX) That the Managing Committee of the institution has been formed as per the guidelines of the State Govt affiliating University

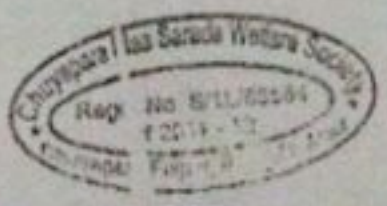
(XXXI) That the Management undertakes to submit Performance Appraisal Report regular as per provisions of the NCTE Act, Rules & Regulations
