

2018 SOURCES OF CONTRIBUTIONS


2018 contributions: \$427.71 billion by source of contributions (in billions of dollars - all figures are rounded)

WHY BLACK PHILANTHROPY HOUSTON?

- To celebrate and acknowledge black generosity
- Questions after 20+ years of experience:
 - O How do we address root causes, disrupt cycles, and create impact?
 - O Why are there so many disparate efforts?
 - O How can we be informed by community needs?
- Less than 2% funding by nation's largest foundations goes specifically to black communities* and only 7% of all non-black donors support black organizations
- Black givers with common interests are often unknown to each other

BLACK PHILANTHROPY

Black Americans give:

- \$11 billion annually given
- 25% more of their income to charity but do not view themselves as philanthropists
- Does not account for extensive non-monetary contributions, collective action, and volunteering
- Cultural context matters- country of origin, traditions of giving differ by community
- Black donors have varied social cause interests




BLACK PHILANTHROPY

High Net Wealth Black Americans:

- Not linked philanthropically or politically to each other
- Giving patterns follow other HNW individuals- education, traditional charities also strongly identify with family and community
- Informed by a desire to "give back" and create opportunity
- May represent new resources for social and racial justice and specific challenges affecting communities of color
- Reach out to HNW donors in different sectors



Charity Navigator Ranking 2017

- San Diego philanthropic community leads the nation
- Houston charities raise more money
- Cleveland charities are richer

Overall financial health and commitment to accountability and transparency:

- 1. Houston (#1 last 2016)
- 2. San Diego (tied for #4 2016)
- 3. St. Louis (#2 2016)
- 4. Tampa/ St. Petersburg (#3 2016)
- 5. Dallas (tied for #4 2016)

Charitable Giving Patterns of Houston Women, The Women's Resource 2010

- Houston women give substantial time, money, and resources to causes they care about
- Multiplicity of interests of women donors could dilute their voice and power to resolve the challenges they want to address

- Easy to set up, flexible, self-governed, responsive to community needs
- One of fastest growing forms of giving



A social entrepreneur...

- Heals themselves and community as part of the work.
- Builds up the community as they build revenue.
- Develops products, services, resources, and access that address. neighborhood, city, state, national or global issues.
- Can work for a socially conscious business or a nonprofit.
- Listens. Watches. Talks. Knows the community and understands the systemic reasons for challenges.
- Are about fundamental change...not band-aids.

More Accessible Definition

A person who pursues novel applications that have the potential to solve community-based problems. These individuals are willing to take on the risk and effort to create positive changes in society through their initiatives.

Social Entrepreneurship v. Conventional Philanthropy

- Focus on revenue generating
- More risk, often responsible for building infrastructure
- Impact created through business model and business operations
- Falls outside of preconceptions
- Often peels back to the system

- Less focus on revenue, skew towards grants based
- More susceptible to political/economic environment
- Initiatives subject to funder predilections and rules
- Less risk and more risk adverse
- Often addresses the symptom

Philanthropy · /fəˈlanTHrəpē/

- 1. The desire to promote the welfare of others, expressed especially by the generous donation of money to good causes.
- 2. Active effort to promote human welfare.
