1.0 ON-SITE CLARIFICATION REQUESTED

.1 Relating to 205 Bagot Street

There is no interior storage available on site. A small bin will be permitted to be stored on the grassed area on the Wellington Street elevation provided the bin is fenced in and all damages to soft landscaping surfaces are restored to as-new condition.

As shown on the Accessible Unit Layout and Detail Drawings, new wiring is to be in new surface mounted conduit. Surface mounted conduits are to be painted to match existing wall finish. Contractor to route surface mounted conduit to minimize disruption to finishes and to ensure conduits run along wall/ceiling corners (not to run along ceilings at mid-span).

.2 Relating to 381 Bagot Street

A small interior storage room will be available at 381 Bagot Street; however, this room is currently, a will be continued to be accessed by building staff during the duration of the project. Space will be made available in the east parking lot provided the allocated areas are fenced off.

As shown on the Accessible Unit Layout and Detail Drawings, new wiring is to be in new surface mounted conduit. Surface mounted conduits are to be painted to match existing wall finish. Contractor to route surface mounted conduit to minimize disruption to finishes and to ensure conduits run along wall/ceiling corners (not to run along ceilings at mid-span).




Figure 1: 205 Bagot Street - Drawing R2.4




Figure 3: 381 Bagot Street - Drawing R2.2
