CLARIFICATION & ADDITIONS

1. General Requirements, Section 01 10 01, page 6, 1.11 Construction Barriers and Enclosures.

Add:

- .4 For this project, all work location fencing to be minimum 6' high metal modular fencing. This will need to be up for the duration of the work around the playgrounds and the new concrete pads. In addition, this fence will need to remain in place until after the new playground base has been installed and cured. Every effort must be taken to minimize the time the playground is closed due to this work. The scheduling of work must ensure that the playground base is installed in a reasonable time following the preparation of the base.

2. General Requirements, Section 01 10 01, page 1, 1.1 Work Sequence

Add:

- .3 Take all necessary steps to minimize the down time of the playground structures.

3. Allowances, Section 01 21 00, page 1, 2.0 Cas Allowances. .5

4. Information for scheduling

- a. The minimum temperature for the playground base installation is 10 degrees Celsius overnight. Please take this into account when scheduling this work.

5. Earthwork and Related Work, Section 31 14 11, page 1, 1.1 Scope, allowable distances: (measured from top of new playground base)

- a. Please subtract 5cm from all maximum heights mentioned. These are maximum distances, and we can be less. This 5cm should allow for any possible settlement issues.

6. Please see attached mandatory site review attendance list.

7. Earthwork and Related Work, Section 31 14 11, page 3, 3.5 Existing Planting

a. Delete:

- .1 Maintain finished grades around existing trees and shrubs by conservation measures indicated. Do not disturb soil within branch spread of trees or shrubs to remain.

- .2 In the case of failure when plantings are relocated, replace with equivalent species and size at no additional cost to the Owner.

b. Insert:

- .1 Maintain finished grades around existing trees and shrubs where possible.
- .2 Every reasonable effort must be taken to protect the existing plantings.

8. Site Furnishings, Section 32 37 00, page 1, Part 2 Products

Add:

- 2.3 Acceptable alternative products:
 - .1 Canaan Site Furnishings, picnic table CAT-033 with wheelchair accessibility and mounting hardware, park bench CAL-701 with mounting hardware, waste receptacle CAY-119B with mounting hardware and rain bonnet.
 - .2 Paris Site Furnishings, picnic table PPS-4PP-SM with wheelchair accessibility and mounting hardware, park bench PA6 with mounting hardware, waste receptacle PFT34 with mounting hardware and rain bonnet.
 - .3 Vista Furnishings, picnic table PT001L-G with wheelchair accessibility, surface mounting ability and mounting hardware, park bench SVA6-AL with mounting hardware, waste receptacle TC001-AL with mounting hardware and rain bonnet.
