



Open Book Ministries — Terms and Conditions

1. **Agreement to Terms:** Welcome to Open Book Ministries. These Terms and Conditions ("Terms") govern your access to and use of our website, services, communications (including SMS/text messaging), content, and any related applications or services offered by Open Book Ministries ("we", "us", "our"). By accessing or using our website or services, registering for communications (including SMS), you agree to be bound by these Terms. If you do not agree to these Terms, do not use our website or services.
2. **Eligibility:** You must be at least 13 years old to use our website and services. If you are under the age required by applicable law in your jurisdiction to consent to the processing of personal data, you must obtain parental or guardian consent to use our services. By using our services, you represent and warrant that you meet the eligibility requirements.
3. **Changes to Terms:** We may update these Terms from time to time. We will post the revised Terms with a new "Last updated" date. Your continued use after changes are posted constitutes acceptance of the modified Terms. For material changes, we may provide additional notice where required.
4. **Use of the Website and Services**
 - **Permitted Use:** You agree to use the website and services only for lawful purposes and in accordance with these Terms.
 - **Prohibited Conduct:** You agree not to:

- We reserve the right to suspend or terminate SMS messaging to any number that violates these Terms or applicable law.
- We are not responsible for message delivery failures due to carrier issues or changes in your phone number.

6. Intellectual Property

- All content on the website, including text, graphics, logos, images, audio, video, and software (collectively, "Content"), is the property of Open Book Ministries or our licensors and is protected by copyright, and other intellectual property laws.
- You may view and download Content for your personal, non-commercial use only, provided you keep all copyright and other proprietary notices intact.
