We are glad to be back in the desert for the winter and look forward to a busy year with all our P.S.H.O.G. chapter friends.

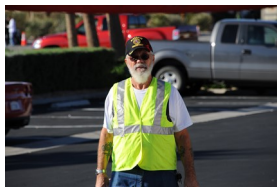
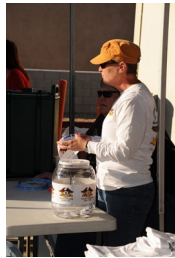
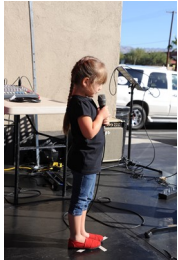
