Cease and Desist the use of our company name, NATIONWIDE POSTING AND PUBLICATION, INC.

i, Billie Rene' Frances Lillian Powers and my partner Valerie Lopez are delivering this email missive as to communicate a very important issue through legal publications that have affected Californians at large who have lost their homes in mass numbers.

The FD CPA is very clear about the use of communications for unfair debt collection practices and the laws are very clear that a company that is not in good standing cannot perform business in California. We are giving you notice of unlawful use of the name to publish legal publications affecting the title and ownership of, at a minimum, hundreds of thousands of homeowners in California.

We own Nationwide Posting and Publication, Inc. and are giving your company notice that the people having advertised under that name previously with you have been acting under a dissolved corporation since 2013. (see attached dissolution of company). We are seeking the documentation through which homes were advertised through alleged contract your company holds with Nationwide Posting and Publication, Inc. We want to have a list of any and all publications done through the use of the name since the dissolution of the use in 2013 by Linda Stevens.

We further must make sure that you are aware of the legal conflicts and liability of the use of our company name and your legal publications to those who may have had their properties taken.

Valerie and I spent many years in working to end the illegal taking of property of Californians and Americans at large. We have found that many companies involved, in what we believe is RICO of the highest order, are not registered with the Secretary of state to be conducting business and are using platforms, like yours at the Register, to perpetuate the work of their unclean hands that have left many innocent homeowners on the streets. We are seeking remedy to allow for the reversal of damage done to those who have been affected by the use of a dissolved corporation and to end the use of our company name in your legal publications.

As we seek to remedy this issue it is hopeful that your company will take the time to make announcements of improper publications having been at the foundation of trustee sales and other real estate notices using a dissolved company. We will not be liable for any use of our name unauthorized, and we have not authorized any legal publications that your paper has published using our name at this time or before.

Thank you for responding and assisting us in making sure that no harm continues and that those wrongly affected previously are given the ability to reverse damages the publications caused them since the dissolution of Nationwide Posting and Publication, Inc in 2013 and up until our making you aware the name is ours and we are lawfully conducting business as the name and without our authorization any publications you are currently running or previously ran may be of liability to your company.

We have both noticed the DA and other Orange County and Riverside officials, the Secretary of State of California and other Public Servant offices of the crimes we believe have been involved in these matters and have Cc'd those we are wanting to assist in shutting down the unclean hands taking that which is not theirs by way of use of dissolved/suspended corporations, of which there are many involved using this platform.

The DA Tony Rackaukas's office has been complicit to these matters and we hope that he will now assist in the removal of all the fraudulently recorded documents in the land records affecting so many women, children and families made homeless through what we believe are massive crimes against humanity.
