This is a public notice that The California 18 and The League of Fraudulently Dispossessed Homeowners are filing claims against Kamala Harris; The STATE of CALIFORNIA; The owners of the software and database known as S.E.C.U.R.E et al. on behalf of all men and women injured by the taking, and those threatened with the taking, of their properties, to include; RICO, Misprision of a Felony, violations of their Business Charters; Violations of the STATE Constitution through third party contractors injuring and violating Californians and the public at large. These Claims we bring are serious and could have been avoided had the public servants stopped the bankers crimes, rather than participate in the RICO. These claims are backed not only with the evidence, but with homeowners un rebutted affidavits of crimes committed and facts into evidence. These claims have not been remedied for the people and now, we are forced to bring claims to end the crimes and return all the stolen estates, lands, homes and lives to Californians and all Americans pirated of their properties. We demand justice.

It is no secret that homeowners and their families have suffered greatly at the hands of bankers, unlawful detainer courts, STATE and FEDERAL courts, attorneys and foreclosure mills nationally, yet the genocide of private property ownership continues. i write this letter to regain protection for those who have already been viciously locked out of their homes and those being threatened with the taking of their property. i write this letter to bring the end to the fraud upon the courts and Financial Crimes Against Humanity.

Attached are articles i've written to explain the RICO and Treasonous crimes that have been committed against us and to show that we have done our best to bring these crimes to the law enforcers, congress and public servants in all capacities. We are not law enforcers, but we are demanding laws be enforced and criminals brought to justice. Our job is to report crimes and we have done that for years without remedy.

There is a woman running for President, Kamala Harris, who single handedly could have helped, who promised assistance, but she did not investigate as promised for the homeowners. Harris allowed Steve Mnuchin to walk and One West Bank to go without indictments, she allowed crimes by banks to end as settlements for the STATE while homes, land and lives of the people at large were, and continue to be, stolen. The settlements did nothing for the injured homeowners and in fact did nothing to end the criminal acts against humanity at large.
