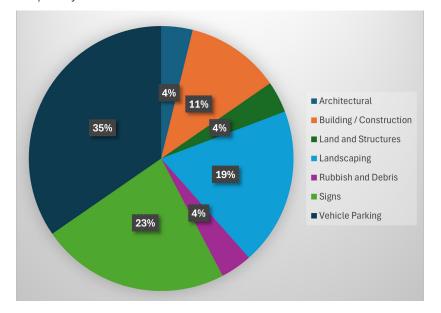

MEETING THE POOL ATTENDANTS & POOL RULE REVIEW



We have 3 returning pool attendants this year and 3 new faces. Teresa is your Friday night and Saturday morning pool attendant, Summer and Jake are your Saturday afternoon pool crew, and Alexandra is your Sunday Pool monitor. If Alexandra looks familiar ... it is because Monday – Friday Alexandra is also the 2nd Association Manager in *The Trails* HOA office. Unfortunately, her being on-deck Sundays does not allow her to provide services for the business office. You will need to pop into the HOA Office Monday- Friday for your association administrative needs. Monday through Thursday, Carl and or Sue Harrell monitor the deck from 10:00 a.m. – Noon, and Diane is the Gatekeeper from Noon until 9:00 p.m.

Please understand that the attendants are hired to monitor the gates for access for members or tenants of the community needing to purchase access. As well, they ensure rule adherence during the busiest times of the pool season (April - September). The gate attendants are not lifeguards; however, they do have the authority to monitor and enforce the rules to minimize risk to the Association and the amenity from accidents, unauthorized use and general shenanigans that may occur when one may believe that no one is watching.... Big Brother sees you though, there are surveillance cameras on the deck, and we have captured several behaviors over the last several years that perhaps might make someone cringe and blush! We have also captured wildlife using the pool after hours... Fox, Bobcats and Raccoons! Just be in the know that the camera is accessible to both property managers and Carl after hours, and it is frequently monitored.



In keeping with the annual rules review that we attempt to have published every year in the Spring edition of the Canopy, here are the operation times and a few of the most important rules:

The swipe card for entry will work from 10:00 a.m. until 8:50 p.m. Monday - Saturday and from 10:00 a.m. - 5:50 p.m. on Sunday. The pool closes promptly at its designated closing time and the staff and patrons are expected to be off the deck when the amenity closes. For this reason, access to the pool within 10 minutes of the official closing will be denied.

Inclement weather policy for the Trails HOA Pool - Currently the Trails Pool acknowledges the lightning sirens used at the Nova Rec center as conditions within a 7-mile range conducive to lightning strikes, that effectively trigger the siren. Having said that, the leisure services have also said storms can be present within a 10-mile radius or even closer and due to the sensors NOT reacting, that we should not rely on the sirens when setting policy. Which is why the attendants use My Lightning Tracker.

The following rule is what has historically been, and will continue to be followed: When the attendants are alerted of potentially dangerous weather, specifically lightning and thunder, they will close the pool from swimming: 60 minutes from the sound of thunder or from the visual of the lightning on their weather apps called **My Lightning Tracker (check your mobile play store)**. In instances where

lightning occurs within 20 miles, the attendants close the pool deck by chain locking the gate. Lightning that occurs typically after 6:30 pm will close the pool for the evening at the discretion of the pool manager.

"Florida is the lightning capital of the world" people have been struck from storms as far away as 25 miles, most recently occurring in the death of a beach goer on Daytona



Beach a few short years ago. A posted policy may deter tempers from flaring when the attendants make the announcement that the pool will close for inclement weather.

Specifically, on sunny days where the conditions for lightning are not so readily obvious. For that reason, the Board of Directors has adopted a lightning policy that the pool staff MUST adhere to.

Pool attendees who refuse to leave the pool deck or who remain in the water after the lightning notice to the users of this amenity have been made, risk having their access card shut down and future access being denied for a period up to the conclusion of the active swimming season in September. This is for your safety as well as the safety of the pool attendants. Your cooperation, politeness and understanding are appreciated.

When a pool pass is purchased or renewed, members will be given a copy of the lightning policy and pool rules. The most enforced rules we receive complaints for enforcing are the following...No Balls of any

kind, No Frisbees, No Unauthorized Floats, no "Oversized" Pool Noodle Chairs, No Pets, No Glass or Glass Containers, No Food or Drinks in or on the side of the pool, and Toddlers should be in official swim diapers. Children over 14 years of age who have a pool pass can be admitted without a parent, however children 17 and under may not bring a guest without adult supervision. Tenants must produce a current lease listing the (#) occupants.

Stay safe at the pool, and enjoy your Summer.

The following Code of Conduct and Business Ethics outlines the expectations of an individual serving on the Board of Directors of the Trails Homeowners' Community Association.

Board Members Shall

- Always strive to act in the Associations' best interests, regardless of their personal interests. Directors serve for the benefit of the entire community and shall strive to do what is best for the Association as a whole.
- Discharge their duties with reasonable care and diligence to properly maintain commonly owned assets and protect property values, while doing so in a fiscally responsible manner.
- Use sound judgment to make the best possible business decisions for the association, taking into consideration all available information, circumstances, and resources.
- Act within the boundaries of their authority as defined by law and the association's
 governing documents. Board members shall always make reasonable efforts to make
 decisions consistent with the Association's Declaration, Bylaws, and other governing
 documents, and they should be familiar with all such documents. Board members sha
 likewise comply with and make decisions consistent with all applicable laws.
- Perform their duties without bias for or discriminating against any individual or group
 of owners or non-owner residents, including, but not limited to, based on race, color,
 religion, national origin, gender, family status, or mental or physical disability.
- Disclose any perceived or potential conflicts of interest to the Board, such as personal
 or professional relationships with any company or individual who has or is seeking to

The financial health of *The Trails* HOA continues to improve, bettering the 1st quarter results. *The Trails* residents have been responsive to the improved financial management systems from Real Manage and have used the expertise of our wonderful Office Managers to access and learn these tools.

Currently, 154 owners are registered for ACH (13% of the membership). Only 6% of the membership are delinquent by some portion of their assessment more than 60 days, while 13% are delinquent by 30 days. These data result in 81% of the community being collected through the 2nd quarter. This is an all-time collection record for *The Trails* HOA! It is a group effort by the residents, Board, and Management...teamwork really does make the dream work!

Of course, these new systems and community communications are not perfect yet, but we continue to monitor them and make improvements. We appreciate residents' cooperation to date and welcome further comments so that we may iron out any rough stops. Your Trails Office Team is always ready to work with you.

*** REMINDER *** The Real Manage Accounting Department is preparing a draft budget for its July 2025 Management Budget Building Workshop. Our Office Managers will participate in this effort to formulate a working draft budget for our own Annual Budget Workshop in August. When we have a firm date for it, we will let you all know.

LANDSCAPE COMMITTEE – Update & Yard of the Quarter

This has been a busy quarter for our Yellowstone employees and committee members. The sick Bismarck palm in the island on Main Trail near Shady Branch Trail has been replaced, as promised; the dwarf snapdragons at the entrances were replaced by mixed vinca and the railroad ties at the Nova entrance were replaced May 15. The HOA has asked the city to replace them with a brick retaining wall and we await further news on that.

New Railroad Ties

Behind 8 Crooked Trail the first set of damaged trees was removed, but one contained honey bees, so a beekeeper was hired to relocate them and a notch had to be cut in the tree to facilitate the relocation of the queen. The city arborist marked two or three more damaged trees for removal as well. The large stump on the path between

Holly Ridge Trail and Shady Branch will also be removed. \$12, 750.00 has been spent on tree removal so far and \$1,000.00 was spent from miscellaneous landscape funds for the bee removal. \$5,900.00 has been spent for sod replacement from the winter freeze and the large sod area near Little Pond will be replaced by Wire 3.

The Little Pond fountain has been repaired by FPL after residents' inquiries for months, and the Lake Walden pumps have been repaired. \$1,042.00 has been spent on irrigation repairs so far this year.

Work is ongoing on the bike paths and residents have asked that debris be moved and not blown off the paths. Two paving companies have submitted proposals for repaving the bike paths that washed out in the hurricane last fall, and the parking lot at the clubhouse will be resealed. Weed spraying along the paths has begun and it takes about twenty-one days to complete throughout the community. When there are windy conditions, it cannot be done.

The Landscape Committee meets the first Thursday of every month at 3:00 p.m. in the first-floor conference room in the clubhouse and we invite all Trails residents to attend as guests or as potential members.

THREE SURPRISING THINGS YOU MAY NOT KNOW ABOUT FERTILIZING YOUR LAWN

Beautiful lawns do not just happen by accident. They require care and nurturing, including regular applications of fertilizer for the turfgrass. Lawns that do not receive fertilization have to rely solely on what is already in your soil, which for most of us, is not inadequate enough.

If you want a truly lush and green lawn, then fertilization is a must. Even so, we find that a lot of homeowners do not know too much about fertilization and are often surprised to learn that fertilizing lawns can have many positive benefits they did not even know about.

In the spirit of learning together, here are 3 surprising facts about fertilizing your lawn.

1. Fertilizing Lawns Provides Essential Nutrients

All fertilizers add nutrients to the soil to help plant growth. The key nutrients that lawns need are Nitrogen (N), Phosphorus (P) and Potassium (K). Each of these nutrients serves different functions for your grass.

Nitrogen is used by plants to push leaf growth and boost its green color. Phosphorous is used to help form new roots and help fight disease. Potassium helps grass to better tolerate disease and environmental stresses.

These three nutrients are very important for plant health, but they are also the elements most deficient in most soils. That means without lawn fertilization, your grass is not going to thrive. Fertilization is a key differentiator between a so-so lawn and one that is looking and performing its best.

2. A Thick and Healthy Lawn is Good for the Environment

You might be surprised to know that a thick and healthy lawn, especially if it has been made that way by lawn fertilization, has several positive environmental benefits.

A thick lawn will ultimately have less storm-water runoff than a thin lawn with a lot of bare patches. Healthy lawns are also great at filtering rainwater. Rainwater filtered through a healthy lawn can be as much as 10 times less acidic than water running off a hard surface, according to The Lawn Institute. Healthy turfgrass also has many miles of fibrous roots that holds soil in place, preventing erosion.

Lawns trap more than 12 million tons of dust and dirt annually. Plus, turfgrass, like that found in our lawns, is much cooler than asphalt or cement, acting as an "air conditioner" for the surrounding area (lawns can be 22 degrees cooler than urban asphalt "heat islands").

Healthy and thriving lawns also release oxygen. It is estimated that a 50 by 50-foot lawn (2,500 square feet), releases enough oxygen for a family of four.

Of course, the key to this is the proper application of fertilization products—something that landscape and lawn care professionals are trained to do. They adhere to strict regulations relating to both the products they use as well as the rates at which they apply those products.

3. You will Get Better Results with a Professional Lawn Care Service

This may not seem like a "surprising" fact. As with most things, when you hire a professional, you will ultimately get better results—after all, they are trained experts.

Buyers, should review all this information closely, Covenants & Restrictions, Estoppel, etc. – not only for budgeting purposes, but also to understand what services (like landscaping or termite bonds) are covered and what community standards they will be expected to uphold.

Marinated Flank Steak

INGREDIENTS

¾ cup vegetable Oil

1/4 cup honey

¼ cup soy sauce

2 tablespoons dried onion flakes

2 tablespoons white wine vinegar

1½ teaspoon powdered ginger

1/8 teaspoon garlic powder

2 - 3 lb flank steak



Combine all ingredients (except steak)

Pour marinade into large ziplock bag, add steak and marinate for four hours to overnight.

Get your grill very hot. Carefully, using large tongs remove steak from the marinade and place on the grill. The oil will create a flare.

Let cook for five to seven minutes, then flip.

Spoon some marinade on the seared side to moisten. Cook second side for about four minutes. Temp with a probe thermometer.

Remove when center is 120-125. Cover with foil, let rest for ten minutes then slice thinly.

Pour any liquid from the resting plate and cutting board over the steak. Be careful not to overcook or it will be tough.

SHARE THE ROAD - PEDESTRIANS, BIKES, AND CARS

Warmer weather has brought the normal increase in walker, runners, and bikers of all ages on our trails, streets, and sidewalks. As the

American Automobile Association (AAA) suggests, this is a good time to remind ourselves of some basic safety rules to follow when sharing different pathways with others.

Florida law requires several commonsense actions for bicyclist, such as:



- obeying traffic signs and signals,
- riding with traffic if on a roadway,
- signaling pedestrians before over taking them,
- wearing a protective helmet if under the age of 16.

In its most recent newsletter, the AAA published its own reminder about safe bicycle and vehicle road sharing. Please have a read and enjoy being out and about in our lovely community.

EDITOR'S NOTE: Recently Property Management has received multiple reports of "near-misses" involving motorized/electric scooters on the bike paths. This 2023 article "Share the Road" is being reprinted by request of Management as the information also applies to scooters.

Readers, please review and share this information with your teens and children, reminding them to let walkers know they are coming. Thank you.

Bicycle Basics

The weather is warming up, and it can be refreshing to take a bicycle ride. So, it's a good time for drivers and cyclists to brush up on safety tips and remember that both have the same right to the road. Here are a few tips for smart driving and riding.

Tips for drivers

- Avoid distractions. Place your cellphone in the glove compartment or have a passenger send messages and navigate for you.
- Don't honk your horn at cyclists. This can startle them into running off the road or into traffic.
- Before turning, check to your side and behind you to ensure a bicyclist isn't coming up alongside your vehicle.
- Before opening your door, check around you for cyclists.

Tips for cyclists

- Assume that drivers don't see you. All vehicles, including cars, trucks, buses, vans and RVs, have blind spots, so it's a good idea to stay far behind them and use extra caution if they're turning right.
- Wear reflective gear if you're biking in the morning or evening; it shines brightly in the headlights of passing cars, making you more visible to drivers.
- Stop before entering a roadway. Look left; look right; look left again—and then proceed with caution.
- Ride on the roads or shared pathways rather than on sidewalks.
- Plan your trip ahead of time. Bicyclists can map their bicycle routes at AAA.com/TripTik or through AAA.com/Mobile. Choose the bicycle icon to adjust the route.

LONG-TERM CRUISING - WHAT IS IT LIKE? Settling in for the Long Haul

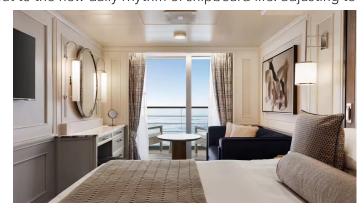

Barcelona is a fine port for ending or starting a cruise, long or short. The Las Ramblas area where we stayed, is very near the cruise port, a 10 to 12-minute walk to the cruise terminal bus stop from our hotel. Plus, this area is loaded with museums, galleries, shops, hotels, and restaurants of all types and levels scattered among the avenues, street, and alleys. We eased into the rhythm of travel by watching the world go by from shaded café tables, espresso in hand. People-watching while sitting in a café is good preparation for our long sea adventure with 20 countries, 30 ports, and 25 sea days.

Planning this story showed me the complexity of this two-month, back-to-back cruise on which we were embarking. The official cruise titles—West Africa Rhythms and Colonial Crowns—offered a general sense of direction, though perhaps understated the complexity and cultural depth of the voyage. Each destination reflected a blend of colonial legacy and distinctive local vibes. Also, the massive cruise area is influenced by three different climatic zones - temperate, dry, and tropical, and three different oceans - Atlantic, Southern, and Indian. But the most significant adaptation, perhaps, was not to geography, but to the new daily rhythm of shipboard life: adjusting to

unfamiliar surroundings, making space-literally and figuratively-for others, and finding calm in a schedule dictated by tides, tours, and trivia.

A Cabin-for-Three – I dubbed my old friends "John the Kalm" and "John the Driven" as I fell somewhere between them in disposition. Fitting three adult males in a 291 square foot room required a bit of choreography. However, as experienced travelers in challenging places, we managed to divide the limited storage space equitably, stow belongings, and stuff the bags under the beds. In a few days, we had settled into a smooth rhythm and felt at home. It helped that we had three slightly different schedules driven by individual activity preferences. Each evening, we received the next day's schedule of activities, events, and tours. From this information we established our joint or individuals plans.



Morning Routines - John K and I were up at 0600 and in the gym minutes later, mostly to avoid crowds. Forty-five to sixty minutes later, we used the gym's steam and shower rooms, then headed to "Baristas" for a morning cup, both of us, "black no sugar, please." Our ship provided breakfast fare in four venues, but we typically gravitated toward the alfresco options at the Waves Grill or Terrace Café. Sometimes, John D would join us, mostly on Port days when we had joint adventures planned. Usually, John D would arise later, depending on how late a night he had had. Normally, he would do his 90-minute spa and workout when the facilities were mostly empty, near lunch time or early afternoon. A bonus for John was that he got to know the onboard entertainers as this was their preferred gym time, as well. I must say, the dancers were very fit group indeed.



Onboard Activities - The energetic Entertainment Staff provided many daily activities, with more on Sea Days. The most popular were Evening Shows, afternoon and evening Team Trivia, and outdoor sports (e.g. mini golf, bocce), and the Art Scavenger Hunt. Additionally, on Sea Days there were Guest Speakers, Cooking and Art Classes, and various Card and Casino Tournaments. Both Johns and I played all the sporting events possible, attended the lectures, and daily (afternoon) trivia. John K played with the Duplicate Bridge Group and did jigsaw puzzles; I did the art classes, evening trivia, and watched some shows; and John D attended all the shows, did late-night Karaoke, and joined and performed in the Christmas choir.

A Word About Team Trivia - The Eight-Person Teams were quite competitive, in a fun way, and the event, habit-forming. The afternoon session, led by the Cruise Director, was the main event. The evening session somewhat less well attended since it competed with later dining times,

but still fun. We formed our team with people we met and liked from other activities, and after several weeks of twice-a-day trivia, we created strong bonds.

<u>End of Day</u> - Our different evening activities clearly staggered our bedtimes. John K headed to the room after dinner to check the news and sleep. I would retire after evening trivia and maybe checking out the show. John D arrived late. As long as we maintained good sound and light discipline in the room, we did not disturb each other. After some amusing trials and missteps, we made it work and are still close friends.

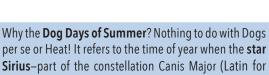
