Section 4. Legislative.

### Section 4.11 Approval by Vote of Electors Required for Amendments to Land Development Regulations.

**No text amendment to the zoning code or other land development regulations that would create a new zoning district, or that would amend any definition of a term used in the land development regulations, or that would have the effect of allowing a use not currently permitted, increased residential density, additional hotel or other accommodation units per acre, or increased lot coverage, height, or floor area ratio, shall be effective until approved by 60% of the electors voting on the amendment.**
