Two classroom buildings were renovated and a third building was expanded at St. Kizito Rubuguri Primary School to add teacher offices, a computer lab, a library, and four classrooms. Plans were created for an additional classroom building and a dormitory.

Two computers and a printer were purchased as were school supplies, desks, sports equipment, beginners music instruments, and shoes and sweaters for students. The school added a girls volleyball team. A new student gardening group created Kylie's Garden to grow, produce, and teach new skills. Students were able to participate in a vocational shoe making class. Ten students received sponsorships that cover their tuition, uniforms, school supplies, and on-campus housing at St. Kizito Rubuguri Primary School and St. Joseph Secondary and Vocational School.

Participated in building renovations, conducted a community needs assessment for three schools as part of a Rotary global grant, and created and coached a girls volleyball team.

Members have ten days to review the application and provide input. If there is no input, the completed Form 990 is signed and submitted.

Form 990, Part VI, Section B, Line 12c - There are currently, two officers / board members. An effort is made to ensure that all company policies are carried out and enforced to ensure that there are no conflicts of interest. Neither officer works or is engaged in any activities that could lead to conflicts.
