Side-by-side comparison: Exhibit C compares Exhibit III-UR (unredacted) page 33 against Exhibit III (redacted) pages 24–25 for the same date range: June 13–16, 2023.

- Targeted concealment on June 13: On June 13, 2023, Exhibit III-UR records: “Request updated Rule 26 Disclosures from J. Freedberg and J. Harkness; Receive disclosures; Save in client Witness Disclosures file.” In Exhibit III, that entry is reduced to “Request updated Rule 26 Disclosures,” omitting the names Freedberg and Harkness and the “receive disclosures/save in file” content.
- Freedberg conference appears only in unredacted: On June 15, 2023, Exhibit III-UR expressly states: “Telephone conference with Jay Freedberg; Revise Witness Disclosures; Review changes to discovery requests; Instructions to paralegal...” In Exhibit III, the Freedberg reference is removed while the remainder (“Revise Witness Disclosures...”) remains.

- Pattern indicates selective redaction: Across the compared entries, the redactions are not random. They remove identity and linkage (names and expert-disclosure context) while preserving neutral task phrasing.
- Direct tie to witness disclosure work: The June 15 entry links a Freedberg conference to “Revise Witness Disclosures,” supporting that witness-disclosure revisions were contemporaneous with and informed by Freedberg communications.
- Temporal proximity: These entries occur immediately before the June 16, 2023 witness disclosure event described elsewhere in your motion narrative, making the timing probative of coordination rather than coincidence.
- Purpose of Exhibit C: Exhibit C is offered to show that Exhibit III’s redactions concealed expert-related identities and context, thereby obscuring the record of who was involved and when, during a critical disclosure window.

The comparison shows that Exhibit III was redacted in a way that specifically removed references to Freedberg and expert disclosures, while leaving the surrounding billing narrative intact.
