- Roger provided a little information about the next Superstition Kennel Club show. The 2016 show will be held indoors at the AZ State Fairgrounds on the same weekend (March 5th and 6th). There will be no competition west of the Mississippi that weekend so they are hoping for a good turnout. Agility, barn hunt, obedience, rally, and specialty will all be on site. Pot-lucks will be allowed at the fairgrounds this year.
