Notice regarding extra precautions for the 2021 Water Trials

An inherent risk of exposure to communicable diseases exists in any public place. Communicable diseases can be extremely contagious and/ or lead to severe illness and death. It is incumbent upon event attendees to follow CDC and AVMA guidelines to prevent the spread of communicable diseases.

Attendees assume all risks related to exposure to communicable diseases.

The following plan is designated at this time for the PWDCA sanctioned water trials hosted by RSPWDC and subject to change. Failure to comply could subject the individual to not be allowed to be tested.

- 1. All attendees are required to follow state, local and facility guidelines in effect at the time of the event.
- 2. Due to Covid-19 guidelines, the public is not invited to these trials.
- 3. All participants during check-in, in the Judge's briefing, and while in and around the trial site when dogs are being tested, will be required to wear a face mask covering mouth and nose. A face shield may also be worn but it will not substitute for a mask that covers mouth and nose. This means that:
- Handlers will be required to wear a face mask covering mouth and nose during their warm up and while being tested whenever they are closer than 6' to other people. Handlers may temporarily remove their face mask when they are more than 6' away from other people.
- Rowers, land stewards and all others who are in or near the test area will be required to wear a face mask covering mouth and nose during the trials, except to drink water.
- 4. If you have recently been in the presence of a person who has either tested positive for Covid-19 or has symptoms (coughing/sneezing/temperature etc.) please stay home.
- 5. If you are ill, feel unwell, are coughing or sneezing, or if you have a temperature higher than normal, please stay home. All attendees should self-assess daily.
- 6. Exhibitors and all participants should sanitize hands as frequently as possible.
- 7. Be self-sufficient. Please remember to bring personal face coverings, hand sanitizer, etc. for your own personal use.

Entry Limit: Entries are limited to 30 teams per day, not to exceed 8 hours of judging per day.

Draw Period 9/8/21 - 9/21/21: If the limits stated above are exceeded during the Draw Period, a random drawing will be conducted on 9/22/21 in accordance with the rules in the PWDCA Water Trial Manual. All entries in excess of limits will be put on a waiting list in the order drawn.

Closing Date and Time: October 5, 2021 at 9:00 PM.



Notice to All Participants

Additional rules and restrictions may be required due to the Covid-19 epidemic, and will be announced prior to the trial, if possible, in an email to participants. Additional rules and restrictions, if any, will be announced at the beginning of the trials each day.

Equipment: Participants may use their own equipment if approved after inspection by the judge or designee, if allowed in the water trial rules. Extra equipment will be provided by the RSPWDC. USCG approved PFDs as well as protective footwear must be worn by all participants.

No dogs allowed off leash except for dog being tested. This is a campground and marina rule, and it applies to everyone before, during, and after the trials.

Awards: Teams that successfully pass all exercises required in their test level will receive the applicable certificate or title from the PWDCA, Inc. Ribbons will be awarded to all qualifying teams, compliments of the RSPWDC.

Rules and Regulations: The trial will be held in accordance with the rules and regulations of the PWDCA, Inc. and it will be the responsibility of each participant to familiarize themselves with these regulations. Copies of the PWDCA Water Trial Manual may be downloaded from https://www.pwdca.org

Bitches in season will participate after all pre-entered teams, and shall not be brought to the test area nor surrounding area until it is time for the team to begin their warm up. Handler is required to be present at judges briefing for level entered.

Fees charged by Canyon Lake Marina, (daily fee per car is expected to be \$20) are separate from those charged for RSPWDC events and activities. No plastic sheets, or solid tarps, or tents with floors may be set up on the grass. Shade canopies are allowed. No glass containers of any kind are allowed.

Refunds: Entry fees shall not be refunded in the event the dog is absent, excused by a veterinarian or judge, or barred from competition by action of the host committee. If for any reason it is impossible to open or complete the trial, no refund of entry fees will be given. Please inform the trial secretary if you have to cancel your entry for any reason.

Substitute Stewards: A participant may use his/her own steward where allowed by the water trial rules, and the substitute steward must be named on the entry form. Requests for any change in steward must be approved by the trial secretary and judge. Substitute stewards must conduct themselves according to the PWDCA Water Trial Rules and Regulations, and must sign the agreement contained in this premium list.

Day of Trial Move-ups will be considered at the discretion of the judge and the trial secretary. They will take place on a time and space available basis and will take place after the last regularly scheduled team.

Meals: No meals will be provided at these trials. Please bring all of the food and water needed for you and your dogs.

Conditions: These trials are open to pure bred Portuguese Water Dogs. I/we understand that the dogs must be in good health, proper fitness and condition for the test they are about to enter and must be at least 6 months of age in order to compete in the water trials. I/we agree to these terms. I/we accept full responsibility for the care of my dog(s) during the water trial.

Special Rules: The water trial is located within the confines of Canyon Lake Marina Campgrounds. I/we agree to become familiar with and adhere to all site rules and regulations including but not limited to the following: Dogs must be on leash or confined to a crate at all times except when participating in practice sessions or when actually being judged. I/we will bring no glass into the marina. If my dog soils the ground, I am responsible for cleanup.

General Rules: The Portuguese Water Dog Club of America, Inc., (hereinafter "PWDCA") rules, regulations, policies and guidelines for water trial participants (hereinafter "the rules") are in the current PWDCA Water Trial Manual available on the Web site, www.pwdca.org. I/we have received the current Manual and/or have read the rules via the Web site and I/we agree to obey the rules.

Hold-harmless: I/we agree to hold the PWDCA and the event-giving club, their members, directors, officers, agents, and judge(s) at this event, the owner and/or lessor of the premises, any provider of services for this event and any employees or volunteers of any of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person, animal or thing by the act of my dog while in or upon the trial grounds or while entering or leaving same, and I/we further agree to hold the aforementioned parties harmless from any claim for loss, disappearance or theft of, or damage or injury to, my dog, whether such loss, disappearance, theft, damage, or injury is caused or alleged to be caused by the negligence of the club or any other parties aforementioned, by the negligence of any other person, or by any other cause or causes.
