Wednesday- Junior, Apprentice, Working, Courier, Master Thursday- Master, Courier, Working, Apprentice, Junior

Entry Limit: Entries are limited to 30 teams per day, not to exceed 8 hours of judging per day.

If the limits stated above are exceeded prior to closing, all entries in excess of limits will be put on a waiting list in the order received.

Closing Date and Time: 9/14/2024 at 6:00 PM Central Daylight Time.

Waiting list: Entries received prior to closing in excess of limit will be assigned to a waiting list in the order received. The waiting list will be used to fill slots as they become available.

Cancellations: Cancellations after the closing date and time will not receive refunds. Please contact the trial secretary, however, if you have to cancel for any reason.

Day-of-Trial Entries: Day-of-trial entries and day-of-trial move-ups will be accepted if space and time are available, at the discretion of the judge and trial secretary.

Non-Regular Entries: Non-regular entries will be allowed on a space available basis after all regular entries are accommodated.

Camping fees include entry to park.

Day use fees are \$15.00 per vehicle.

Driving directions:

From I-10, take exit 281 toward AZ-83 S/Sonoita/Patagonia/I-10. Turn right onto AZ-83 toward Sonoita/Patagonia. Drive 25.2 miles. Turn right onto Hwy 82 Rd (AZ-82) toward Patagonia/Nogales. Drive 19.7 miles. Turn right onto Patagonia Lake Road. Drive 3.6 miles. Arrive at Park Entrance. Follow signs to Beach parking area.

IMPORTANT NOTICE REGARDING DOGS IN THE PARK

Dogs are allowed in the park but not typically at the day use beach.

RSPWDC has special permission to have dogs at the beach during the water trials.

Everyone must follow all posted rules regarding dogs in all areas of the park except during the water trials when we have special permission to use the beach.

Participants will receive information regarding the park's special rules for us in the entry confirmation correspondence from the trial secretary.

Notice to All Participants

Additional rules and restrictions, if any, will be announced at the beginning of the trials each day.

Equipment: Participants may use their own equipment if approved after inspection by the judge or designee, if allowed in the water trial rules. Extra equipment will be provided by the RSPWDC. USCG approved PFDs as well as protective footwear must be worn by all participants.

No dogs allowed off leash except for dog being tested. This is a campground and park rule, and it applies to everyone before, during, and after the trials.

Awards: Teams that successfully pass all exercises required in their test level will receive the applicable title certificate from the PWDCA, Inc. Ribbons will be awarded to all qualifying teams, compliments of the RSPWDC.

Rules and Regulations: The trial will be held in accordance with the rules and regulations of the PWDCA, Inc. and it will be the responsibility of each participant to familiarize themselves with these regulations. Copies of the PWDCA Water Trial Manual may be downloaded from https://www.pwdca.org

Bitches in season will participate after all pre-entered teams, and shall not be brought to the test area nor surrounding area until it is time for the team to begin their warm up. Handler is required to be present at judges briefing for level entered.

Fees charged by Patagonia Lake State Park are separate from those charged for RSPWDC events and activities. No glass containers of any kind are allowed.

Refunds: Entry fees shall not be refunded in the event the dog is absent, excused by a veterinarian or judge, or barred from competition by action of the host committee. If for any reason it is impossible to open or complete the trial, no refund of entry fees will be given. Please inform the trial secretary if you have to cancel your entry for any reason.

Substitute Stewards: A participant may use his/her own steward where allowed by the water trial rules, and the substitute steward must be named on the entry form. Requests for any change in steward must be approved by the trial secretary and judge. Substitute stewards must conduct themselves according to the PWDCA Water Trial Rules and Regulations, and must sign the agreement contained in this premium list.

Day of Trial Move-ups will be considered at the discretion of the judge and the trial secretary. They will take place on a time and space available basis and will take place after the last regularly scheduled team.

Meals: No lunches will be provided at these trials. Please bring the food and water needed for you and your dogs.

There will be a Chili Dinner after judging on Wednesday.

Hotels and B & B's

Please make your own arrangements; no group rate is available. There is one hotel and several B&B's in Patagonia (7 miles north of park) and several hotels in Nogales (22 miles south of park). Please contact them directly for pet policies and availability.

PWDCA Water Trial Participant Agreement

Conditions: These trials are open to pure bred Portuguese Water Dogs. I/we understand that the dogs must be in good health, proper fitness and condition for the test they are about to enter and must be at least 6 months of age in order to compete in the water trials. I/we agree to these terms. I/we accept full responsibility for the care of my dog(s) during the water trial.

Special Rules: The water trial is located within the confines of Patagonia State Park, AZ. I/we agree to become familiar with and adhere to all site rules and regulations including but not limited to the following: Dogs must be on leash or confined to a crate at all times except when participating in practice sessions or when actually being judged. If my dog soils the ground, I am responsible for cleanup.

General Rules: The Portuguese Water Dog Club of America, Inc., (hereinafter "PWDCA") rules, regulations, policies and guidelines for water trial participants (hereinafter "the rules") are in the current PWDCA Water Trial Manual available on the Web site, www.pwdca.org. I/we have received the current Manual and/or have read the rules via the Web site and I/we agree to obey the rules.

Hold-harmless: I/we agree to hold the PWDCA and the event-giving club, their members, directors, officers, agents, and judge(s) at this event, the owner and/or lessor of the premises, any provider of services for this event and any employees or volunteers of any of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person, animal or thing by the act of my dog while in or upon the trial grounds or while entering or leaving same, and I/we further agree to hold the aforementioned parties harmless from any claim for loss, disappearance or theft of, or damage or injury to, my dog, whether such loss, disappearance, theft, damage, or injury is caused or alleged to be caused by the negligence of the club or any other parties aforementioned, by the negligence of any other person, or by any other cause or causes.

Indemnification: I/we hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting there from, sustained by any person or persons, including myself (ourselves) or on account of damage to property, arising out of or in consequence of my (our) participation in this water trial, howsoever such same may have been caused or may be alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other persons.

Arbitration: Notwithstanding any of the above, in the event that I/we or my dog(s) suffer any damage, injury, illness, or loss (including the death of the dog(s) arising from the water trial), I/we agree that any claim arising out of or related to the entry, exhibition or attendance at the event or as to the construction, interpretation and effect of this agreement shall be settled by arbitration pursuant to the applicable rules of the American Arbitration Association. I/we agree that any such arbitration will take place in Arizona within 60 days of the incident giving rise to the claim, or at such other time and place as the parties may agree. I/we agree to pay a pro-rated share of the costs of any such arbitration.
