A Walk in the Park!

March 28, 2020 8:00 - 11:00am

Riparian Preserve at Water Ranch 2557 E Guadalupe Rd, Gilbert, AZ 85234

We have a pavilion reserved from 8:00 - 11:00am. The park opens at dawn and you are welcome to come early and stay late. Early morning is the best time to enjoy a walk around the park with our PWDs before it gets too warm. We will meet at the pavilion for a club meeting at 10:00am.

Bring a maximum 6' leash, binoculars, water bottle for yourself and a water dish for your PWD. PWDs can rest in crates or on leash while we meet. Ice cold water and hot coffee will be provided. Bring a refillable water bottle and your own coffee cup. Bring snack items to share if you wish.

Over 4.5 miles of trails weave through the park, and there are interpretive education panels on wildlife and vegetation throughout. Viewing blinds have been established at various locations near the edge of several ponds to further enhance the visitor's experience. A floating boardwalk crossing the northern end of the lake allows visitors a close up view of the fish and ducks on the water. Additional educational areas include an ethnobotanical garden, a paleontology dig site, gardens for pollinators including a hummingbird garden and butterfly garden, plus a state-of-the-art observatory and hilltop outdoor classroom. The preserve also includes restroom facilities.

Dogs are Welcome! Keep dogs on a maximum of a 6 foot leash at all times to ensure dogs cannot approach wildlife, for the safety of all.

PWD water training near Phoenix

RSPWDC members have a long history of water work training in Arizona, beginning when several members participated at the first PWDCA National Specialty water trial in 1994 in California. The Rio Salgado PWD Club has hosted PWDCA sanctioned water trials since 2003 at the Canyon Lake Marina Campground beach.

For over 20 years we have looked for suitable sites to train and hold water trials in Arizona. Most open water in Arizona is surrounded by county, state or federal land. Nearly all of the open water in Arizona has fluctuating water levels making it impossible to know if there will be a beach, rocks, or cliffs at the water's edge in advance.

Canyon Lake located east of Phoenix is the only reservoir lake near Phoenix that maintains a consistent water level. We have been fortunate to be able to hold our water trials on this lake. We are indebted to both the Canyon Lake Marina Campground business and all of the individual RV campers who rent RV spaces at our trials, making our trials possible.

For training, it is common for a few people to meet at a lake to train. The west side of Lake Pleasant, entering the park off of North Castle Hot Springs Road, is a popular destination. Depending on the water level, suitable training areas can often be found after entering the Main entrance. Additionally, there are often suitable training areas near the Castle Hot Springs Boat Ramp by entering the North entrance. There is a fee to enter the Lake Pleasant park. The Tonto National Forest boat launch areas at Canyon Lake are also popular spots to get in the water with PWDs. One good training area is between the Acacia Picnic Site and the Palo Verde Boat Launch. Another training area can be found at the Laguna Boat Launch. Parking at these sites requires a Tonto Pass that must be purchased at a business in town.

Canyon Lake Marina Campground campers can swim their PWDs at the campground beach as long as they follow the rules of the campgrounds. These include keeping all dogs on a leash when not on a boat or in the water working, cleaning up after the dogs, and being good neighbors to the other guests at the campgrounds. Day entries are not permitted so only campers can use the beach. Campers must reserve two nights on the weekends and three nights on holidays. Because of the unique situations described, we have several challenges when attempting to schedule club water events including water practice. The Canyon Lake Marina beach is only available to campers so a majority of the participants must reserve camping spaces in order for us to plan an event there. Although the RSPWDC has tried to get permission to host events at other lakes, none of the parties in charge have ever approved our applications to hold dog specific events at these lakes.

To help the dog community in Arizona we hope that everyone who takes their dogs to a lake is extra careful to follow all the rules and be a good citizen. Clean up after your dog, and keep your dog on a 6 foot or shorter leash at all times. Remember that not all people like dogs and some may be afraid of yours even if she is super friendly. Never leave your dog unattended where he may be a nuisance or worse, be in danger. If you know of places where the club might be able to host water events, please bring them to the attention of the RSPWDC Water Trial Host Committee so we can check it out.


