In regards to Family Court Case # 27-FA-13-2680

I, the undersigned, am writing to you today as a member of the Family Court Anti-Corruption Coalition. Although we are a global coalition, we aim to ensure that the courts are acting in the interests of the individual people they directly represent. We are focused on exposing court corruption and demanding accountability and justice in the context of Family Court, CPS and Guardianship fraud.

We are deeply concerned about a family court case in your jurisdiction of Hennepin County. We are seeking a FBI and Federal Grand Jury Investigation into a case involving a 12-year-old girl named Adella. At just 6 years old, Adella was wrongfully removed from the care and custody of her biological mother and has endured an almost 7 year long battle of trying to return home. Over 30 CPS reports have documented a childhood of trauma from physical, sexual and emotional abuse from her father who is the current custodial parent. Instead of helping this child return home, State actors have caused irreparable harm and emotional distress, and continued to place the child in a dangerous situation. The department is currently forcing the child to live with a convicted felon that has continued to cause irreparable harm.

At this time, Adella's mother Lynnea Sterling has nowhere to turn to protect her daughter. The police coax the child back to the abuser, and the school silences Adella by failing to document mandated reports. Adella is still reporting to trusted adults, and during the last court hearing on April 15, 2021 the Guardian Ad Litem refused to investigate another CPS report that documents the fact that Adella had been dragged up the stairs by her hair and hit 15-20 times by her father because she wanted to call home to her mother. This child has reported her father having sexual videos on her phone connected through Icloud, in addition to her enduring sexual assault from her father. The MN Plymouth Police immediately closed the report, refusing a forensic investigation.

We are contacting your office because dozens of our members have witnessed the outrageous and cruel treatment of this mother and her eldest child. We have witnessed how cavalierly the courts can rob a child of her loving, attentive, mother in a blink of an eye, under color of law.

This is a classic RICO case where the court, social workers, court appointed attorneys and county counsel are conspiring against rights to illegally detain a child for their own personal gain. This case is not unique. We believe that there is a pattern of practice, and that the FBI will be able to uncover massive family court corruption and fraud on the court in Hennepin County when they take this case.

Our CPS Anti-Corruption Task Force has discovered thousands of similar cases across the country. We are collecting the data on these cases and would be very happy to turn our evidence over to your office and the FBI.

It is well known that the State of Minnesota has the 8th highest rate of CPS corruption in the nation. As the Minnesota State Representative, the responsibility falls on your office to fully investigate and prosecute this type of corruption.
