To: State Representative Thomas Albert,

I, the undersigned, am writing to you today as a member of the Family Court Anti-Corruption Coalition. Although in its infancy we have amassed over 1250 members in all 50 States who aim to ensure that the courts are acting in the interests of the public they serve. We are focused on exposing court corruption and demanding accountability and justice in the context of Family Court, CPS and Guardianship fraud.

Children and persons with disabilities are the least able to advocate for themselves, therefore we aim to hold to the highest standard those who are charged with protecting them. As such, this Coalition holds a vested interest in court corruption in your jurisdiction.

We are deeply concerned about a guardianship fraud case in Michigan. We are seeking a FBI and federal grand jury investigation into the case involving **Emily Delph Case #13-193245-DD** before **Judge David Murkowski, Kent County, Probate Court**, court appointed attorney for Emily - **Matthew G. Reens**, and court appointed guardian **Karin Van Sweden**.

Emily Delph was savagely removed from the care, custody and control of her loving mother, Holly Delph (a nurse) only to become a ward of the State and put into an institution, Laurels of Kent 350 North Center St. Lowell, MI 49331 where she is placed in the **dementia ward, in a room without windows**.

Emily is not receiving any of the services that a person with cerebral palsy is entitled to receive in the USA. The court-appointed guardian **Karin Van Sweden** took away all of Emily's medical equipment that she needs to **prevent abscesses and contractures** and maintain her physical health and quality of life.

Emily is not receiving any vital necessary medical care. The facility where they have placed her is not equipped to care for people with her disability. This is willful neglect, malpractice and violates this young woman's civil rights.

Our coalition will not stand for this type of cruelty and injustice towards Emily and her mother Holly and we will not rest until they are reunited and justice is served. We have video and photos of the horrific

abscesses that are life threatening. A court appointed guardian robbed a young woman of her mother and under color of law, for federal funding.

This is a classic RICO case where the court and the court appointed guardian are conspiring against rights to illegally detain a severely disabled woman for their own personal gain. This case is not unique. We believe that there is a pattern of practice, and that the FBI will be able to uncover massive court corruption and guardianship fraud when they take this case.

Our Guardianship Fraud Task Force has discovered dozens of similar cases across the country. We are collecting the data on these cases and would be very happy to turn our evidence over to your office and the FBI.

It is well settled that the State of Michigan has one of the highest rates of guardianship fraud in the nation. As the State Representative, the responsibility falls on your office to fully investigate and prosecute this type of corruption. We have confidence that you are up for this challenge, and we look forward to your response and further communication.
