1. All food vendor spaces are located within the Fairground's Food Court Area. Food vendors are not allowed to set up in the Flea Market area
2. Vendors are not allowed to occupy space outside their assigned leased area
3. No sub-leasing allowed
4. Vendors are responsible for their own merchandise
5. Vendors need to stay open for business until Saturday 7 PM & Sunday until 2 PM
6. Vendors who wish to stay overnight with their booth may do so for free (No services except for Fairground restroom & shower facilities)
7. Camping sites are available for a fee
8. Morgan County Antique Machinery Association shall not be liable to any vendor, or its employees for damage to the vendor, its employees, or its property
9. Morgan County Antique Machinery Association assumes no liability for loss or damages or injuries in any manner at any time

5. Vendors shall be responsible for their own merchandise
