1.1 Challenge

To mobilise and govern multi-billion-riyal procurement within aggressive development schedules for national giga-projects such as NEOM and other confidential Saudi masterplans.

1.2 Approach

Designed end-to-end procurement tracking and implementation systems integrating CAPEX/OPEX governance. Drove engagement with international master planners and consultants. Ensured compliance with Kingdom-level governance standards and client transparency protocols.

1.3 Results & Metrics

2.5 bn SAR of contracts procured and negotiated within 18 weeks. Delivered transparent procurement process meeting highest governance standards. Established cost-forecasting systems linking to FP&A and project controls, replicable across giga-projects.

2.1 Challenge

Regional clients in the MENA region sought to accelerate digital procurement maturity and AI adoption across fragmented Source-to-Pay ecosystems.

2.2 Approach

Delivered Al-driven value engineering workshops for C-suite stakeholders. Integrated Generative AI, RPA, and NLP analytics into ERP/S2P platforms (Coupa, Ariba, Ivalua). Defined new Target Operating Model with centralised procurement services and AI-enabled spend compliance.

2.3 Results & Metrics

Deployed core model in 10+ countries, managing €500 m+ indirect spend. Automated supplier-risk and spend-analysis workflows, cutting cycle times by 30–40%. Delivered measurable uplift in "Spend under Control" and stakeholder satisfaction indices.

3.1 Challenge

Fragmented procurement and logistics functions across multiple FM contracts in the UAE and KSA lacked scale efficiency, data visibility, and governance consistency.

3.1 Approach

Designed and executed centralised category-based model. Consolidated 40 stores into 1 central warehouse, integrating WMS and Power BI reporting. Automated manual workflows and introduced procurement policy frameworks aligned to ISO standards.

3.3 Results & Metrics

Annual managed spend: SAR 800M (USD 218M). SAR 18M annualised savings. 11% logistics-cost reduction and 35% reduction in paper product consumption. Increased procurement efficiency and governance maturity across 7 geographies.


