Thank you for reaching out to us about becoming a volunteer. Attached below is an information sheet along with an application that will need to be emailed back or brought to the next meeting.

Our department meets the first and third Mondays of the month for a business and training meetings at Nevada City Hall located at 424 FM 6 Nevada, TX 75173 at 7pm.

You will need to fill out an application and have to pass a background check, if you are certified in Fire/EMS, we require you to attend two meetings (business and/or training) and if you are non-certified in both, you will be required to attend three meeting total. Both statuses require an interview with Command Staff. Once the above is complete, you will be placed on a 6 month probation.

Important Notes:

- We are an EMR level department and can only respond within those standards. We are assisted by professional ambulance services that provide a higher level of care. *if you are certified in medical response, with permission or direction from those ambulance services, you may operate at a level closer to your certification.
- There is required training for non-certified (fire and/or medical) recruits on the second and fourth Monday's with our Training Officer and instructors.
- You will be issued bunker gear, a radio, radio number, and T-shirt's
- We use Active 911 in conjunction with Collin County CAD system.
