This legally binding Contract Agreement assures the Customer that the Service outlined in this contract will be provided by Braeside Camp, and that Braeside Camp accepts the assignment of responsibilities, obligations, and duties as they are defined. Written notice must be given and permissions must be granted by both parties, before any exceptions can be made.

Braeside Camp has the authority and obligation to terminate the remainder of the Service if the Customer does not abide by the Braeside Code of Conduct. Actions such as unwelcome physical contact or destruction of property are immediate grounds for termination without exception. It is the mandated responsibility of Braeside Camp and their staff to report suspected abuse or neglect. The Customer understand the risks involved in participating in the Service.

The Service provided does NOT include childcare and no exceptions will be made to the assignment of this responsibility. Braeside staff is legally mandated to report each instance that guardians leave children unsupervised to the authorities.

Braeside Camp is not responsible damages incurred from actions taken by the Customer. Any costs for damages will promptly be covered by the Customer. The Customer agrees to indemnify Braeside Camp from any claims, judgements, liabilities, or proceedings related to the performing of such actions.

Braeside Camp reserves the rights to photographs and media related to the Service. Authorities must be granted before sharing these rights to assure the correct permissions are given by those involved. The Customer will inform Braeside Camp in writing if they do not wish their likeness included in any shared photographs and media pertaining to Braeside Camp or their affiliates. This becomes effective the date it is received.

All personal and medical information is confidential and will never be shared without written authorization. Information may be stored for up to 12 months after the Service is complete. The Customer agrees to be contacted via the provided methods of communication until termination of all services with Braeside Camp.
