1. Acceptance of Terms

2. Class Enrolment and Payment Terms

- All classes at Galaxy Dance & Gymnastics Ltd are invoiced and payable **termly**.
 - **Invoices are issued for the full term**, regardless of attendance, and are **not prorated**.
 - Invoices must be paid **in full within 14 days of receipt**.
 - If full payment is not received **within 30 days**, a **late payment fee of 10%** of the invoice total will be applied.
 - Failure to settle overdue accounts may result in the suspension or cancellation of your child’s place.

3. Cancellation Policy

- A **minimum of two weeks’ written notice** is required to cancel your child’s enrolment.
 - These two weeks are **chargeable**, whether or not your child attends during that period.
 - If written notice is **not provided**, we will assume your child is continuing with their place.
 - In such cases, invoices will continue to be issued and will remain **payable** for current and future terms until two weeks’ notice is received and served.
