In the event of any discrepancy or disagreement regarding royalties during this period, both parties agree to resolve disputes through mediation, and if necessary, binding arbitration conducted in accordance with the laws of the State of New Jersey.

3. Exclusivity and Legal Matters

- **3.1** Throughout the term of this Agreement, the Artist agrees not to enter into any other exclusive synchronization, licensing, or distribution agreements for the Song that would conflict with the rights granted to the Station herein.
- 3.2 The Artist warrants and represents that they possess all necessary rights, licenses, permissions, and clearances for the Song's use as granted in this Agreement and will indemnify and hold the Station and its affiliates harmless from any claims, damages, liabilities, costs, and expenses (including reasonable attorney fees) arising from any breach of this warranty.

4. Indemnification and Liability

4.1 The Artist agrees to indemnify, defend, and hold harmless Independent Hip-Hop Radio, Michael Redd, and its affiliates, officers, directors, employees, and agents from and against any and all claims, damages, liabilities, costs, and expenses arising out of or related to any breach of this Agreement by the Artist or any alleged infringement of third-party rights associated with the Song.

5. Compliance and Confirmation

5.1 The Artist acknowledges that compliance with this Agreement is a material obligation and confirms understanding and agreement by signing below.

6. Applicable Law and Jurisdiction

6.1 This Agreement shall be governed by and construed in accordance with the laws of the State of New Jersey, and any legal action or proceedings related to this Agreement shall be brought exclusively in the state or federal courts located in New Jersey.
