Terms of Service Agreement

Health and Safety:

I certify that my dog is in good health, is physically fit and has no medical problems which would interfere with training. I further verify that my dog is up-to-date on all vaccinations, including Rabies (Rabies not applicable if under six (6) months of age).

Responsibility and Liability:

I acknowledge and agree that I am solely reliable for my dog and my dog's actions during training and in the future. I acknowledge and agree that any training my dog and I receive or contract for does not constitute any guarantee whatsoever that my dog will not cause harm or loss, intentional or unintentional, to a human being, animal or property. I agree that if my dog causes property damage, or bites or injures any dog, animal or person (Including but not limited to Trainer), during or after the term of this Agreement, the Client/Owner(s) agrees to pay all resulting losses and damages suffered or incurred, and to defend and indemnify Trainer from any resulting claims, demands, lawsuits, losses, costs or expenses, including attorney fees.

I hereby hold **Sharp Shooter's K9 Services** harmless of any loss or damage to me, my dog, or my property including, but not limited to, loss or damage from disease, other dogs, other persons, other pets, my dog running away, fire, or other unavoidable causes.

This contract shall be deemed to have been made in, and shall be construed pursuant to, the laws of the State of Missouri. This contract shall be binding on the heirs, administrators, personal representatives, and assigns of the Client/Owner(s) and **Sharp Shooter's K9 Services**. Any controversy or claim arising out of or relating to this contract, or the breach thereof, or as the result of any claim or controversy involving the alleged negligence by any party to this contract, shall be settled in accordance with the rules of the American Arbitration Association, and judgement upon the award rendered by an arbitrator may be entered in any Court having jurisdiction thereof. The arbitrator shall, as part of his/her award, determine an award to the prevailing party of the costs of such arbitration and attorney's fees of the prevailing party.

Client/Owner(s) acknowledges that **Sharp Shooter's K9 Services** has not represented, promised, guaranteed or warranted that the Dog will never bite, that the Dog will not be dangerous or vicious in the future, that the Dog will not exhibit other behavioral problems, or that the results of the training will last for any particular amount of time. This Agreement may be amended only by a written instrument signed by both Client/Owner(s) and Trainer.
