## **Springdale Frontier Days Royalty Guidelines and Code of Conduct**

The Springdale Rodeo Royalty serves as ambassadors for the Springdale Frontier Days Association as well as the community with the highest level of poise and integrity. They recognize the importance of promoting a positive image and preserving our western heritage.

Being selected onto the Royalty Court is a privilege and an honor. The Springdale Rodeo Royalty will fulfill their responsibility with grace, dignity, and courtesy at all times. Our Royalty are role models who exhibit good moral character and social behavior.

#### Qualifications

- Open Rodeo Royalty candidates must be between 14-20 years old.
- Pee Wee Rodeo Royalty candidates must be between 7-14 years old.
- Live within 50 miles of Springdale.
- Have knowledge of the sport of rodeo and horsemanship.
- Behave in a ladylike manner and portray high moral standards.
- Criminal history or criminal offense during reign will be cause for disqualification.
- Use of drugs, alcohol, and tobacco is prohibited.
- Must have own transportation, horse, and equipment.
- There is no limit to the number of times an individual can compete for a Springdale Royalty title as long as the contestant meets eligibility requirements. However, a titleholder may not compete for the same title two (2) consecutive years.

### Responsibilities, Guidelines and Conduct of Royalty

- Royalty and chaperone should arrive no less than one (1) hour prior to any rodeo, riding or parade event.
- Hair and makeup will be in a clean, neat, age appropriate style.
- Clothing will be clean, properly fitting, in a western style. This will consist of a pressed western shirt, jeans or skirt, belt with buckle, polished boots, and western felt hat.(Black & Red are association colors)
- Must stay in full Royalty attire during events (unless competing).
- Throughout your reign, "significant others" cannot be a distraction while you are performing your duties. Royalty will not appear to be attached.
- Social media posts must be appropriate in attitude and wording as a representative of SFDA at all times. Inappropriate posts may constitute a revoke of title and reign.
- Royalty must have chaperone over 21 years old with them at all events (coordinator, parent, other approved adult). Royalty will communicate their schedule with the royalty advisor including chaperone attending.
- The Royalty Court will provide their own horse, tack, and transportation, at their own cost.
- Royalty will not compete for or hold any other royalty position, honorary position or participate in school activities that would interfere with any of the duties as Springdale Rodeo Royalty for the year of reign beginning November 1 and continuing for 1 year.
- Royalty is expected to become members of the SFDA.
- Royalty are required to do a minimum of 10 hours of community service.
- Absence from two (2) scheduled events without advisor approval may result in dismissal.

- The following is property of the Springdale Frontier Days Rodeo Association and shall be returned clean and in good condition by November 1 of the reigning year.
  - o Crown
  - Flower Pack
  - Serape (including 3 sets of fringe)
- Each royalty member will need to provide their own chaps, outfits, boots, hats, belt buckle, and sash.

#### Horse and Equipment

- Royalty must be able to ride and have access to a suitable horse for the contest, rodeos and all other events such as parades. Suitability will be determined by the royalty advisor and SFDA board. Any horse substitutions must be submitted to the royalty advisor for approval prior to use.
- Horse must be trained, safe, must not be a danger to others, and capable of performing at appropriate speeds.
- Horse must be clean, well groomed and in good overall health and condition.
- Tack will be properly fitted to horse and rider, in good repair, and clean.

#### Royalty Funding

- Fundraising specifically for royalty will be divided fairly between court.
- Royalty are allowed to find sponsors for themselves but must also assist in the funding of the Association.
- All money will be turned in to Association Treasurer.
- All reimbursement requests will be submitted to Treasurer with Original receipt.
- Any damage or loss to association property (crown, flowerpack, serape, etc.) will be the responsibility of the Royalty.

#### **Required Fees and Deposits**

- SFDA Membership = \$30
- Royalty Fees (to provide customized white sash and buckle) = \$140
   Additional Sashes can be purchased through the association for \$40 each
- Property Deposit = \$100
- Fees and Deposit must be paid upon inauguration. Deposit will be returned when property is returned to the association undamaged.

#### **Contest Guidelines**

- Springdale Frontier Days Rodeo Association must have three (3) eligible contestants registered
  by the deadline in order to hold a royalty contest. If this number is not met, SFDA reserves the
  right to rescheduled tryouts in an attempt to increase numbers. In the event that the minimum
  number of contestants cannot be met, SFDA reserves the right to contact past Springdale
  Royalty (in reverse chronological order) until a reigning queen is found or forego a queen for the
  reign.
- Best attempts will be made by SFDA to have a three judge panel consisting of highly qualified professional individuals whom may or may not be from Springdale and the surrounding area.
- Contestants must receive 70% of the possible points in each division to be crowned. In the
  event of a tie, the contestant who receives the highest combined total horsemanship score will
  be crowned.

#### Judging:

- Contestants will be judged on the following criteria:
  - Appearance 20%

The ability to show their outfit with poise and grace. You are judged on your personality projection, how you handle yourself and the ability to have fun.

- Speech, Interview, and Knowledge 30%
  - Quality and content of answers given in the interview, as well as the ability to answer questions related to horsemanship, rodeo and Springdale. Prepared speech questions will be judged on poise and public speaking ability.
- Horsemanship 50%

Horsemanship tasks will be provided the day of the contest. Judged on overall appearance, the correctness and efficiency of tasks, and ability to adapt to the horse and situation.
