## 2022 Election for Adams County in less than 60 Minutes



## Mini Autopsy of the 2022 General Election results for Adams County:

Below, you will find the November 8th Election Results by Precinct and broken out by Party Votes – Republican, Democrat & Other. Although voter participation was good, with a 64.48% turnout, there's no way to sugarcoat the results. While we don't know how anyone voted on November 8th, Adams County voters did not come out and support the Republican Party as a whole. The results reflect that Republican Voters either crossed party lines or withheld their vote. As a party, we would hope to see results that are more reflective of Dr. Joyce's numbers where he is consistently pulling in more votes than the registered Republican base as shown in the graphs.


The best comparison would be the 91st District where Dan Moul had an opponent on the ballot, Marty Qually. On a good note, Qually could only muster up an additional "701" votes out of those additional 7,471 voters. Qually received 9,324 in 2018 and 10,025 in 2022, Moul received 15,920 in 2018 and 18,988 in 2022. The fact is, most Voters are knowledgeable about the campaign ad wars during an election cycle, and the baseless and unproven hit pieces – voters aren't influenced. Unless they include evidence like revealing Qually's participation in Cancel Culture, Americans are too sophisticated and have become immune to the political slingshots.



If it weren't for the GOTV Efforts and the 7,471 more votes cast in this election than in the Gubernatorial Election in 2018, the results may have been worse for Adams County. We've got a lot of work to do in bringing those Republicans back to the Party, to bring over those "other" registered voters – they are all needed to win statewide races. Elections are not won by County, they are won by the votes in each County.

As of January 7th, zero of the <u>six statewide ballot measures</u> have been certified to appear on the ballot for the 2023 Election. Positions on the 2023 Ballot: Judicial (PA Supreme Court, Superior Court & Commonwealth Court), numerous County Row positions which include County Commissioners, Municipal Offices (Township Supervisors, Borough Council Members, Borough Mayors), and School Boards. The importance of filling School Boards with candidates who possess the intestinal fortitude to be on the front line to stop public schools from being utilized as indoctrination centers is critical. There is only one option we should aim for which requires a unified front – that's to WIN!









Democrat Votes = Total number of Registered Democrats who Voted in the November 8, 2022, Election




Democrat Votes = Total number of Registered Democrats who Voted in the November 8, 2022, Election
