HARBOUR DUES PAYMENTS

- (A) Tonnage dues will be payable at the rate of US \$0.80 per ton on the net registered tonnage of the vessel.
- (B) If a vessel enters and leaves in ballast, only half the tonnage dues are payable.
- (C) All vessels including those engaged in coastal trade are required to pay light dues at the rate of US \$0.32 per ton on the net registered tonnage. There will however, be a minimum charge of US \$6.40 for vessels of 10 - 20 tons burthen.
- (D) Shipping fees will be payable at the rate of US \$27.20 on engagement and US \$27.20 on discharge.

PART II

Fee for the Pilotage of Vessels from the Pilot Station to the Harbour of Georgetown or from the Harbour of Georgetown to the Pilot Station shall be payable in accordance with the following scale:

For the Pilotage of Vessels to, in or from the Essequibo River.

- (A) A vessel entering the Essequibo River and proceeding to Parika or leaving the Essequibo River to pay pilotage fees as for entering or leaving Georgetown.
- (B) A vessel proceeding from Georgetown to Parika or vice versa to pay double the pilotage fees for entering or leaving Georgetown and in addition the sum of US \$27.20.
- (C) Vessels entering the Essequibo River and proceeding beyond Parika to pay pilotage fees as at (a) or (b) above, in addition to an extra charge for distance from Parika on the following: (see next page)

10 miles or under, 25% of the pilotage fee for entering Georgetown.

Over 10 miles but not more than 20 miles, 50% of pilotage fee for entering Georgetown.

Over 20 miles but not more than 30 miles, 75% of pilotage fee for entering Georgetown.

Over 30 miles, the pilotage fee for entering Georgetown.

For vessels proceeding down river the same fees shall apply.

Fees for vessels entering or leaving the Harbour of New Amsterdam.

Fees for Pilotage of Vessels:

- (A) To or from a dock in the Harbour of New Amsterdam or from an anchorage to an anchorage in the Harbour of New Amsterdam will be the same as stated in item 2 of part II.
- (B) From the Pilot Station to the Berbice Beacon US \$88.00.

PART IV GENERAL

- 1. Fees for detention of Pilots:
 - (a) In Port (all districts) - US \$35.20
 - (b) At Sea awaiting a vessel which did not arrive at her expected time of arrival - US \$35.20.
- 2. Retainance fee in all districts – US \$19.20 for each hour or part thereof.

3. Fees for cancellation after Pilot's arrival at vessel:

(a) At Georgetown	35.20
(b) At Parika	49.60
(c) At New Amsterdam	68.80
(d) At any point in the Essequibo	102.40

4. Fees for cancellation after Pilot has left by launch for the Pilot station is US \$20.80 for each hour or part thereof which, as a result of the request for his services, the Pilot spends away from port.

5. The fee payable in respect of a Pilotage Exemption Certificate is US \$160.00. However, be it clearly understood that being a holder of a Pilotage Exemption Certificate does not exempt the vessel from paying pilotage.
