### A MESSAGE FROM OUR CEO

Wood River Health celebrated its 47th anniversary in 2023. While our Federally Qualified Health Center has experienced many changes since we opened our doors in 1976, this has been a particularly exciting time for our organization. One of the most economically diverse and challenged regions in RI, Washington County continues to experience a steady, growing demand for health care services.

**9,186 UNIQUE** PATIENTS

23,543 PRIMARY CARE VISITS **6,335 DENTAL VISITS 5,074 BEHAVIORAL HEALTH VISITS** 

In 2023, we reported our highest number of encounters ever: 9,186 unique patients, 23,543 primary care visits, 6,335 dental visits, and 5,074 behavioral health visits. We continue to identify ways to expand our capacity, programs and staffing to help the members of our community achieve and maintain healthy lives.

This year, Wood River Health was recognized by the Health Resources and Services Administration as a Gold Health Center Quality Leader. This credential demonstrates that Wood River Health is a model for excellence in health care delivery and a leader in the promotion of community well-being. Only 149 health centers in the country received this recognition in 2023. This was achieved because our dedicated staff work as a team to provide the highest quality of care to our patients.

In 2023, we opened our new building at our Hope Valley site, which enabled us to expand our clinical space by 57% and incorporate Express Care and physical therapy services. We were invited to serve as the backbone agency to Healthy Bodies Healthy Minds, the Health Equity Zone that is charged with removing obstacles to accessing health care for residents of Washington County. We have partnered with Gateway Healthcare to serve as a Designated Collaborating Organization for Washington County's Certified Community Behavioral Health Center. We are also partnering with Block Island Health Services to offer dental services to island residents. We are expanding our Westerly site to meet the increased demand for health care services.

It's been a year of exponential growth, and one that would not have been successful without the support of our volunteer Board of Directors, our staff, and the generosity of our community partners, grantors and donors. We thank you for investing in our mission.

Wood River Health was recognized as a Health Center Gold Quality Leader, one of only three health

centers in Rhode Island to achieve this status. We achieved this by expanding primary care same-day access, integrating processes for addressing social risk factors to health, reducing health disparities, and advancing health information technology through pre-visit online check-ins. We expanded our women's health services through UpStream and increased access to pediatric behavioral health services with a dedicated community health worker. We began providing convenient Express Care at our Hope Valley site to provide same-day assistance with cuts, upper respiratory illnesses, sprains and other non-emergency medical concerns. A needs assessment indicates we will need to expand this kind of access in Westerly. On-site services with Genoa Healthcare and Specialized Orthopedic Physical Therapy extended our convenient wellness services. Our care team nurses initiated a new system for tracking and educating patients with new or poorly controlled asthma and will add diabetes and hypertension to this initiative by the end of 2024.

#### **DENTAL HEALTH**

In 2023, Wood River Health participated in the National Network for Oral Health Access (NNOHA) Integrating Diabetes and Oral Health (IDOH) Learning Collaborative. Providing dental care to patients with diabetes can support blood sugar control and reduce medical costs. Uncontrolled blood sugar levels affect the body from head to toe, including the teeth and gums, making it important for our medical and dental teams to work together to improve health outcomes for patients living with diabetes. This program supported our goal to develop and implement integration processes to expand and enhance oral health integration with primary medical care. These efforts resulted in delivering whole-person care to patients with diabetes and increased the number of Wood River Health patients who receive both oral health and medical care.

#### **BEHAVIORAL HEALTH SERVICES**

Wood River Health became a Designated Collaborating Organization of Washington County's Community Behavioral Health Center (CCBHC), operated by Gateway Healthcare. With proven success in other states, the CCBHC model is designed to ensure all Americans have access to coordinated comprehensive behavioral health care. This partnership will improve access and coordination of care for patients whose behavioral health needs require expertise beyond our primary care setting. Our Behavioral Health team continues to provide "Warm Encounters" to assess and connect patients with our other programs and services, ensuring that patients receive wrap-around support. Our Medication Assisted Treatment (MAT) Program has grown to over 40 patients with ongoing care for both opiate and alcohol dependence, using safe and reliable medications alongside peer support and behavioral health counseling. Marigold Health provided online peer support access in addition to onsite behavioral health treatment for participants. Now a new, certified community health worker assists behavioral health patients with initial connections to meet their diverse needs and help with healthcare navigation. We continue to offer group therapy with men's and women's support groups.

#### **COMMUNITY RESOURCES**

The Community Resources Team welcomed a second Community Health Worker (CHW) in 2023; CHWs offer direct help to community members as well as being an integral part of the community they serve. The Team provided direct financial assistance to 38 unique patients through the Kim Hebert Community Fund, which is entirely sustained by generous community donations. Community Resources also assisted in completing 170 applications for housing, SNAP, prescription assistance and other benefits to assist patients in becoming more secure and improving health outcomes. Our Health Insurance Navigators assisted in 119 enrollments in health coverage, improving access for community members to health services that they need. Wood River Health also became a certified Home Stabilization provider for RI Medicaid, expanding our capacity to offer services for housing assistance.

#### **WOMEN, INFANTS AND CHILDREN (WIC) PROGRAM**

WIC is a supplemental nutrition program that provides nutrition education, breastfeeding support and health care referrals to our eligible patients. In 2023, our client caseload increased by 15%, and we anticipate an even higher caseload in 2024. In addition, we purchased a lactation scale to provide further support for our breastfeeding mothers. The lactation weighted/gram scale accurately measures the intake of breastmilk, and now clients can depend on us even more during their breastfeeding journey. In anticipation of the new addition being built, we transferred our Hope Valley clients over to our Westerly location during construction. In September, our beautiful new WIC office was completed, and clients were able to schedule their WIC appointments at both our Hope Valley and Westerly locations. We continued to partner with The Jonnycake Center for Hope in Wakefield. This ongoing collaboration allows us to provide services to the underserved population in Peace Dale, South Kingstown and the surrounding areas. This partnership also helped increase access to the services we provide and aided in the growth of our WIC caseload.

### **DELIVERING QUALITY CARE**

In 2023, Wood River Health continued to make great strides in providing quality health care to our patients. Our efforts were recognized by receiving the following credentials from the Health Resources and Services Administration (HRSA) and the National Committee for Quality Assurance (NCQA).



# FEDERAL TORT CLAIMS ACT (FTCA) DEEMED STATUS BADGE

Wood River Health receives deeming by Health Resources and Services Administration under the Federally Supported Health Centers Assistance Act. We are treated as Public Health Service employees for the purpose of malpractice liability coverage.



#### PATIENT-CENTERED MEDICAL HOME (PCMH)

Wood River Health puts patients at the forefront of their care. PCMHs build better relationships between patients and their clinical care teams. They improve quality and the patient experience, increase staff satisfaction, and reduce health care costs.



#### **HEALTH CENTER QUALITY LEADER**

Awarded to only 10% of community health care centers in the United States, the Gold badge demonstrates Wood River Health is a model for excellence in health care delivery and a leader in promoting community well-being.



#### **ACCESS ENHANCER**

We increased the number of patients who received at least one comprehensive service (mental health, substance use disorder, vision, dental, and/or enabling service) by at least 5% during consecutive reporting periods.

# ADVANCING HEALTH INFORMATION TECHNOLOGY (HIT) FOR QUALITY

Wood River Health uses an electronic health record system, provides telehealth services, and exchanges clinical information electronically with key providers in health care settings. We engage patients through health information technology and collect data on patient social risk factors.

#### **HEALTH DISPARITIES REDUCER**

We demonstrated at least a 10% improvement in low birth weight, hypertension control, or uncontrolled diabetes Continuous Quality Measures during consecutive reporting years for at least one racial/ethnic group. We improved our overall performance from the previous year.



#### TARGET: BP™ INITIATIVE

We were recognized by the American Heart Association and American Medical Association for our commitment to improving blood pressure (BP) control rates, earning gold-level recognition as part of the Target: BP™ Initiative. The Gold award recognizes practices in which high blood pressure is controlled in 70% or more of the adult patients affected.


#### TARGET: TYPE TWO DIABETESSM

Wood River Health was recognized by the American Heart Association's Target: Type 2 Diabetes<sup>SM</sup>, earning gold-level recognition in 2023 for our commitment to addressing the relationship between diabetes and the risk of heart disease and stroke. Our data demonstrated impressive HbA1c control in patients with diabetes and ≥70% adherence to one of the cardiovascular-focused clinical measures. We were commended for our ongoing commitment to improving quality of care through awareness, detection and management of type 2 diabetes and cardiovascular risk factors.

# CHECK. CHANGE. CONTROL. CHOLESTEROL™



#### **WOOD RIVER HEALTH PATIENTS BY YEAR**




#### **2023 PATIENT VISITS**






#### **ETHNICITY**


#### **PATIENT AGES**






#### **INSURANCE CATEGORY**

### **ONE PATIENT'S STORY**

My name is Don and I am a dental patient of Wood River Health.

I have been coming to Wood River Health for about 36 years. My mother found this place and I am so grateful she did. I had developed severe tooth decay and had neglected my teeth for years while managing other health issues.

In my twenties and thirties, I had monumental health problems and lots of pain. I had not seen a dentist for years. It was hard to find a dentist who accepted Medicaid insurance. My mother suggested that I contact Wood River Health and I have been with them ever since.

I did not brush properly and used to drink soda and sugary drinks which caused serious tooth decay. It was all self-inflicted, but I did not know that these habits would cause me so much pain and damage to my teeth.

Wood River Health was there for me when I needed fillings. My severe pain was taken away. Eventually I needed dentures. Dr. Gerald Donahue made my first set of dentures. They fit perfectly from the beginning.

I have seen many dentists and hygienists over the 36 years as a patient of Wood River Health and they have all been very professional and competent.


### **OUR** WORKFORCE

Wood River Health continues to make strides towards positioning ourselves as a Best Place to Work. We have cultivated a dedicated team of health professionals, administrators and support staff that deliver high-quality, compassionate care. Wood River Health is a National Health Service Corps Loan Repayment Program approved site. We offer competitive salaries and a comprehensive benefits package

starting at 20 hours per week. In 2023, Wood River Health reinvented our Diversity, Equity & Inclusion (DEI) Committee.

Currently consisting of nine members from diverse social identity groups, various job functions and levels within the organization are represented, including a board member. The committee serves as an advisory body to Wood River Health's leadership. Members work to identify ways to compel accountability for and ensure the integration of best practices for diversity, equity and inclusion within all aspects of the health center's operations. The efforts of committee members have resulted in raised awareness and increased appreciation of DEI throughout the organization.

In 2023, our community health center continued to experience a steady growth in our workforce, as evidenced by the below chart. We project that Wood River Health will continue to increase its staffing levels and exceed 105 employees by the end of calendar year 2024.

## FQHCs AND OUR CATCHMENT AREA

Wood River Health is a 501(c)(3) nonprofit organization that has delivered high quality health care services since 1976. We provide patient-centered care and offer medical, dental, and behavioral health care and support services. Most of our patients are residents of Washington County, Rhode Island and southeastern Connecticut.

Wood River Health is a Federally Qualified Health Center (FQHC). We are a community-based health care provider that receives funds from the HRSA Health Center Program to provide primary care services in underserved areas. FQHCs have been a tried-and-true tax savings solution for more than 50 years. They reduce emergency room visits, lower health disparities, improve health care access; save taxpayer dollars, reduce COVID-19 mortality rates and improve local economies.

FQHCs must adhere to a stringent set of requirements. This includes offering care on a sliding fee scale based on our patients' ability to pay, and operating under a governing board that includes at least 51% patient-members. There are eight FOHCs in Rhode Island, located at more than 30 locations across the state. Wood River Health serves the catchment area of Washington County. Our primary service area (75%) consists of nine zip codes and our secondary service area supports the next 10-15% of our patients.
